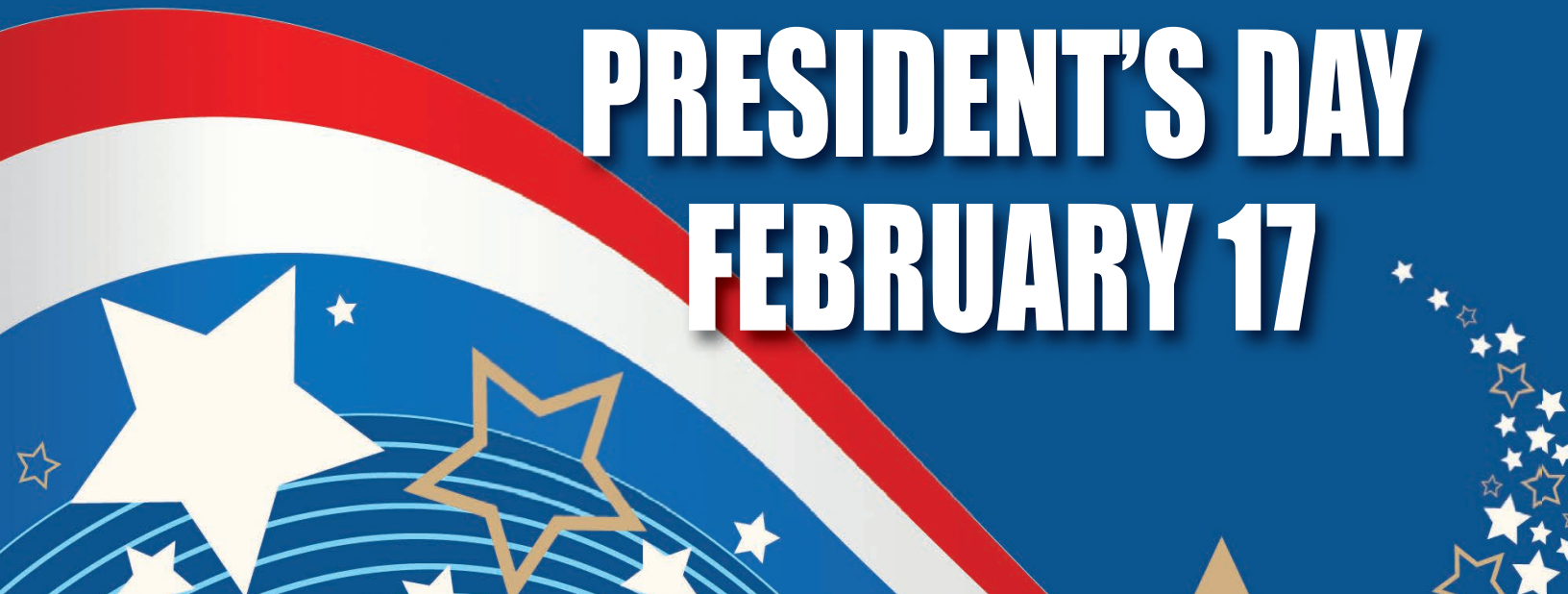

President's Message

UNITY

Unity is easy when times are going good and there are no major issues facing a union. For the past few years this union has faced our share of major issues, none more challenging than dealing with the loss of 5 of our police officers who died in the line of duty. Dealing with that alone would have been a tremendous strain on any union. Dealing with the deaths of our brothers during these times which include the wage/step freeze, the realignment/closures of precincts and several other issues including the misconduct of the former commissioner which led to his resignation puts a huge strain on this union.

It is very easy for members to start losing faith or caring less about the job we all love. We must all dig down deep and make sure that doesn't happen because if it does happen, it is the beginning of the end and it will be difficult to recover. We must all act as one, not as independent contractors. If we act as independent contractors it opens the door for management to seize control.

Of the challenges we face at this moment, none is more challenging than the wage/step freeze which should and must make us all stronger in the end as long as we all stay together. No union to my knowledge has negotiated its way out of a wage freeze although we have come close a few times. We will continue to work towards that goal while also pursuing our legal challenges in court.

I know these times are frustrating for everyone, especially those in steps, and you want constant information and updates, but things change with our talks on almost a daily basis that any detailed information we would distribute could change in a matter of hours or days. There's also information and strategies that can't be distributed for reasons that should be obvious to everyone during our talks.

On January 17th our attorneys filed our briefs with Justice Diamond on the statutory argument that NIFA had no authority to freeze wages/steps since the "Interim Finance Period" had expired. The county and NIFA must file their replies by February 7th. It is unknown how long thereafter a decision will be handed down. What I do know is that whoever loses at the State Supreme Court level here in Nassau County will appeal that decision to the Appellate Division and ultimately to the State Court of Appeals, further delaying a final decision.

In closing I want to remind everyone to stay strong and united and keep the faith.

Top Cops of the Month August 2012

P.O. KERRY HARRACKSINGH P.O. DARIO PIERRE FIFTH PRECINCT

On 08/12/12 Police Officers Kerry Harracksingh and Dario Pierre responded to a 911 call for a fight involving a stabbing which occurred on Merrick Road in Valley Stream. Upon arrival, both subjects and victim were gone from scene. The Officers obtained the subject's description and registration plate number from witnesses. The victim was located in a nearby establishment having suffered numerous stab wounds and was bleeding profusely. After rendering medical aid to the victim, the Officers observed the subjects vehicle traveling in the area and conducted a VTL stop. During the stop they observed blood on the car and the operator's sneakers, along with a knife in the vehicle with blood on it. When advised that he was under arrest the subject began to fight both officers in an attempt not to be arrested. The subject kicked one Officer in the chest and shoved the other Officer to the ground before they were eventually able to place him in to custody. The subject was charged with Murder 2, CPW, and Resisting.

The Officers fast response and keen observations, while demonstrating tremendous courage while fighting an extremely violent felon before placing him under arrest is why they are being honored as PBA TOP COPS OF THE MONTH.

HEALTH AND WELLNESS REIMBURSEMENT PROGRAM

The Members Benefit Fund was bargained for and established during the negotiations for the 2013-2015 Contract Extension. The fund was established to assist Full Active Members by providing additional programs and services. In the past the fund has been used to pay for and provide the Legal Services Plan, The Cardiac Imaging Plan, Defensive Driving Classes for members and their family, and the Pension Estimate Program.

With the contractual increase in the fund that we received as of January 2014, the PBA is now able to further assist members with the Health and Wellness Reimbursement Program. This plan entitles all Full Active Members to up to \$150 in reimbursements for any medical and/or wellness related expenses that they or their spouse or children might incur each year. Examples of expenses that will be covered are prescription co-payments, doctors co-payments, and precinct or private gym dues.

Once a member reaches the \$150 maximum reimbursement for the year he/she will need to submit the receipts for the expenses to the PBA Office. When submitting the receipts mark them to the attention of the Benefit Reimbursement Plan. The member will then receive a check for those expenses. If at the end of the year a member has not reached the \$150 maximum, he/she can submit any receipts for covered expenses during the month of December. A check will then be issued for the amount of expenses the member incurred.

LISTING OF MEDICATIONS FOR DRUG TEST

We recently signed an MOA in regards to listing of medications you might be taking when called for a drug test. With this agreement you are no longer required to list any prescription or over the counter medications that you are taking. If a members test subsequently comes back positive he/she will then be required to list any medication you were taking. If they were prescription medications you will then have to produce the prescriptions for those medications.

SICK LEAVE FOR DISCIPLINARY FINES

We were also able to secure an MOA that has to do with the use of accrued sick leave to pay off disciplinary fines. Under this agreement, any member that receives a penalty in satisfaction of disciplinary issues will be able to use sick leave to pay off some of the fine. If a member is fined over 10 days, the member will be allowed to use accrued sick time to pay off half of the fine. Example: If a member is fined 20 days, he/she will be able to use sick time to pay off 10 of the 20 days. For any member that is in the middle of paying off any outstanding fines he/she will be able to use this MOA to satisfy the remainder of his/her fine.

Legal Report

There is yet another deadline looming regarding World Trade Center benefits for those who were involved in the rescue, recovery or cleanup operations. The New York State Workers' Compensation Board has extended the deadline for filing notice of participation in the rescue, recovery or cleanup at various sites to September 11, 2014. It is important to file the WTC - 12, Notice of Registration, because potential benefits include medical coverage for conditions which are found related to exposure and monetary compensation if you are no longer able to work because of your exposure to the 9-11 terrorist attacks. The registration form is not a claim for benefits in and of itself, rather it is notification of your presence at the 9-11 site or other designated areas. The "World Trade Center site" is defined as "anywhere below a line starting from the Hudson River and Canal Street; east of Canal Street to Pike Street; south on Pike Street to the East River; and extending to the lower tip of Manhattan."

By filing the registration form you are protecting your right to file a Workers' Compensation claim. You do not have to be sick now or even years from now. This will probably be the last time to register should you become ill due to your exposure or activities and protect yourself should you become ill in the future related to 9-11 rescue, recovery or cleanup. These sites essentially follow the law as set forth in claims for accidental disability WTC presumption benefits provided in Sect. 363g.1.(d)(ii) and (iv).

For Workers' Compensation Benefits there is no time requirement for how long you served at the World Trade Center or any of the other designated sites. Also, the Workers' Compensation Law traces accidental disability WTC presumption disability retirement law in providing a "qualifying condition" defined as "as any of the following diseases or condition[s] resulting from a hazardous exposure during participation in World Trade Center rescue, recovery or cleanup operations. Some of these qualifying conditions include respiratory disease, diseases of the gastroesophageal tract, including reflux disease and psychological difficulties including post-traumatic stress disorder. So, you are emphatically encouraged to file your registration form with the Workers' Compensation Board as soon as possible. Do not delay because if you file late, you will jeopardize very valuable rights.

As you undoubtedly know, the topic of post-traumatic stress disorders and other psychological conditions have been front page news recently. Firefighters and police officers, along with their attorney, "pension consultant" and two other members of an alleged scam ring, have been indicted for allegedly defrauding the Social Security Administration of millions of dollars over a 20 year period. Apparently, all the claims were based on psychological disorders. According to newspaper accounts, applicants were recruited by two members of the scam ring, applications were filled out by the "pension consultant" and the lawyer in the group collected an attorney's fee. News accounts also mentioned kickbacks

to the scam artists of amounts ranging from \$10K to \$20K. It appears that all of these applicants were undeservedly awarded Social Security Disability Insurance benefits.

Further, according to news reports, the applicants were coached in feigning their psychiatric disabilities: they were told how to "act" psychiatrically impaired by misspelling simple words, by not remembering three items in a row, by appearing at the Social Security ordered medical examination disheveled and poorly dressed and not looking in the eyes of the examiner, but rather looking at the floor. They were further coached to lie and express the degree of their disability by saying that they were so impaired that they could not leave the house.

The scam was exposed by an inordinate number of these "psychiatrically disabled" applicants applying for gun permits, indicating that there was no psychiatric disability. This, of course, raised a red flag and further investigation followed. The investigators turned to Facebook where they found applicants who claimed they could not leave their houses or that they could not work because of their "psychiatric disabilities," selling pastries at an Italian festival, jet skiing, dancing at a wedding and other activities inconsistent with claims of disability.

An award of Social Security Disability Insurance benefits is subject to review and can be cancelled. If you are disabled and awarded benefits Social Security is an agency continues to maintain ongoing jurisdiction over your claim. Your actions and activities should not be inconsistent with your disabling condition. Deception becomes reality, so if it looks or sounds bad, it's an activity that could get a recipient into trouble. The investigation into the Social Security Disability scam has reached back more than 20 years. The best advice is to take down your Facebook page as soon as you think you might be pursuing a disability claim. You cannot control what others may post on your Facebook page or on any other social media.

Another item that bears clarification is the matter of the police department filing disability applications on your behalf. I recently met with a police officer who did not understand how the system worked. You need to know that the police commissioner or another high ranking officer, acting on behalf of the commissioner is authorized to sign and file applications for POD and/or ADR on behalf of a police officer injured in the line of duty. These applications are subject to the very same statutes and regulations as are those that may be filed by the police officer. For example, an application filed by the commissioner must meet the same definition of "accident," the application must be timely filed and the medical evidence must meet the same definitions of disability, permanency and causal relationship. The burden of proof does not change so the applicant must prove the police officer's entitlement. I was also asked whether the application filed by the commissioner receives greater evidentiary weight than an application filed by the police officer. The rationale of the officer I met with was that the filing by the commissioner would be given more favorable treatment by the Retirement System since the Retirement System would consider such application as the police department's conces-

sion of the officer's disability. To emphasize, an application filed by either the police officer him/herself or the department is subject to the very same standards and scrutiny by the Retirement System.

I was also questioned as to what happens if a claim for either ADR or POD, or both, is denied. The short answer is that since the claim(s) is based on a line of duty injury, the officer cannot be fired because of the safety net provided by Section 207-c of the General Municipal Law. Pursuant to section 207-c, the police officer must be paid by Nassau County his regular salary or wages until his disability arising from the line of duty event has ended or the police officer is retired on a disability pension. Also, this section of the law requires the municipality to pay for all medical treatment and hospital care due to the injuries or illnesses causally related to the accident. Section 207-c also provides certain rights to the employer: the right to file disability applications on behalf of the police officer and the right to have the police officer examined from time to time to determine whether that police officer is fit for full or restricted duty. If the police officer is deemed fit for either restricted or full duty and the police officer fails to avail him/herself of the assignment, then benefits under 207-c will be discontinued.

We are still researching the issue of what happens to an application for disability filed by the commissioner, and prior to a decision by the Retirement System, the commissioner is forced to resign.

TOP COP (AUGUST 2013) POLICE OFFICER MOHIT ARORA

In the early morning hours of Wednesday August 14th, 2013, a 911 call was received for a burglary in progress. The homeowner and his wife were hiding in their home and stated to the 911 operator, that there was someone in their house, the 911 operator lost contact with the victims at this time. Officers Mohit Arora and Eugene Dolan were first to arrive and they observed a male dressed in black clothing, holding two bags, walking away from the burglary location. As Officer Arora and Dolan exited their vehicles to confront the subject on foot, the subject immediately dropped the bags and ran from the scene. Officer Arora and Dolan gave chase and quickly caught up to the subject. The subject quickly turned and fired multiple shots, striking Officer Arora with one of them. Officer Arora collapsed as Officer Dolan dove for cover from the subjects' gunfire. Officer Dolan quickly recovered and rendered aid to Officer Arora. Officer Kenneth Ritter arrived on scene. Officers Ritter and Dolan exchanged gun fire with the subject as he fled the scene and scaled a fence into a school yard. Officer Dolan and Ritter stayed with

Officer Arora and rendered further first aid. Officer Dolan transmitted the description and direction of the armed subject. With the assistance of responding officers, Officer Arora was transported to the hospital.

Third Precinct plain clothes Officers Basil Gomez and Vincent Logiudice responded from the 3rd Squad, where they had been processing an arrest, and arrived on scene within minutes. Officer Ritter pointed to where the fleeing subject had gone. After assessing the situation, Gomez and Logiudice determined which backstreets the subject was most likely to re-merge onto from the school yard. Officers Gomez and Logiudice, having correctly calculated the subjects escape route, came upon him on one of the side streets in the vicinity of the school. The Officers exited their vehicles and encountered the subject, who produced a handgun and pointed it at the Officers. Officer Gomez and Logiudice, while running towards the armed subject, began firing their weapons. The subject fell to the ground, but quickly recovered and took off running, leaving his firearm where he had fallen. As Officers turned the corner in foot pursuit they lost sight of the subject and began to search the area.

Fifth Precinct Patrol Officer John Wellenreuther was first on scene to assist Gomez and Logiudice and with the aid of his RMP's spotlight, uncovered the subject hiding under a parked vehicle. The subject took off again, fleeing into a rear yard where Officer Gomez, Logiudice and Wellenreuther quickly cornered and confronted the subject who violently resisted the officers. After a brief struggle, the subject was placed into custody.

Police Officer Patrick Bergin, while these events were taken place, was canvassing the area and did come into contact with the shooters accomplice and placed him under arrest without incident.

TOP COP (OCTOBER 2013) POLICE OFFICER CHARLES JAVOROWSKY

On September 22, 2013 at 1530 hrs. Officers Javorowsky and Taglia respond to an aided case for a male who had been shot. The officers verified that a male had been shot and killed and was lying in the roadway. Officer Javorowsky was able to secure video of the scene from a nearby business which showed a possible suspect that he was able to identify to the Third Squad Detectives.

On September 25, 2013, Officer Javorowsky was assigned to RMP321 and was in the vicinity of Upland St. and Oxford St., Westbury, canvassing for a suspicious vehicle that was reported in the area. Officer Javorowsky observed the subject from the State Street homicide walking on Upland Street. Officer Javorowsky contacted the Third Squad Detectives and was advised that the subject was wanted in connection with the homicide. Officer Javorowsky requested assistance and did place the subject under arrest.

Officer Javorowsky's keen observations resulted in the arrest of the defendant who was charged with violation of PL 125.25 (1) Murder 2ND

TOP COP (NOVEMBER 2013) POLICE OFFICER JOSEPH MASSARO

On Tuesday October 22, 2013 at approximately 1347 hrs., Officer Massaro, while on patrol on Ring Road in East Garden City, did observe a white BMW with Georgia plates. Officer Massaro conducted a NYSPIN check and discovered that the registration was expired. Officer Massaro conducted a traffic stop where the driver, who appeared extremely nervous produced a Pennsylvania Driver's License. The paperwork the defendant produced identified the vehicle as having a suspended registration. The driver stated that he had just cleared up the suspension. When asked who owned the vehicle the defendant stated that he owned the vehicle, although it was not registered to the driver. The defendant was then asked several questions regarding where he was going to and coming from. The defendant became increasingly nervous as he struggled for answers. Officer Massaro observed a large box on the seat of the vehicle with a shipping label addressed to the defendant. Officer Massaro asked what was in the package and the defendant stated that it was clothing sent from his uncle.

Officer Massaro suspected that the box may have contained drugs and requested K9. Officer Lasala responded with K9 Jax who alerted on the package. The package was opened and contained approximately 50 lbs. of a greenish brown leaf like substance believed to be marijuana. The defendant was placed under arrest and transported to the 3rd Squad for arrest processing.

The defendant was charged with violation of PL 221.30 Criminal Possession of Marijuana 1st.

Emergency Ambulance Bureau

The new year has settled in and I hope that we're all sticking with those resolutions we've all made! Yeah, I know, it was over by mid January.

The weather has been bipolar to say the least. The ground is frozen and we've been dealing with many slip and fall aided's. Please be careful out there, ask for extra help on aided cases when needed for lifting and moving patients outdoors.

While on the subject of cold weather, I'd like to offer some important information regarding exposure to the cold, some signs and symptoms and what you can do to help yourself and others.

"FROST NIP VS. FROST BITE"

Frost nip is a milder form of exposure to the cold and it is what we commonly deal with ourselves when outside working. It's generally recognized by slight tingling, or numbness in the affected area, with the skin becoming pale. The best way to treat frost nip is to simply cover the exposed parts and remove from the cold environment. Most importantly, avoid brisk rubbing of the hands and such as it can cause tissue damage.

Frost bite is a much more serious condition and almost always requires medical intervention. Signs and symptoms include numbness, with the skin turning white or yellow in color. The victim may complain of severe pain and throbbing in the area and they may also appear to lack coordination. While awaiting EMS, you can help by removing any wet clothing and covering with blankets. It is important to not allow partial thawing and refreezing. Also, limit the patient's movement, unless there are other life threatening issues. Again, as in frost nip, do not rub the affected area. This patient requires gentle and safe ambulance transport and definitive hospital treatment.

Remember that if you are not a member in good standing, you are not eligible for the death benefit.

The PBA is in a drive for members to cancel their Newsday and cablevision accounts and switch over to Verizon FIOS. You wouldn't believe the bashing Newsday has been giving the cops in Nassau and Suffolk the past

More provisions of the NYS Safe Act went into effect in January and are really putting the screws to lawful holders of gun permits by requiring all sales of ammunition to be through a registered gun dealer and done face to face. The problem with the new requirements is that the dealers are charging an exorbitant price to do a background check on the buyer and the new law requires a background check for the purchase of one round or one thousand rounds of ammunition. Another Cuomo slap in the face to all lawful gun owners.

Are you carrying heading south for the winter and want to carry your firearm? If you have been certified under HR218, you are ok. If not, your NYS Carry Permit is not good in other states because New York does not recognize other states carry permits. If you want to get certified under HR218, go to the ARPO web site where you will find a link for HR218 certification and a 10% discount for ARPO members taking the course.

Please remit your ARPO dues payment now. A timely dues payment will assist us in not having to send out reminders and incur extra mailing costs and extra work. *Remember if you are a snowbird, the post office will not forward your newsletter. In order to have your newsletter follow you south, you must notify us of your new address prior to the 15th of the previous month you are moving.* Don't wait to the last minute to notify us of your address change. I try and keep up with your address changes by having both addresses on file so all you have to do is give me the date you are heading south.
