# President's Message

As the New Year is upon us I would like to take this opportunity to wish each and every one of you a happy, healthy and safe New Year. It has been an honor serving you as your President and I am looking forward to representing you as we face the New Year.

As we are all well aware, the start of 2020 brought in the New Year with the new criminal justice reforms that passed in Albany during the past session. This included eliminating cash bail in misdemeanors and certain non-violent felonies and requiring appearance tickets to be issued instead of an arrest in most of these cases. There are also several components of the laws, such as 15 days to turn over all discovery evidence to a defendant that we feel would put some cases in jeopardy. There have been several news releases on the new reforms and we hope the public will realize the certain problems with the new law that we as Law Enforcement Officers already know.

The PBA has already been active over the past months addressing this issue. Our 1st Vice President Pete Paterson has been actively meeting with members of both the Senate and Assembly to push for important changes to the law that would stress public safety for the residents of New York State and the Police Officers who protect them. There are new amendments already drafted and introduced in Albany. Pete is also the Legislative Chairman for the New York State Association of PBAs (NYSAPBAs) which is based in Albany. The Legislative Committee has members from both Nassau and Suffolk SOA and Detective Associations as well as the members from the MTA PBA, Port Authority PBA, and NYPD Police Associations. The entire Committee has been lobbying hard for these changes and will be up in Albany this week to continue their efforts during the start of the Legislative Session.

I have directed Pete and our entire Executive Board to make this a priority issue for the Nassau County PBA and we will continue to do so until some much needed changes are accomplished.

We will also be meeting with Representatives of the Governor so we can give the position from a Law Enforcement point of view.

Furthermore, over the past several months we have met with Representatives of the District Attorney's Office and the New York State District Attorneys Association to coordinate efforts to with our partners in Law Enforcement to accomplish our goals.

We will be updating you on the important issue as well as other Legislation we are working on this session

by emailing you a Legislative update as the session progresses.

As your President, my members' safety has been my number one priority and will always be in the future.

## Legal Report

As we begin 2020, there are always a few things that we think are worth mentioning and providing a few friendly reminders at the start of another happy and healthy New Year. So, we are using this month's Legal Report to go over some of the most common questions and issues that have come through our office throughout the past year. Of course, as with any topic, there should not be any questions that go unanswered since we are always happy and available to help in whatever way that we can.

For starters, we wrote about this topic several times over the past years—the biggest reminder has to be that the initial accident reports and paperwork are extremely crucial to any of the claims on which we represent our clients. We recently saw yet another situation where the member in question was injured in what should have been a bonafide “accident” while on duty, but he was denied simply because the initial statements that he provided, as well as the initial accident descriptions provided to the supervisor who took the report and to the police surgeon, did not match the Retirement System's definition of the word “accident.” The officer simply filled out the report on the day he was injured without consulting either his union delegate or our office, and despite the fact that we believe that he actually suffered an “accident” on the job, after a hearing, the Retirement System's Hearing Officer affirmed the Retirement System's denial on the basis that he did not believe the initial report constituted an “accident” for 3/4 purposes. However, the Hearing Officer, surprisingly, wrote in the decision that if he accepted the applicant's description of the event as written on the application and as described during testimony that it would have constituted an “accident”. The Hearing Officer relied on years of case law, which provides that an initial report carries greater weight than subsequent reports or testimony because the more contemporaneous report is considered more reliable. Thus, the member will be approved for his disability pension, but it will only be a Performance of Duty pension worth 50% of his final

average salary. Once again, the lesson to be learned is that when you are injured, every member should reach out to his or her delegate or trustee before drafting an injury report that may or may not be the difference between an Accidental or Performance of Duty disability retirement, i.e., the difference between 75% of final average salary or 50% of final average salary over the officer's lifetime. Executive Board members, trustees and delegates have our cell numbers so we can be reached any time.

Another issue that needs clarification is appreciating the definition of a line of duty injury or illness for members of this Police Department. According to a Memorandum of Understanding dated March 25, 1993, entered into by the Nassau County Police Department and the PBA, a line of duty injury or illness is defined as follows:

1. An injury or illness received while the member was on duty (while not on meal period, except if in a Departmental building or vehicle), if the member was not acting illegally; or
2. An injury or illness received while the member was acting pursuant to the duties and responsibilities of a Police Officer; or
3. An injury or illness received while the member was acting in response to the direction of a Superior Officer.

Line of duty status given to an injury resulting from “acting pursuant to the duties and responsibilities of a Police Officer,” is completely in synch with the Department Manual, Department Policies, POL 4001 Duty: “In furtherance of the Department's Mission, it is the duty of the Police Department and the Members of the Force, at all times of the day and night, to protect life and property, prevent crime, detect and arrest offenders, preserve the public peace, and enforce all laws and ordinances over which the Police department has jurisdiction.”

A Member of the Police Force acts within the scope of official duties when (s)he performs any “legal act or activity either on or off duty, pursuant to the duties and responsibilities of a Police Officer” (see Department Manual, Glossary, “Scope of official duties”; emphasis added). In such a circumstance a member of the force should complete a line of duty packet whether the member has identified himself as a police officer or not. If circumstances permit, identifying yourself as a police officer is the preferable action, but if not possible, the injury will still be line of duty if conditions as described above are met. For instance: if an off duty police officer runs into a burning building to rescue any people that might be trapped inside, this is an example of acting “within the scope of official duties”; if an off duty police officer stops at the scene of a traffic accident and assists in extricating someone from the car, this is yet another

example of acting “within the scope of official duties.” In both of these examples line of duty status will be accorded and whether or not the police officer identified himself as a police officer is not the determinative factor. However, if a police officer becomes involved in a bar fight, whether or not the police officer identified himself as a police officer might be a key factor.

The most important thing to remember is accuracy: if you did identify yourself as a police officer all documentation should say so. Likewise, if you did not identify yourself as a police officer, all documentation should so state. There must be complete, truthful consistency on this matter. The accident report to the Police Department, the Workers’ Compensation Form C – 3, and any documents completed in connection with a criminal prosecution must all be completely accurate and consistent on the issue of police self-identification, as well as all other factors relating to the event. The important take away is that it is not necessary to self-identify as a police officer to make a claim that an off-duty event is entitled to line of duty status.

As a reminder, be aware of Department Manual Article 7, Rule 7, which provides as follows:

“Full pay will be granted to Members of the Force for injuries received while acting within the scope of official duties when such injury has been reported to the member’s Commanding Officer within seven (7) days after the injury was sustained and it can be conclusively shown that the disability was actually received while the member was performing police duty and that no negligence on the member’s part contributed thereto. THIS TIME LIMIT MAY NOT BE EXTENDED EXCEPT BY APPROVAL OF THE COMMISSIONER OF POLICE (emphasis added).”

Two things to appreciate from that clause and to clearly understand is that (A), notice of the event must be given within seven (7) days to the Department per Departmental Rules; and (B), the member has up to seven (7) days to provide the notice of that event. The seven (7) day deadline differs from the Workers’ Compensation Law which provides for notice to be given up to 30 days from the date of the injury; obviously the Departmental Rule is the one to follow regarding line of duty claims. But, as we noted earlier in this Legal Report, accurate statements might be the difference between a 3/4 Accidental Disability Retirement or getting a 50% Performance of Duty Disability pension, so having to do an accident statement is required. Take the time to accurately review your initial statement because it is crucial to protecting yourself, as long as it is provided within seven (7) days. And, we make ourselves available to all members and their delegates and trustees in order to help make sure those statements are accurate and that they thoroughly protect each member.

Finally for this Legal Report, we feel it is important to mention Social Security Disability Insurance benefits, which are available to anyone who has accumulated the required number of quarters of coverage (i.e., paid FICA tax) and can demonstrate that (s)he is “ [unable] to do any substantial gainful activity by reason of any medically determinable physical or mental impairment which can be expected to result in death or which has lasted or can be expected to last for a continuous period of not less than 12 months.” One of the requirements to establish entitlement to SSDI benefits is that the applicant must not be engaged in “substantial gainful activity,” which means essentially that the applicant is not working. In determining whether work activity amounts to “substantial gainful activity,” an applicant’s earnings will be considered. Payments of other disability benefits (i.e., accidental disability retirement benefits, performance of duty disability retirement benefits, Workers’ Compensation benefits) or accumulated sick/vacation time or royalties or interest on investments or sick pay do not constitute “earnings” so as to disqualify an applicant from receiving SSDI payments. So, if an applicant is disabled within the meaning of the Social Security law and is receiving any of these payments, including the receipt of even full GML Sect. 207-c tax free wages, SSDI benefits may be payable.

## **BUFFY'S SPOTLIGHT**

Great job by Officers Higgins and Carbone. On December 3rd these officers conducted a VTL stop

and detected the odor of marijuana emanating from a vehicle that was occupied by three suspects. During the investigation, these officers were assisted by PO Foley, Garland, Timpanaro, and Sukalic. While searching the vehicle, officers observed a loaded .40 caliber handgun inside the vehicle. At this time, one of the suspects took off on foot. Officers took two of the defendants into custody at scene. The third suspect eventually turned himself in. This was great work. All three defendants are alleged Crip Gang Members. Outstanding work by everyone involved.

Great job by Sgt. Iger who, while canvassing for a suspect wanted in a robbery, heard another call for a possible burglary with a subject matching the description of the suspect from the robbery. While canvassing, Sgt. Iger observed a male matching the description. As Sgt. Iger exited his RMP, the male took off running. Sgt. Iger broadcasted a notification and chased the suspect who was finally placed into custody with the assistance of responding officers. While the defendant was placed into custody, a third call came out for a burglary that just occurred. The defendant was charged with Robbery and two occupied Burglaries. This is an outstanding and a great job by all involved. In all, the defendant was charged with 7 Felony charges, 4 Misdemeanors, and had 4 open warrants. This story is crazy and I love it. Great work fellas!

## **TOP COPS**

### **September 2019**

On September 15, 2019 at approximately 0301 hours, the defendant FaceTimed his ex-wife and pointed a handgun at his face and stated that he wanted to kill himself. The ex-wife and the defendant's son went to the house and upon arrival, the defendant was waiving the gun at both his ex-wife and son. While inside the home, the defendant stated that he was going to kill them both. The ex-wife and son were able to call 911. Officers Mateo & Salvadori received the assignment for a suicidal person armed with a handgun. Upon arrival, the officers did observe the defendant in the basement holding the handgun in his left hand. The officers went into the home through the rear door and the defendant surrendered and was placed into custody. While inside the home, the officers observed a defaced black Smith and Wesson .380 Caliber semiautomatic handgun that was loaded and recovered numerous plastics bags containing a white powdery substance believed to be cocaine. The approximate total amount of weight of cocaine recovered was 30.2 grams / 1.129 ounces. Additionally, the defendant threatened to kill the officers who transported him to the hospital. Due to Officer Mateo & Salvador's quick response and tactics, the suicidal/violent armed defendant's life and those of his family were saved and he was placed under arrest. The defendant was charged with two



counts of Menacing 2nd: Weapon, Criminal Possession Weapon 3rd: Previous Conviction, Criminal Possession of Weapon 3rd: Defaced for Concealment, Criminal Possession Weapon 4th: Firearm, Criminal Possession Controlled Substance 3rd: Narc/Intent, Criminal Possession Controlled Substance 3rd: Narc (1/2 Ounce), Criminal Possession Weapon 2nd: Loaded Firearm-Outside Home, and Criminal Possession Controlled Substance 4th: Stimul. 1 Gram. The Top Cop Committee is proud to have Police Officer Mateo and Salvadori as the Top Cops of the First Precinct for the month of September 2019.

### **October 2019**

On October 21, 2019, at approximately 1920 hours, Police Officers Cohen and Girona received an assignment for an assault just occurred. Upon arrival, the officers were approached by a victim who stated that he was shot with a paintball gun from subjects that were driving. Officers Cohen and Girona located the vehicle and conducted a car stop of the vehicle. Three defendants were placed into custody without incident. A fourth defendant, when asked to step out of the vehicle, grabbed onto the roof rack of the vehicle with both hands and refused to let go. Officers gave numerous commands for the defendant to put his hands behind his back but he refused to comply. Officer Sukalic deployed the drive stun mode of his taser and the defendant was finally placed into custody. Upon further investigation, three other victims who were shot with a paintball gun by these defendants were identified. Due to Officers Cohen, Girona, Sukalic, and Walsh's quick response, tactics, and observation skills, they placed four violent defendants under arrest. The defendants were charged with Assault 2nd: with intent to cause physical injury with a weapon, Criminal Possession Weapon 3rd: Previous Conviction, Resisting Arrest, Obstructing Governmental Administration 2nd, Menacing 2nd with a weapon, and VTL violations. The Top Cop Committee is proud to have Police Officers Cohen, Girona, Sukalic, and Walsh as the Top Cops of the First Precinct for the month of October 2019.

When the red-light cameras were installed in Nassau County in 2009, there was public outrage. People issued tickets were complaining and demanded that they be removed. However, public safety prevailed, and the cameras remained.

Now, 10 years later, the County Executive talks in glowing terms about red light cameras because of a AAA Northeast study that showed crashes in Nassau County dropped by 26 per cent since red light cameras were installed. In her statement she said that her "... highest priority is the safety of our residents" and that "Nassau's red-light cameras are there to deter people from driving recklessly on our roads. The data shows that this program isn't just effective—it's saving lives."

That is a very powerful statement. Accidents down. Lives saved. Public safety highest priority. Seems that when it comes to red light cameras, if you do not want a ticket, slow down and stop when the light is red. It is that simple. Hard to argue with that.

### **SPEED CAMERAS IN SCHOOL ZONES**

A few months ago, the County had a press conference to raise awareness of roadway safety measure for pedestrians and drivers. The County Executive said that "...ensuring the safety of both motorists and pedestrians is a top priority." "Nassau County has a wide-ranging approach to addressing pedestrian safety utilizing the latest technology, comprehensive traffic studies and community outreach."

The County, on its website, lists several tips for pedestrians and drivers as part of its "wide-ranging" approach. Among several commonsense tips, is the following: "...everyone needs to slow down. Is that 30 seconds going to make a difference? Is it really worth it?" This sounds great, but does the County really care about public safety?

In 2014, the County installed speed cameras in school zones. These cameras did not activate unless you were speeding 10 miles over the posted speed limit. The message was clear. If you do not want a ticket, slow down in the school zone. The safety of our children was the County's primary concern. Hard to argue with that right? Well...

# Notes from Booth F

Unfortunately, the Administration at the time did not implement the program properly and people were getting tickets when school was not in session. Did the County correct the problem and maintain the program? No. The County scrapped it all together. Our children's safety did not matter as much as the political backlash. That is unacceptable and deplorable. Politicians have been putting themselves before our children ever since.

In August 2018, the County Executive wrote a letter to the County's 56 school superintendents supporting a program to bring speed cameras back. She cited a day-long 2014 study of the five school zones with the highest traffic volume and noted that 51 per cent of motorists exceeded the posted speed limit by more than 10 miles per hour. The effectiveness of speed cameras in New York City was also noted by the County Executive because only 3 per cent of tickets are being sent to repeat offenders.

Almost immediately, the County Legislature began to balk. More information was necessary, was it really a safety issue, is it really something the community will embrace...seriously?

You have to be incredibly bold to argue against speed cameras in school zones. After all, the cameras won't activate unless you go 10 miles over the posted school zone speed limit. There's been studies showing the need and effectiveness of these cameras and there has been talk about bringing the cameras back, but instead of being leaders on this issue, politicians would rather punt it and hope it goes away.

## SAFETY, BEFORE POLITICS

The County Executive recently signed legislation passed by the Legislature to allow cameras on school bus stop-arms. Those motorists passing a bus stopped and equipped with this camera will be issued a ticket. The reason cited for these cameras are identical to the argument made to bring the speed cameras back —our children's safety!

The politicians in this County need to stop playing politics when it comes to the safety of the public. In the press conference I cited earlier about pedestrian safety, it was clear the County was worried about an uptick in pedestrian injuries and fatalities. In fact, a cop in the Sixth Precinct was just injured when he was struck on a crossing by a motorist late for work. There is no excuse for going 10 miles over the speed limit in a school zone and by opposing these speed cameras, the politicians in this County are saying it is okay. The question that remains is what will they say when a child is hurt or killed?

I hope everybody had a good holiday and that Santa made it to everybody's house with something more than just coal!

We all know certain offenders who have a pretty good knowledge of the law and will not hesitate to push certain situations to the very limit, the very breaking point at which they know things will start to risk more serious repercussions for them. Keep this in mind while handling any situation, always watch each other's back, and be familiar with any and all of the new changes that will affect you during your daily patrol duties. We can

only hope for the best, but be ready for the unexpected. If there are any common, major concerns that you and your peers come in contact with, please reach out so that we can address the issue and reach a common ground for all of us who may be or will be experiencing a possible issue.

Again to touch on a delicate topic—contract negotiations. Rest assured that our Board is making the best possible decisions for the patrol division. So far, members are doing a great job of disseminating proper information and reaching out with questions or getting clarification on any information on which they are unsure. ## Seventh Precinct

Welcome to 2020, is this the year that our union must fend off a direct attack against our very existence? The signs are here.

The Long Beach Police PBA rejected a 12-year contract in late December as the terms were an assault on termination pay, vacation, sick leave, and health insurance—all the hard-won benefits that are the real value of union collective bargaining agreements. The LBPBA's rejection was in the face of public threats voiced by Terry O'Neil, the City's outside labor attorney, who threatened the department members with disbandment and contracting with Nassau County PD for police services.

First, in case you were wondering from what cloth Terry O'Neil is cut. His published articles include "Taylor Made: The Cost and Consequences of New York's Public Sector Labor Law" and "Triborough Trouble -- How an Obscure State Law Guarantees Pay Hikes for Government Employees -- and Raises the Tax Toll on

New Yorkers." It is the same cloth from which NIFA Chairperson Adam Barsky is cut. Barsky, in fact, could possibly be labeled the weaver of the cloth if not for the lack of craft that his trade entails—union busting requires little finesse, diplomacy, skill, or respect.

Second, the threat of absorption of smaller departments into the Nassau County PD, or their complete dissolution, is not new or unprecedented—Planedome, Woodsburgh, and Laurel Hollow, are all no longer and became NCPD. Whispers of a similar fate for Hempstead PD also abound. Are such threats viable? I doubt it. The scale is unprecedented—Long Beach is a city with a population in the tens of thousands. The Village of Hempstead is even larger, over 50,000 reside within its borders. It is not an economically feasible option for Nassau, there's no money in it. Nassau taking on Hempstead would be like Target putting Sears on its balance sheet. One thing is for sure, such mergers would destroy Nassau's crime statistics. Pay attention to what is included in our historically low crime numbers, the disclaimer notes: "figures shown reflect crimes reported within the Nassau County Police District and DO NOT include crimes reported in other Police Jurisdictions within Nassau County." That means the crime statistics of Long Beach, Hempstead, and others like Freeport, do not mar our numbers nor threaten our standing as New York's safest large county.

Finally, is the Nassau County Police Department the most likely replacement for a city or village looking to destroy its own department? Historically, the answer was yes but those paying attention will notice the expansion of the New York State Police under Governor Andrew Cuomo. The Troopers were already called to Hempstead in August to address an uptick in gang-related shootings. Back in January of 2017, Cuomo took troopers and redeployed them from rural areas, where they are the primary police presence, to the bridges and tunnels of NYC, amidst a very crowded law enforcement field.

Circumventing the status quo, the rules, and fair play, are the way the Governor operates now. Look no further than the criminal justice reforms that were passed with no democratic process in the state budget for evidence of his disregard. Cuomo and the New York Democratic Party are no longer blanket pro-union, they have moved so far to the left that a labor union such as ours (that provides for middle class families) is not worthy of their support. We are not the workers the Party seeks to help "rise up." In fact, our hard-won contract was and continues to be, victimized by Cuomo through his appointed NIFA Board. Remember, Cuomo's past goals and accomplishments include lower retirement benefits for public employees (Tier 6, that's you).

With a strong union and a comfortable existence,

up until now, it was easy for most of us to give little regard to class or power but it is time to start paying attention. We have been under attack for so long, since the NIFA freeze, that this state of war may feel normal. The contract is the next great battle and the only tried and true way to win is to remain united. Straying further from "one job," giving into fear and voting in favor of unacceptable terms, will assure a contract that will force out anyone capable of leaving and be the true beginning of the end. The command presence you learned in the Academy is more than a personality to assume on patrol. Act like this contract is a fight for your very existence against those who would take everything from you because it is.

Dear PBA Member,

Periodically, your PBA reminds its membership of appropriate steps that should be taken if you are called to Internal Affairs or become part of ANY department investigation. Recent events underscore the importance of involving the PBA and your legal counsel, me, as soon as possible.

Should you be called to Internal Affairs, be it as a witness or subject, you must notify your local PBA representative IMMEDIATELY. If you are deemed a subject, you have the right to have both a union representative and legal counsel with you during the interview. **If the investigation is criminal in nature, call me first!**

REMEMBER: You must be afforded a reasonable amount of time to contact a PBA representative and attorney. You have the right to confer with us both before and after questioning.

YOUR PBA REPRESENTATIVES AND ATTORNEY  
ARE HERE TO PROTECT YOU!

In any situation, be it at Internal Affairs or otherwise, where you are asked to write a letter and there is even a remote possibility of discipline, be sure to begin the letter with the following statement:

"I am making this statement for administrative purposes only. I have not done so voluntarily, but in compliance with an order of a Superior Officer. This statement in no way constitutes any waiver of my rights, and this statement, or any part thereof, may not be used against me in any subsequent criminal proceeding."

Finally, upon notifying your PBA representative that you have been called to Internal Affairs as the subject of an investigation, we will arrange to meet prior to your interview at my office to review the facts and circumstances.
