President's Message

WAGE SETTLEMENT

On May 3rd at 2am NIFA finally approved the settlements reached by the PBA, SOA, DAI and CSEA and lifted the wage freeze through 2017. There is still work to be done to restore longevity and we will work towards that goal. The wage freeze took a tremendous toll on all the county workers especially those frozen in steps.

The wage freeze not only had an impact on the personal lives of each and everyone one of us, it had a huge impact on this job. The recovery of this job must begin immediately. We need the leadership from the top to develop a plan on how this department will recover and what this department will look like going into the future. We have seen that what has happened to this job over the last few years cannot continue. If it does it will be the death of this great police department.

Back in 1966 Francis Looney was appointed the Commissioner of Police. During his tenure he changed the future of this department by introducing new technology and making this department more professional by starting Looney U which required college education. When he took over the department's strength was at 2,700 officers. Today we sit under 2,200 not including the 140 recruits that were hired May 5th. This department was the envy of all police departments for decades.

The question now is who will be that commissioner who will take on this responsibility to restore this job to where it once was and to rebuild the morale that has been shattered over the past few years. There is enough talent on this job to turn this place around but it won't happen unless there is a plan in place that makes sense for everyone to believe in. The plan needs to include restoring the closed precincts which will build morale and pride in the police officers that patrol the streets each and every day, protecting the residents of Nassau County and restoring the pride we always had. We all know it will take time to rebuild and it will not happen over night but there needs to be a vision, something that has been lacking for a long time.

NIFA LAWSUIT

Our attorneys are working on the appeal in State Court in regards to Justice Diamond's decision in Supreme court which upheld NIFA's statutory authorization to freeze wages during a control period. We will let everyone know as the appeal progresses. We still retain the Federal Court litigation challenging the constitutionality of the wage freeze. That litigation is in a holding pattern until the state litigation is completed. As stated in previous messages, the wheels of justice move very slowly as this litigation has shown.

Since this is the last newsletter until September we will continue to keep everyone posted on any updates via emails. Have a safe and happy summer.

PBA Top Cop January 2013

The PBA Top Cop committee has selected Police Officer Robert Psomas and Police Officer Scott Breslin of the Fifth Precinct as our Top Cops for the January 2013.

On January 18, 2013 Officers Psomas and Breslin while on patrol in an unmarked vehicle were investigating a complaint of narcotics activity occurring in the vicinity of a business located in Elmont in close proximity to a High School and which is frequented by students from the school.

While conducting their surveillance, the Officers observed a subject engaged in what appeared to be a narcotics deal with approximately fifteen students surrounding him. The subject left the area on foot and was stopped by the Officers. As the Officers were approaching the subject they noticed a bulge on the left side of the subject's jacket and during a subsequent pat-down felt what appeared to be a handgun. When the subject's jacket was opened to further investigate the Officers discovered a loaded Hi-Point 380 caliber handgun. The subject was taken into custody. It is because of the dedication, keen observation skills and alertness of these Officers that this subject was arrested and another handgun was taken off of the streets and for their actions they are our Top Cops for January 2013.

PBA Top Cop February 2013

The PBA Top Cop committee has selected Police Officer Richard Adams and Police Officer Michael Karp of the seventh Precinct as our Top Cops for February 2013.

On February 6, 2013 at approximately 2035 hrs two subjects entered a business in Wantagh and announced a robbery with one of the subjects displaying a pistol. The subjects removed approximately three hundred dollars from the register and fled the scene in a Kia Soul. A short time later after hearing the radio call and information on the subjects Officers Adams and Karp were canvassing the area for the subjects and located the subjects' vehicle a short distance from the scene. They were able to stop the vehicle without incident and conducted a positive show-up. Both subjects were arrested and were subsequently found to be responsible for a robbery pattern in which ten cases were solved. Due to their quick response and alertness in their duties these officer were able to locate and apprehend the two subjects responsible for the robberies and they are named our PBA Top Cops for February 2013.

Legal Report

Generally the Legal Report focuses on the procedures and news worthy events occurring within the State Retirement System regarding disability pensions or the world of Workers' Compensation. There is another major benefit that should not go unnoticed though. Social Security Disability benefits can be another lucrative disability benefit that police officers with injuries may be eligible for in addition to a disability pension. However, as with anything in life, a different system means a different set of rules and standards. Social Security is no different.

For the most part, we all pay Social Security taxes throughout our working careers. It is essentially government mandated insurance to cover us financially once a person reaches retirement age or becomes disabled within the meaning of Social Security Law. The Social Security system also covers disabled children, disabled widows, and adults with disabilities since childhood. The Social Security Disability program provides two main benefits, a monthly check and medical coverage in the form of Medicare.

The monthly check Social Security provides is the most commonplace understanding of the Social Security system. For disability purposes, this is no different. Social Security provides a monthly monetary amount to a person found to be disabled that is based purely upon what that claimant has paid into Social Security during his or her career. Typically, these amounts vary from as low as \$500 per month to as high as \$2600 to \$2700 per month. Given the salaries of police officers, the typical applicant in our office receives between \$2000 to \$2500 per month. In addition, Social Security will also provide auxiliary benefits for children under the age of 18. This benefit is in addition to the monthly benefit the disabled member is already receiving, and the auxiliary benefit may be as high as one-half of the member's benefit. Of course, the government attempts to prevent Social Security Disability benefits from being a windfall or appearing as though the injured worker just won the lottery so these benefits may come with some offsets towards other benefits, such as Workers' Compensation payments being received. However, the earnings of police officers typically are high enough to where no offsets ever exist. Plus, there is no offset at all between the Accidental Disability Retirement benefits (3/4 pension) or Performance of Duty Disability Retirement Benefits (50% pension) and Social Security Disability Insurance Benefits.

In addition to the monetary benefits that Social Security Disability provides, an approval also guarantees medical coverage for the disabled worker in the form of Medicare. If a member is approved, that member becomes eligible for Medicare benefits 29 months from the date of the onset of disability. Though not as important for Nassau County police officers with medical benefits post-retirement anyway, these medical benefits are often times one of the major reasons that people apply for Social Security Disability in order

to continue to receive care for their conditions.

Obviously, an approval for Social Security Disability for an injured worker sounds like a great opportunity for some, and it is an absolute godsend for others. Getting the benefit is always where the rubber meets the road on a claim, but there are distinct differences between the development and standard for a Social Security Disability case as opposed to a disability retirement benefit from the New York State Police and Fire Retirement System.

As you recall from past articles, when it comes to a disability pension claim for an accident or an incident, the Retirement System is evaluating an applicant as to whether or not he or she is permanently disabled from the full duties of a police officer. Therefore, the injuries suffered and how they affect the activities and duties required by a full duty patrol officer are crucial to the determination. A severe injury to an officer's trigger finger might never allow that officer to safely discharge his or her weapon in a high-risk police scenario, and thus, that officer could be rendered permanently disabled from the full duties of the job simply on that injury alone. The applicant's injury and impairment matters most when it comes to that applicant's ability to do the job, regardless of age, years on the job, or education level. The Social Security system, as you might have guessed, is entirely different.

Social Security Disability is predicated mostly upon an analysis of the employability of the applicant rather than the impairments alone. Of course, the impairments should play a crucial role in that applicant's ability to work in the national economy, but the Social Security Law and Regulations rely heavily upon the age, education, and past relevant work of the applicant as well. Most importantly to our police officers is that Social Security is not concerned only with the inability to perform the full duties of a police officer but the ability to perform any other work at all.

For instance, that same police officer from the example above might not be able to fire a weapon safely and effectively due to his trigger finger injury. If that same officer is 35 years old and has a college education, Social Security may acknowledge his inability to be a full duty police officer but find that this officer could perform other work activities within the economy. In fact, an officer on restricted assignment limited to only performing desk duties could win a disability pension but at the same time be denied his Social Security Disability because he is clearly capable of performing restricted assignment. The devil is in the details and knowing which analysis and medical opinions apply to which benefit is very helpful to succeeding in either claim.

Social Security Disability is yet another benefit to which injured workers may be entitled. However, often, these benefits are not explored by people once they are no longer able to work. A common misconception is that one needs to be receiving a disability pension in order to file or obtain Social Security Disability Benefits. This is simply untrue. As long as a person is under his or her full retirement age for Social Security purposes (typically, 66 or 67) and that person is incapable of performing any work that exists in the national econ-

omy in any capacity, he or she may be able to obtain benefits. If the combination of age, education level, past relevant work, and impairments would render a person unemployable, he or she should apply. The only requirement is that a member must have paid enough recent quarters into the Social Security system in order to file. Typically, this requires a member to file within five years of the last time he or she worked. Also, from a legal fee point of view, there is no downside to the applicant because fees are contingent upon the applicant being approved benefits, and the fee must be approved by the Social Security Administration. This fee does not exceed 25% of the past benefits due an applicant. Also, the only out of pocket expense the applicant may incur would be any costs associated with medical development of the file.

Therefore, in our office we always look at our clients three-dimensionally after they suffer a line of duty injury. The injury will certainly be covered under Workers' Compensation entitling a member to get all the medical treatment and attention required to heal and return to work as quickly as possible. However, if a return to work becomes unlikely, the member might be in line to file for a disability pension as well as Social Security Disability. We affectionately call this the "Trifecta". Of course, there are times when a member might be entitled to less than all three benefits, but they must be evaluated on a claim by claim basis and nurtured in such a way to give the member the best opportunity to win every benefit available.

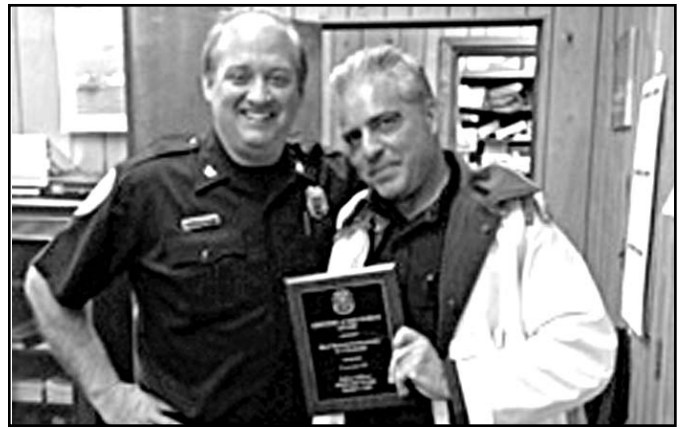

A witness at scene advised the Officers that the subjects were observed coming out of the reported location and gave the Officers a description of the second subject who fled back towards the home. A broken window believed to be the entry point was found and the Officers advised radio requesting additional units and K9. They set up a perimeter and after a search of the immediate area Officers Mazzei and Piscitelli entered the home to search for additional subjects. Inside the home Officers Mazzei and Piscitelli located and after a brief struggle, apprehended the second subject whom the witness described. The owner of the residence responded to the scene and both subjects were taken into custody. Because of their quick response and immediate actions these two subjects were located, arrested and charged with Burglary and Felony Criminal Mischief.

TOP COPS APRIL 2014

On April 20, 2014 Police Officer Edward Coddington and Police Officer Eugene Sullivan responded to a radio assignment for an unknown problem in Manorhaven. While en-route the Officers were advised that there was a subject at scene attempting suicide. Upon arrival the Officers were met by neighbors who had called 911 and the subject's mother who advised them that her son was locked in a bathroom and was attempting to take his own life. Locating the bathroom the Officers found the door locked with no response from inside. Officer Coddington kicked the door in and the subject was found face down on the floor with blood coming from his arms and multiple kitchen knives alongside of him. Officer Coddington began to clear the knives from the room by passing them to Officer Sullivan and as he attempted to secure the final knife a struggle ensued between him and the subject over the knife. The subject was subdued and the last knife was cleared from the room. As the subject was moving the Officers observed multiple razor blades on the floor that were secreted under his body and the subject was removed from the bathroom by the Officers. He was transported to NUMC for medical treatment and psychological evaluation and survived the suicide attempt due to the quick response and actions of Officers Edward Coddington and Eugene Sullivan.

The result: Due to PO Cammarata and PO Blanthorn's immediate response and subsequent observation of the subjects, four arrests were made. These arrests may have also prevented the arrestees from committing further crimes in addition to the Criminal Trespass charges that were filed on them.

As stated earlier, PO Blanthorn, an experienced veteran from our ranks, displays why he has a nose for sniffing out the bad guys. By definition, accreditation is a progressive and contemporary way of helping police agencies evaluate and improve their overall performance. It provides formal recognition that an organization meets or exceeds general expectations of quality in the field. This NY program became operational in 1989 and has four principle goals, one being to promote public confidence. It is comprised of 133 standards and divided into three categories. As for SCPD, they became accredited

in 2005. Shortly after, they began to place the decal stating such on their patrol vehicles. There is a long list of state agencies from Albany PD to Yorktown PD that also carry this distinction. There is also a long list of agencies in the state like Nassau that aren't. This by no means takes anything away from them. I hope this answered your question.

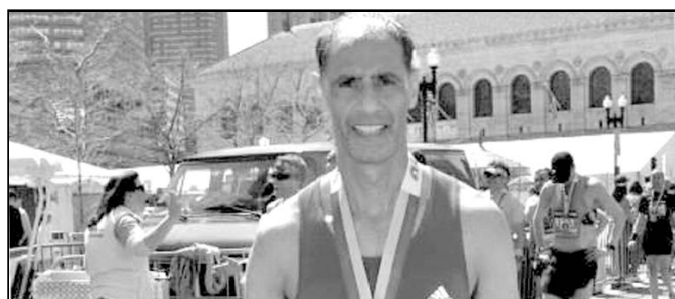
