President's Message

From an early age, one of the most important lessons we are taught is to "practice what you preach." This saying is so common that we can often forget the true meaning behind it. During this ongoing pandemic we were directed by our Commissioner to double Recruits with Officers for field training. That order violated State and CDC social distancing guidelines, put our Members in harm's way, and was just plain wrong. There was no need for this to be done, and every reason not to do it. The Commissioner, sadly, just ignored the dangers because they didn't apply to him. He said to the press that he supported his Officers, but his actions told a different story. He clearly doesn't practice what he preaches.

When the Commissioner turned his back on us, we brought this exposure risk to the attention of the County Executive. We explained how the Department's Order actually caused Members to become sick with COVID-19. We gave her an opportunity to act and she punted. Rather than doing what was right, she passed the issue off to Health Commissioner Eisenstein, who has no experience whatsoever in law enforcement. Commissioner Eisenstein said doubling recruits with a FTO was permitted based on the guidelines given to the City by NYS, even though these guidelines were related to the need to have two officers per car in high-crime areas where danger can't be avoided. The County Executive and her leadership team let us down and ultimately, put our Members at great risk.

While that was going on, the County Executive made her now-famous appearance at a tennis court. Standing next to her was not the Parks Commissioner but, the Police Commissioner. The County Executive gave her advice, that since has gone viral, about not playing with other people's balls. She also issued a new County regulation, that due to COVID-19 concerns, residents could not play doubles tennis. That left us with this sad reality about the head of our Department and our County: doubling our Members in the front seat of a police car for twelve

hours is fine, but playing doubles tennis outdoors on a court is not. That sure sounds like a double standard.

Know you all have had an extremely difficult time with the COVID crisis. I can tell you, your PBA representatives have been working hard , getting lists of PPE equipment, making sure cars are ionized, precincts are being cleaned, compiling lists of members exposed, and making sure the presumption is honored, by getting you line of duty packets, when you test positive or test positive with antibodies. All this was done on our part to make sure the Department was moving fast when you needed something to get the job done. All the PBA representatives have been doing this, daily since the crisis started, and won't stop until we are all safe.

In regards to the Medical Administration Office, I know there has been issues over the last few years. I will be in contact with them, I will discuss the issues with them, and I look forward to resolving as many issues that I can work out with them to your benefit as possible. Please feel free to contact me with any issues you may have, and we will try to work things out.

Legal Report

With the discussions that we have had with the Retirement System over the past few months concerning COVID-19, we felt this article was worth re-visiting in terms of proving the connection between a work related injury and the job itself. That connection and nexus is the foundation to either a Workers' Compensation claim or for an Accidental or Performance of Duty Disability Retirement. As such, proving that connection can be crucial to the viability of any case. This is particularly true in these claims because both in Workers' Compensation as well as the Retirement System, we are seeing the agencies take the position that without a presumption covering COVID-19, they feel that there is not enough to prove within a reasonable degree of medical certainty that the illness was contracted on the job. This is despite the Departmental Order that granted such a presumption. As such, we want each member to be informed as to what causal relationship is...and how we will go about defending any claims related to COVID-19.

Causal relationship is an issue that permeates Workers' Compensation claims, disability pension claims, and claims for line-of-duty injury status with the Police Department. Therefore, it is obviously an issue that

needs to be addressed, especially in light of the litigation that we have been involved in because of the issue of "causal relationship." In claims for $\frac{3}{4}$ or $\frac{1}{2}$ of final average salary the Retirement and Social Security Law presents the issue as follows: "[Being] Physically or mentally incapacitated for performance of duty as the natural and proximate result of an accident [or incident, respectively] not caused by his [the applicant's] own willful negligence"

Causal relationship is the connection between a work related event and the ultimate injury. If you are in a motor vehicle accident and, as a result, injure your back, then there is a causal relationship between your back injury and that car accident. In order to qualify for line-of-duty injury status under General Municipal Law, Section 207-c, there must be a causal relationship, or causality, between the event and the injury. If there is no causality, then the line-of-duty injury will be rejected and the member will need to burn his or her own sick accruals if out of work due to the injury. As it relates to line-of-duty claims, there must also be causality between an injury and any recurrence claim as well. This is where we have seen the biggest pushback by the Police Surgeons and the Department. In the example above, if that member has the car accident, injures his or her back, and then goes back to work, the causality still exists. However, what if the member wants to go back out on that back injury and that "I" number four (4) years later? If the member wishes to do so, he or she still must prove that the back injury is still causally connected to the car accident from four (4) years earlier. And, of course, the Department and the Police Surgeons will not take the member's or our word for it. Thus, in that case, we need the treating doctor to provide as much medical evidence and medically supported opinion as possible to show that the recurrence of the back injury is still related to the car accident from four (4) years earlier. This does not guarantee that the Police Surgeons will accept the treating doctor's opinion (and, in fact, typically they do not), but without that treating physician's opinion, the member will have no grounds to stand on when they request medical review or a GML Sect. 207-c hearing.

Our recent experience has also shown that this issue has become almost the pet topic of the past year or two with the Retirement System as well. On many occasions, we are seeing the Retirement System's medical experts, or the State Doctors, concede that the member is permanently disabled from the full duties of the job of a police officer. Despite this finding of permanent disability by its own medical experts, the Retirement System does an end run around this opinion and manages to deny the disability application on the basis that the disability is not causally related to the injury claimed on the application, or that the disability is merely related to age-related degeneration over time. Further, in the vast majority of cases, the State Doctor provides almost no alternative explanation for

the disability, stating simply that the disability is not related to the accident or incident.

Unfortunately, the Retirement System, despite perhaps knowing that this opinion might be hollow in many ways, still rejects the application and adopts the opinion of its own medical consultant. At this point, we request a hearing on this issue and challenge the determination of the Retirement System before a hearing officer. Thankfully, there have been several cases decided in our favor on this issue, but the time and expense (and frustration) can be taxing.

Therefore, the point of this discussion is to make the membership aware of another potential pitfall that exists with an injury claim. Unfortunately, what seems obvious to both you and us, very rarely seems obvious to the agency or Department. Also, they very well may be turning a blind eye to it simply because it is not in their best interests to accept the claims or the recurrences. So, the best way to combat this issue is to make sure that you are always discussing with your doctors whether or not they will be supportive that an ongoing injury is still related to the event or accident in question. If we can make sure that our own treating sources are in our corner, then we can better combat the issues that the job and the Retirement System will raise later on.

In addition, it is also worth mentioning that simply because a period of time has passed between an event and the recurrence does not mean that they are no longer related. It simply comes down to what the perspective of the person making the decision might be. Thus, it is not entirely unexpected that the Police Surgeon and the Department would not find the injury to still be related. However, despite questionable information that has been reported by some sources, there is no hard and fast rule as to how much time must pass before a line of duty claim goes "stale". We have been told many times by clients that they have been told that if you do not use the "I" number for two years then the claim is dead. This is not true. The issue is still whether the injury is still causally connected to the event that first caused the problem. Therefore, if there is no intervening accident, and there has been intermittent treatment, the treating doctor can offer an educated opinion on why it is still connected and the member will always have an argument that the claim should still remain open. The intermittent treatment must be provided by a physician, an M.D., since the Department does not recognize chiropractors, nurse practitioners or physician's assistants as "physicians." However, if the member has had an intervening accident(s) between the claimed accident and the recurrence, of course questions will be raised about the continuing connection between the first event and the injury. There simply is no hard and fast rule on this, and each claim must be taken on a case by case basis.

WHY YOU ARE AFFECTED BY THE 2011 WAGE FREEZE

As a Mets fan, I have gotten used to disappointment and perhaps that has helped me cope with the ongoing saga of our Wage Freeze lawsuit which was filed in 2011. Most of you believe you are not affected by the freeze because you were in High School or College at the time. However, every Cop from the Commissioner to the zippiest of zip code recruits now raising their hand is affected by this lawsuit and its far-reaching ramifications.

Please note that I am not a casual observer to this matter. I've used my legal background and experience as a former attorney to follow this lawsuit, read the legal papers and briefs, and was present for every oral argument on appeal....I've also had over \$160,000.00 taken from me as a consequence of the freeze. I have been outspoken and vocal about this matter every step of the way; have been unfortunately accurate with much of my predictions; and have suffered greatly at the hands of the County's unjust actions.

The most recent court decision is very disappointing from a legal and practical standpoint because the Judges, for the most part, agreed with our legal position. However, instead of sending it back to the lower court, as we petitioned, the Court ruled, in sum and substance, that NIFA was within their powers to freeze wages based on the conditions present in 2011. Despite this latest setback, we have decided to press on and exhaust every legal option available.

The lawsuit is no longer just about the nearly \$300 million dollars the County has taken from its workers. If a freeze were justifiable in 2011, it could happen at any time, particularly when there is little revenue coming into the County (Pandemic anyone?). That alone is worth the fight.

I've discussed in this space the importance of the PBA's remarkable foresight in 2014, and in light of this decision it is even more important that we did not take an "all or nothing" approach at the time. It was a bitter pill to swallow, and we are still faced with the unsettled issue of longevity.

This is of concern because of the pending longevity lawsuit being appealed by the County. Longevity is no longer a "top pay" problem. Those that were sworn in on May 05, 2014 are now the latest class losing the longevity they are owed. The list of affected members continues to increase, which is another reason for continuing this fight.

It is important to me that you know that being forward thinking as a course of action is preferred and that waiting for something to happen is not a plan. The PBA continued its forward thinking when it successfully had the Step Legislation passed, giving those in steps more protection than we had in 2011.

Exhausting all legal options for the wage freeze lawsuit is a continuance of that course of action and necessary to move forward. You and everyone else, deserve to know that we did everything we possibly could to protect you.

That is always a fight worth fighting.

VIRTUAL INSANITY

It has often been said that if you don't embrace technology you will become a victim of it. So here we are currently in a pandemic. In late March the Department initiates the idea of Virtual Visits with the Police Surgeon. This appears to be a good idea. Why send Force Members that that are infected by Covid to Headquarters to possibly expose others that aren't infected? Why send Force Members who sustained physical injury to Headquarters and possibly expose themselves to Covid? This seems like a very good idea and convenient to everyone.

Never forget one of first rules of business or getting conned on the street. If something is too good to be true, it probably is. The PBA embraced the idea of Virtual Visits and requested reasonable requests to protect YOU! The Department wants you to use your personal smart device to access Department E-Mails for appointments. The Department also wants you download an App so you can face time with the Police Surgeon. It was always my understanding the Department phones were to used for Department business and personal cell phones are NOT to be used. The PBA has concerns that downloading the App has GPS attached. Imagine the Department having the ability to track your location on your day off. The Department now has a crystal ball tracking your personal life. This is very dangerous. Can the Department use the GPS on your own phone and initiate discipline for something completely unrelated to your injury? You better believe it!

The Department wants to convince you that face time is a complete win for you, the injured member. When you visit the Department Surgeon's office, at Police Headquarters, it is a one-on-one appointment, with a Doctor. You get examined and the Department Surgeon determines if you stay out sick, go restricted duty, or go full duty. At times the Department Surgeon's decision is unfair and members have the option to seek the due process of medical review. Now if you use face time there is a question of privacy. Is the appointment recorded? You make think that the examination is with the Department Surgeon only. Think again! How do you know if the Commissioner, Chiefs, Internal Affairs, or Supervisors are ease dropping and taking notes on your appointment. How do you know if a Department Attorney is secretly present and taking notes on your appointment? It sounds like the Departments goal is to have the deck completely stacked against you. This sounds like an old song. The GPS in your RMPS was intended for Police Safety. It has become a tool of discipline for the Department. If you do not think for one second that the Department use Virtual Visits to discipline you I've got a bridge to sell you. The Department takes it personally on Force Members that do not wish to use Virtual Visits as to intimidate others to do so. There are current disciplines pending showing evidence of this truth. That is not how anyone who is sick or injured should be treated. The PBA goes above and beyond to protect the membership and the memorandum of agreement proposed is completely reasonable. Virtual Visits with contractual protections in place is a good idea. The Department is now using face time technology in court proceedings. The PBA will monitor this as well. Again, I would advise all members not yo use your personal property for Department business. On the bright side , we are drifting to the right side decreasing Covid cases. Hopefully things will open up and we can return so some normalcy. Will Virtual Surgeon/Court visits be here to stay?.....to be continued.

ON THE JOB

On April 14th 8th pct officers put over a notification for a robbery from a store on Hempstead tpke. 8th pct officers found the vehicle and attempted to pull it over, while doing so the subjects hit the rmp. When they finally pulled over around the 135 and southern state parkway one subject was apprehended immediately and the other fled on foot. 8th pct members put out a notification and ESU had two rescue vehicles (PO's Bruckbauer, Spedaleri, Roslow, Badolato and McWhirk) along with Sgt Papa and Faivre in the area and they assisted with the search. Once K-9 Officer Munnelly arrived, PO's Badolato and Roslow cut the lock to the sump and assisted PO Munnelly in the search with two BSO officers. Almost immediately the subject was located and PO Badolato brought the subject under control at gunpoint. The BSO officers then proceeded to search and place the subject in custody. Remember ESU is available if you ever need assistance whether it be gaining entry to a sump, pair of handcuffs, perp search, extrication the list goes on.

In March we had a great week at the range for rifle and shield work. Unfortunately that was also the time the COVID-19 issues started to arise. With not only the job on a learning curve but ESU as well we had to postpone finishing up tactics (For social distance reasons) and worked on two weeks of towing. ON THE JOB

Friday May 8th, ESU received a call for a male who fell 25 feet into a recently poured foundation at a construction site. Responding units used a makeshift ladder that was made by the construction company to climb down and join medics and first arriving PO's. PO's Badolato, Spedaleri, Roslow, and McWhirk started coming up with a plan to package the aided and haul him out. Upon arrival of Sgt. Papa, PO's Bruckbauer and Sheehan, they determined they would set up a haul line and safety on nearby trees and vertically haul the patient in a stokes backset up the ladder. PO's McWhirk and Roslow packaged the patient, and PO Roslow assisted the haul team by supporting the stokes basket up the ladder. When all was said and done the job was over within 30 minutes of ESU's arrival. It was a great job done by Patrol for notifying ESU in a timely manner, the Medics who started rendering aid and the FD who was on scene and offered any assistance needed.

TRAINING

The new guys have been in full swing of rope training and by the time this letter comes out will have completed high angle rescue, confined space rescue and low angle rescue. The last week of May brought trench training which completes the tech-rescue portion. June has more tactics lined up for the new guys including active shooter training and EDP training. Things are moving along and lets hope they will be on field training soon.

Dear PBA Member,

Periodically, your PBA reminds its membership of appropriate steps that should be taken if you are called to Internal Affairs or become part of ANY department investigation. Recent events underscore the importance of involving the PBA and your legal counsel, me, as soon as possible.

Should you be called to Internal Affairs, be it as a witness or subject, you must notify your local PBA representative IMMEDIATELY. If you are deemed a subject, you have the right to have both a union representative and legal counsel with you during the interview. **If the investigation is criminal in nature, call me first!**

REMEMBER: You must be afforded a reasonable amount of time to contact a PBA representative and attorney. You have the right to confer with us both before and after questioning.

YOUR PBA REPRESENTATIVES AND ATTORNEY
ARE HERE TO PROTECT YOU!

In any situation, be it at Internal Affairs or otherwise, where you are asked to write a letter and there is even a remote possibility of discipline, be sure to begin the letter with the following statement:

"I am making this statement for administrative purposes only. I have not done so voluntarily, but in compliance with an order of a Superior Officer. This statement in no way constitutes any waiver of my rights, and this statement, or any part thereof, may not be used against me in any subsequent criminal proceeding."

Finally, upon notifying your PBA representative that you have been called to Internal Affairs as the subject of an investigation, we will arrange to meet prior to your interview at my office to review the facts and circumstances.

Remember to update your information

For those who have not done so in a while you should check your contact and personal information with the PBA and the Department especially if you have any changes in your life. Changes may include an address or telephone number change. A change in marital status or the birth of a child. You should also make sure that your beneficiaries are up to date with any life insurance, the Pension system and the Departments Termination pay beneficiary form. If you have never completed the Termination Beneficiary Form you should do so immediately. A copy of the Termination Pay Beneficiary form (PDCN 406) is included in this newsletter and can also be obtained from the Departments Intranet site.
