### 1st Vice-President

The 2012 legislative session in Albany has started with the introduction of the budget for the fiscal year 2012. While there was an introduction for a new Retirement Tier System for new hires contained in the budget, we were pleased that they didn't go after any benefits for existing employees. **Your current pension is protected by the New York State Constitution**, but we still have to protect other rights and benefits. The Governor even went as far as to mention in his budget proposal that the new tier will only affect the "unborn". While this does not affect our current members, we are still opposing the effort to implement a new tier system. Just three years ago, Tier V was enacted for new employees and most departments, including ours, have not hired any one under this plan. This is still yet another attack on our benefits.

The budget is still being worked on and I will let you know what happens with the new pension tier proposal for new hires, if it stays in the budget.

#### Legislative issues

Workers compensation law

The PBA is supporting a bill that would assist our members that are having difficulty with getting medical treatments from Chiropractors or physical therapists. They have instituted new rules that limit the amount of treatment from what you would have normally received under the old rules.

Tier ll Death Benefit Annuity Beneficiary

This would allow beneficiaries of members in Tier ll to receive the death benefit in the form of an annuity and be able to assign another beneficiary. Currently the law allows the beneficiary to receive the death benefit in the form of an annuity but he or she cannot assign another beneficiary, therefore the benefits stopped upon their death.

#### 4th of July Holiday for Military Reservists

This bill would amend the military law so that active reservists can have the same exact benefit for the Fourth of July holiday that retired reservists have.

#### The Martins Act

This bill would allow the comptroller to seek damages due to losses in investments that occurred due to violations of state security laws. The New York State Comptroller has some ability to join in class action suits, and has done so, in order to recoup monies that were invested from the pension funds. While the Comptroller's office have recouped millions of dollars by doing so, this bill would allow him to bring a direct action for damages against an entity that committed, aided or abetted or participated in securities fraud under the Martin Act.

#### **Line of Duty Disabilities for Active Reservists**

Currently, the law provides for line of duty death benefits for public employees who are killed in the line of duty while serving our country. This bill would seek to take care of any of our members who may become permanently disabled from their participation in the war on terror so that their families would be properly provided for.

We are working on several other legislative issues and I will address them in a legislative update and later newsletter columns.

#### **Retirement System update**

I recently attended a New York State Comptrollers advisory meeting in Albany to receive a formal update from New York State Comptroller DiNapoli. He has publicly been a strong supporter of our defined benefit pension plan that we have now.

At the meeting he pointed out several issues that will be a potential problem with the new Tier VI if it is enacted. He further stated that the investment portfolio has been bringing in stronger returns over the past year. Since the contribution rate is figured with using a five year investment rate period, this should hopefully bring down the rates in the near future. We will be following this closely to see what effect it has on the next few county budgets.

The Pension system is fully funded and the system maintains a strong ranking amongst state pension systems

#### 9/11

A great deal of Police Officers and Firefighters made the ultimate sacrifice that day and they should never be forgotten. A lot of our membership participated in the rescue and recovery effort at the World Trade Center disaster and unfortunately are suffering from various illnesses as a result. We also don't know how many are going to be affected in the future. We have been working on this issue for several years on a local, state and federal level. Here is some of what has been accomplished so far:

Local level: negotiated an agreement for our members who were activated immediately after the events of 9/11 so that their families wouldn't suffer undue financial losses. We have several outstanding issues we have to deal with for our members. One issue involves our members who participated as first responders for another agency such as the NYPD or NYFD. There are several questions arising of what benefits they are entitled to since they now work for another agency. The PBA held a seminar in the fall at the PBA office, and it was very well attended. We received a lot of good ideas and we are following through with them both locally and through the state legislature.

We have been in contact with representatives from the 9/11 task force and we hope to have some new legislation put in the near future to address some of the concerns and issues that were brought up.

#### **Federal Legislation**

I am a member of the Legislative Committee of NAPO (National Association of Police Organizations). This is an

organization that represents police officers with respect to federal issues and legislation. NAPO worked closely with Congress to supply the necessary funding under the Zadroga law to provide treatment and monitoring the health of our first responders of the 9/111 attacks.

Recently, a committee recommended that certain cancers be covered under the Zadroga Act. We will be working closely with NAPO and support their efforts to include these illnesses in the law.

I will send out a legislative update in the near future to keep you advised of thee issues and any other legislative issue arises.

# **Legal Report**

Finally, after writing endlessly about the Appellate Division, 3rd Department finding that "accidents" had not occurred, I can now write about a decision in which an "accident" was found to have happened.

This case involves a Port Authority of New York and New Jersey police officer who was assigned to JFK International airport. The rules and regulations governing accidental disability retirement benefits for Port Authority cops are identical to those applying to Nassau County and all other police officers and firefighters who are members of the New York State Police and Fire Retirement System.

The facts of this case are not complicated. As part of his work duties, the Port Authority police officer was required to perform weekly safety tests to assure that all systems on the emergency fire rescue trucks were operating properly. These safety tests were called "functionals." In January 1999, the PANYNJ police officer drove a rescue truck onto one of the taxiways to perform a functional. As he was getting out of the cab and putting his left foot on the ground, he slipped on black ice and fell, twisting his left leg and ankle and hitting his head and shoulders on the pavement.

In May 2007, the police officer filed an application for accidental disability retirement benefits and a Hearing Officer granted benefits. However, on review of the Hearing Officer's decision, the Comptroller reversed the favorable grant of benefits, finding that an "accident" had not occurred. The police officer filed this Article 78 proceeding to review the decision of the Comptroller.

The Court provides a succinct definition of the term "accident": "For purposes of accidental disability retirement benefits, the underlying incident must be 'a sudden, fortuitous, out of the ordinary and unexpected event that does not result from an activity undertaken in the performance of regular or routine employment duties." Further, the Court noted that "A[n] [applicant] seeking benefits bears the burden of proving entitlement, and a determination by the Comptroller will be upheld when supported by substantial evidence".

In this case, the police officer was able to establish through testimony and documentary evidence that the day of the accident was cold and clear with no precipitation. The record showed that the taxiway was dry as the police officer and his partner drove to the spot where they would be performing the functional, and the cop saw no ice as he was exiting from the truck's cab. The cop testified that he had never experienced icy conditions on the taxiway unless it had snowed.

As a basis for denying the occurrence of an "accident", the Comptroller based his determination in part on the application for benefits, on which the police officer assumed that the ice was created by leakage from the truck. In his testimony, however, the cop said that he did not see any water leaking from the truck and his assumption was based on the fact that there did not seem to be any other explanation for the presence of the ice. The court noted that the record did not contain any evidence of such a leak.

The Court went to cite examples of when a slip and fall on ice would not be an "accident" and would be an "inherent risk" of the duties being performed: a fall caused by a slippery surface is not an accident when that condition could have been reasonably anticipated, i.e., applicant slipped on ice while stepping over 18-inch snow bank on snow-covered sidewalk; a firefighter applicant (same rules and regulations apply) witnessed fire department douse an area with water in sub-freezing weather and he slipped and fell on ice that accumulated while he was fighting the fire in sub-freezing temperatures.

The Court concluded with the observation that "we have never countenanced a doctrine, and cannot do so now, that would hold that any slip and fall during the course of work performed outside during winter renders that event foreseeable." As a result, the Court found that the Comptroller's decision was not supported by substantial evidence and the matter was sent back to the Comptroller for further processing consistent with the Court's decision.

This is a very nice decision indicating that when there is some unforeseeable intervening factor that is the cause of the ice in winter, a slip and fall on that ice can be an "accident" within the meaning of the law.

Unfortunately, the following week, on February 9, 2012, the Appellate Division came down with five (5) decisions and those applicants lost all of them. We have to relish Appellate Division victories when we can.

Police Officer is protected by a contractual provision known as "medical review". As part of this process, the Nassau County Police Surgeon will call you to discuss the officer's ability to return to work in a "light duty" capacity. Please be advised that all officers are required to work 10 - 12 hour shifts answering phones and interviewing complainants that enter the station house. If the surgeon articulates any reduced work schedule or special accommodations for your patient, please request that this information be put in writing and submitted to you for agreement before you state your opinion on your patient's ability to work.

#### **Second Precinct**

#### TRUSTEE REPORT

I am writing this, in the aftermath of the February 13th legislative meeting where various committees met, and voted on several police issues including the issue of Precinct closures. At the time of this writing, the issues were pushed forward for a vote to the full legislature. I as well as all of you, wait their decision.

Putting aside the issue of precinct closures for now, something else passed the rules committee that is worth taking note of. It was a new rule that gives the Police Commissioner full authority to fire anyone he sees fit, without the benefit of the member going to an arbitrator.

On June 8th 2008, the PBA entered into an agreement with the county, to give you the working Police Officer, the right to see an arbitrator if your penalty exceeds 10 or more days. While very few members' have taken this option since this was enacted, it gives you various protections that are necessary for you to do your job.

Apparently the legislators, and the new police commissioner, want to bring back the bad old days, were the working police officers can be at the whim of one man. A time where there were no checks and balances, where you have the right to go to a departmental hearing, where your guilt is predetermined. The PBA has asked to have these arbitration rules put into place to protect you from politically motivated firings.

In recent times, the departmental hearings by the Disciplinary Review Board have been fair. Many of my 2nd pct. members' had been able to go there to explain their actions, and get favorable results. In the past 9 years I have been involved in the Union, I felt that the department took a turn for the better when it comes to discipline.

I personally remember the bad old days. When I had 4 years on the job, I was asked by several superiors officers (All of which are retired) to change fault on an accident report, to help a friend of the Chief of Patrol. (Also retired) As you know, I refused to do so. Without going into painstaking detail, I was privately threatened by several supervisors, and brought into Internal affairs without the benefit of a PBA representative or an attorney.

At that time, the department would tell you that I was a witness. I can tell you I was absolutely a subject. And my very livelihood was at stake. All for a 2 car property damage auto accident. While I never was disciplined for anything connected to this incident, it was due to the actions of Gary Delaraba and the PBA. However, this could have easily gone the other way. I can tell you that I and my family suffered during this time. At that time, I was in my 20's and had a more Pollyannaish view of life. I can tell you it was an eye opener.

My point in telling you this story is that the actions of the new police commissioner and the legislators are clear. They want to go back to the days where you get fired for your political standing in the department, whether you are liked, or who you have as political friends. You will not be free to make an unbiased call based purely on the law anymore. You will have to be aware of who you are dealing with politically, and act accordingly.

It is my hope that the legislators rethink this. While I'm sure our new police commissioner is a nice man, many at the top of the Police Department are subject to political pressure in making decisions. We cannot have politics involved in decisions that affect people's lives, their families, and their ability to make a living. What is the harm in having an arbitrator look at the decisions made?

This is a direct attack on the working police officer, as I wrote last month; both sides of the isle have the goal, of making your families suffer, and making you the enemy of the people. As you can see, they are attaining their goals. I

don't want to see anyone go through what I went through during late 1994-95. You should be free to do your job, without politics getting in the way. While arbitration is not perfect, it is necessary to have checks on the new police commissioner.

We need to more aggressively fight the administration, on this and other issues. These Politicians have no problem, with some of you losing 2 grand a month in pay, cranking up discipline, closing precincts to diminish police services, all designed to make your job more difficult. It's time we make some of them uncomfortable.

- 1 Detective Lieutenant
- 4 Detective Sergeants
- 27 Detectives

### **Fourth Precinct**

On February 12, the three Republican-controlled legislative committees voted along party lines and sent Ed Mangano's police reorganization plan to the the full legislature for a final vote on February 27. Hundreds of angry residents and law enforcement personnel voiced their opposition. Many pointed out the obvious bias by Republican committee legislators. Legislators were asked by the public to leave politics out of their decision and to vote for what is fair and ultimately the right choice for the people who elected them and for whom they represent.

For hours the public listened to Rob Walker, an appointed official with no law enforcement background, and Thomas Krumpter, recently removed from the Acting Police Commissioner's position to Deputy Police Commissioner, speak on Acting Police Commissioner Dale's behalf. Dale was present and has been leading the department in an acting role for the last 6 weeks. His inexperience as a Nassau Police Official was evident by his inability to answer questions about his "personal plan" on his own. The presentation ended with the Nassau County Police Department Mission Statement. The mission reads: To serve the people of Nassau County and to provide safety and improved quality of life in our communities through excellence in policing.

The mission is a powerful statement and is accompanied by core values: Loyalty, Integrity, Fairness, and Excellence. In the last three weeks, the County Administration and the Police Commissioner have generated a drastic and not well thought out plan that would negatively change the way policing is provided to the residents of Nassau forever. It should make you wonder if the leaders of our County and the Police Department follow the NCPD Mission and it's values.

Where is the Loyalty to the residents and communities we serve? Is it by diminishing eight precincts to four precincts within a matter of weeks while not considering the public safety risk to residents. Is it trying to balance a bloated budget on the back of public safety? Nassau County started with four precincts in the early 1900's and as the population grew so did the Police department. Today's current layout works and has provided Nassau with the reputation for being the safest municipality of it's size in the country. This is a testament to the police officers who go out there everyday to protect the public in Nassau. As a resident stated at the hearing: "why change something that is not broke." This change is drastic and the proposed annual savings is a minimal return for what is ultimately being sacrificed: your public safety.

Integrity speaks to obeying the law, individual accountability and responsibility for actions and decisions. When a new idea is proposed that affects the residents of Nassau County, the common practice by the legislation will be to hold public hearings before they go to a vote. It is a legislative process law that has been adhered to for many years. When this idea was first leaked to the public a couple of weeks ago, the Mangano administration tried to avoid all public hearings. The goal was to avoid public opposition and to place this idea, because their "plan" lacks sound numbers and information, into the hands of the Republican dominated legislative process for immediate approval. In the last couple of years, ideas have floated around in regards to consolidating the police department. At first, it was combining the 2nd and 8th precinct. In late 2011 it evolved into closing two precincts. Not included were the 1st and 5th precinct, which under the new plan will be gone. Now a couple of months later, the County has proposed the closing of 4 precincts. The precincts that are closed will then be converted into unnecessary and community policing centers. Acting unwanted Commissioner Dale also praised technological advancements in the department. It was noted that these advancements such as touch screens in cars and the updated radio system alleviate the need for a precinct. The Acting Commissioner was a three star chief with the NYPD. Historically, NYPD has always been on the cutting edge with technology and equipment. At no time during his lengthy tenure as a supervisor did he implement the closure of city precincts. Currently, the city is adding another one in Staten Island. Does the Acting Commissioner truly believe this is right or is he abiding by the rules set forth by the County Executive to try at all cost to bypass contractual obligations to fill police cars? It is a simple equation: closing precincts will lead to less police officers on the street and an increase in crime.

Residents deserve impartial service from the department. When you look at the proposed closures, it is clear that the minority communities in the First Precinct and the

Fifth Precinct suffer the most. Where is the fairness to those citizens? How can the Police Department and County Executive earn the respect and continue to strengthen relationships with community leaders and their residents when you strip away their core services. This is not about race but about a Police Department and County administration that should provide the best police service to each resident no matter his or her socio-economic status. Hundreds of residents from the 1st and 5th precinct have signed petitions against the closure of their precincts. Residents physically show up to civic meetings and hearings by the legislators. Their voice as well as many other county residents voices are being heard loud and clear. Unfortunately, politics, not what is best for residents is what is dictating the final decision.

We are constantly reminded that we are committed to excellence in the police service we provide. There is no questioning the tough economic times that we are all currently experiencing. It is nationwide. But, policing is a vital service that should never be compromised. I agree that technology and methods of policing have changed throughout the years and as department you must adapt in order to provide the residents you serve with the best policing possible. Criminals continually adapt and so should the department. Under this proposed idea, two out of the four precincts are in flood zones and during natural disasters/storms, most recently Hurricane Irene, will have to be evacuated. That idea is not following a commitment to excellence in police work. Hiring outside law enforcement officials for \$150,000 a year to carry out an elected officials agenda is not an example of excellence in policing. Stripping citizens of precincts or safe havens and opening community centers is not providing excellent service to the community. Implementing this idea, because you can (based on party vote) with so much public opposition does not encompass the importance of excellence. If anything it is Un-American.

The final vote for the implementation of this "plan" is on Monday, February 27. Your Police Department and elected officials should be here to serve you. Your voice should be heard and recognized. Making quick judgments and rash decisions is not how we became the safest municipality of our size in the country. It has taken years to gain that status, and you can attribute it to the hard working officers who are dedicated to serving you. The Acting Commissioner and County Executive should slow down and look again at the way we are spending money towards policing instead of slashing and cutting services that the public deserves and clearly wants. We are all waiting and watching for someone to step up and make a sound decision for what is best for our residents. I assure you the criminals are waiting and watching also.

#### **Atrocity**

Although, by the time you read this newsletter and this article the outcome of the Legislative vote on the County's Police Consolidation plan, or Police Efficiency Initiative, or whatever they are calling it now will have been voted on by the Legislature. We will either be dealing with the continued demise of the Nassau County Police Department or taking a sigh of relief that a tragedy was averted. On February 6, 2012 at the Public Safety Committee meeting of the County Legislature the administration was to present their Police consolidation plan and Acting Commissioner Dale delivered the plan to the Legislature only minutes before the Committee was to vote on it. Legislator Denenberg asked the Acting Commissioner if he himself would vote on something that was presented to him only minutes earlier to which the acting Commissioner responded, absolutely not. This is exactly the point that some Legislators were trying to make, but it appeared that the Republican majority on the committee was set on approving this plan and pushing it forward for a full Legislative vote. In my opinion the Republicans had their marching orders and they were going to approve this plan whether they agreed with it or not and whether it jeopardized public safety or not. Acting Commissioner Dale attempted to answer questions but fell short of articulating the plan and even stated that he was told to bring the plan to the Legislative meeting. Maybe he thought he was just going to drop it off and have it approved without any questions. I guess the pressure was getting to be a little too much because now Deputy Commissioner Krumpter and the Deputy County Executive of Public Safety, Victor Politi joined Dale at the podium. The three attempted to take charge of the meeting and even told the Legislators to e-mail or write down their questions which they will answer at the next meeting to be held on February 13th. They kept attempting to sit down only to be called back to the podium time and time again. I don't know about you, but this tells me that they were not prepared and didn't have the answers as usual. I guess they didn't realize that they were now in the House of the Legislators and were subject to their control and questions. The arrogance grew with Victor Politi even taking cell phone calls while at the podium. Maybe the County Executive or his sidekick Rob Walker was ordering them out of there before they embarrassed themselves further. Again Acting Commissioner Dale was asked if he would approve a plan that was presented to him only minutes earlier and this time he responded, no comment. I guess he was told that his original response of, absolutely not was wrong by whom ever told him to bring the plan to the Legislature. A five minute recess was taken when the discussion became heated and when the Legislators returned, the Police Department Brass and County Executive staff were nowhere to be found. The Republicans adjourned the meeting without a motion or vote to adjourn, and left the chamber leaving the Democratic caucus and the public in shock with many questions.

I don't know about you, but I always thought that if there was a committee such as the Public Safety Committee they were to take into consideration any issue relevant to their purview and if it was not appropriate, safe or fit for approval it would die in committee and it would not see the light of day. But not so with this Republican majority lead committee, they were all set to just push this thing through even though it flies in the face of everything that is just. These Legislators are going against everything that they represent and everything that they were elected to do. They were elected to represent the people of this County, they represent checks and balances in County Government, and they are suppose to stop any plan, motion or directive that is detrimental to the County and its residents. Instead they are tuning out the pleas of their constituents to stop this proposal and they are marching in line with their party to ram down the throat of the residents and the employees a plan that should never be entertained because the County Executive wants it. I am a resident of this County, my friends and family are residents of this County, as well as many of my coworkers and I will do everything that I can to make sure that these Legislators who followed in lockstep with their party and failed to represent the people are voted out of office. This plan is not about increasing efficiency but ultimately about reducing the payroll by 100 employees and circumventing contracts that were negotiated in good faith with the County for the safety of the public and the Officers that protect them. They don't care about the work load that they planned on shouldering the remaining administrative staff with or about the diminished services that they would be providing the public. It is all about reducing costs at no matter the cost to the public or the Officers that serve them. Nothing in this plan points to increased efficiency, it just continues the trend of doing more with less and the end product will suffer for it. The arrogance of the County and the members of the Department that presented the plan to the Legislature were astounding. The ignorance of the republicans who sit on the Legislature was overwhelming and it was epitomized when Legislator Ford pleaded with the Unions to sit down with the County

and make concessions. This is no longer just about concessions, and the County was going to push forward with this plan regardless of whether there were Union concessions or not and if I'm wrong, and this was all about them trying to extort concessions from the employee unions then that makes the situation all that much worse if the Legislators knowingly had a hand in this. The County is looking to break its workforce while they continue to play charades with the residents of this County by throwing car shows, upgrading sports fields with artificial turf, and throwing free public concerts and events that ultimately cost the taxpayers' money because someone has to pay for it, all while they continue to say that we are in a financial crisis and try to balance the budget on the backs of the employees.

February 15, 1962: Judge Frank Gullota signed the charter to create the Nassau County Police Columbia Association. Patrolman Henry Tirone and Patrolman Sam DiGuiseppe formed the Association when Francis Looney was appointed Commissioner and one of his duties was to approve the forming of the Columbia Police Association of Nassau County.

December 17, 1962: First Columbian Christmas party was held at the Garden City Hotel.

May 19, 1963: The First Anniversary celebration was held at the Alitalia Restaurant in Mineola. Hugo Mutz, Jr., a Suffolk County detective was given the Association's Citation award.

June 4, 1964: A Stag Spaghetti Dinner was held at the Wheatley Hills Tavern in Westbury.

October 12, 1964: The 2nd Annual Scholarship Dinner & Dance was held at Carl Hoppl's in Baldwin.

October 3, 1965: "Italian Day" was held at Salisbury Park by order of the County Executive, Eugene Nickerson. A variety of Columbian Chapters merged at this point.


October 9, 1965: The Scholarship Dance was held at Carl Hoppl's in Baldwin.

Awards were given for achievement in entertainment. The first one went to Salvatore Baccolini of the Metropolitan Opera (a gracious recipient) and Anna Marie Albergetti (a not gracious recipient).

December 11, 1965: Christmas Party held at the Levittown Hotel. 350 people attended.
