



Legal Report

You may have heard rumors that the Police Department has begun to schedule "207-c" hearings. The rumors are true. So, what is a "207-c" hearing and why is it important to you

"207-c" hearings are held pursuant to NYS General Municipal Law (GML) Section 207-c, which provides that a Nassau County police officer (among other law enforcement throughout NYS) will be paid full tax free wages when injured in the performance of duty. In order to protect this benefit, there are some critical steps you must follow.

It all begins with the line of duty injury. Art. 7, Rule 7 of the Nassau County Police Department Manual states as follows: "When injured while acting within the scope of official duties:

1. Full pay will be granted to Members of the Force for injuries received while acting within the scope of official duties when such injury has been reported to the member's Commanding Officer within seven (7) days after the injury was sustained and it can be conclusively shown that the disability was actually received while the member was performing police duty and that no negligence on the member's part contributed thereto. This time limit may not be extended except by approval of the Commissioner of Police."

Notification of the injury to the police department will be done by completing an aided packet; it is our preference that you complete a full aided packet as opposed to a non-recordable report for the key reason that a full aided packet will result in the Police Department filing a Workers' Compensation form C-2, while a non-recordable will not. Your accident report should be accurate and thorough enough so that the mechanism of your injury (i.e., how you were injured) is unambiguous and clear. If some sort of defect, like a collapsing step, caused your injury be sure to include this fact in your accident description. (See prior editions of the Legal Report for discussions on the important difference between an "accident" and an "incident.") Make sure to include ALL the body parts that you injured. If your neck hurts very badly but you also "bumped" or "tweaked" or "poked" your back, you must include your back as an injured body part also, because if you do not and you later seek to make your injured back a part of your case, the Police Department will push back hard against your attempt to add a further injury to your

accident report and will not grant you an I-number for the injury reported subsequently. With no I-number you do not get the full salary that comes along with GML Sect. 207-c benefits and you burn your accumulated sick time for when you are not able to work. So, if with proper treatment, your neck is no longer disabling, and you are able to do RA but your back injury is becoming progressively worse and you wind up needing surgery you will burn your own sick time because the Police Department will take the position that your back injury is not causally related to your accident and all because you did not list your back as being injured on your initial accident report; this is the most typical issue to be resolved by a GML Sect. 207-c hearing.

After reviewing your aided packet, the Police Department will notify you of its determination if it finds that the injury did not occur in the line of duty. From the time of this notification, you have 30 days to submit a written request to the CO of MAO for a "207-c" hearing. According to the Memorandum of Understanding, Medical Review Board and Administrative Hearings, "The [207-c] hearing shall be scheduled to be commenced at a mutually agreeable date and time within sixty (60) calendar days of the receipt of the request for such hearing at the Medical Administration Office." Further, the Memorandum cautions of a tough penalty: "If the Department does not conform to any of the aforementioned time limitations, unless extended by mutual agreement, the member, active or separated shall receive his full entitlement of sick leave accumulation upon termination of service." However, the Memorandum is equally tough on the police officer: "If the member does not conform to any of such time limitations, the appropriate sick leave will be deducted upon termination of service." So, you must be absolutely certain to notify the police department of your injury within seven (7) days, and you must request a "207-c" hearing within 30 days of being advised that your injury is not being considered to have happened in the line of duty.

If you have already been through a Workers' Compensation case then the "207-c" hearing process will be pretty familiar to you, but with one KEY difference: In a "207-c" hearing the Police Department appoints the hearing officer from police department ranks, whereas a Workers' Compensation case is presided over by an independent, neutral administrative law judge. So, you may be asking yourself a fair question: What are my chances of succeeding in a "207-c" hearing where the police department is the judge, jury and executioner? If you're thinking that your chances are not really good, you are almost always right; appellate division cases have already held that it's Okay for the police department to appoint the hearing officer from its ranks. In one "207-c" hearing that has been scheduled, Deputy Chief Ronald J. Walsh, Jr. has been selected to serve as the Departmental Hearing Officer in the upcoming hearing.

As an example of a "207-c" issue consider the case of a police officer who broke his right foot in a fall on duty. On his accident report the police officer listed his injury

as “right foot.” Subsequently the police officer developed tarsal tunnel syndrome of the right foot. Since tarsal tunnel syndrome was not listed on the accident report, the police department has taken the position that the tarsal tunnel syndrome is not causally related to the cop’s injury. In a future Legal Report we’ll let you know how the outcome of any “207-c” hearings which have been heard and decided.

In the meantime stay safe, but if you are injured in the line of duty may it be the result of an accident not an incident. Employee Assistance Office

We would like to take a moment to remember our Fallen Heroes and their families during this years’ Police Week. They all made the ultimate sacrifice and that should never be forgotten. We especially want to remember our personal fallen heroes, PO Gary R Farley, PO Michael J Califano, PO Geoffrey J Bretkopf, PO Charles D Cole, PO Joseph P Olivieri, and PO Arthur Lopez. They all remind us of the serious dangers and sacrifices that are a part of being a police officer.

In the March edition of the PBA newsletter we spoke about who we are and what we have to offer to you, the members, and your families. There has been a lot of confusion about the difference between EAO and Peer Support. We want to explain these differences so that way there is no more confusion and everyone can get the proper assistance needed.

The purpose of the Peer Support Team is to assist immediately following a critical incident that occurred on the job. A critical incident could be a variety of things, including, but not limited to, shootings, serious injury to a member, death of a child, homicides, suicides, and or multiple casualties at one time. The Peer Support Team consists of a variety of different ranks and job titles. Typically, a Patrol Supervisor will notify the Desk Officer of the incident and request that the Peer Team is called out to meet with the individual, or individuals involved in the critical incident. In the case of a large scale event, where an Incident Commander is present, the Incident Commander assigns a Care Taker Supervisor, who then assumes responsibility for Peer Support response. In

either case, Peer Support’s response to an incident, large or small, is not considered COUNSELING!!! The Peer Team is there for support, to facilitate a healthy conversation about the incident, and to educate on what types of possible reactions, or ongoing issues MIGHT occur due to the members involvement in the critical incident. This is a very important tool for supervisors to utilize to support officer well-being. It is also an opportunity for our department to acknowledge the difficult nature of our work and to show support. Our mental health is just as important as tactical safety on the street. Our goal is to always go home to our families after our tour. However, we should go home both physically and mentally healthy!!! Peer Support will request that members participating in the Peer Team session complete a roster indicating your name and preferred contact number for Employee Assistance to reach you. This roster is then forwarded to Employee Assistance. Once Employee Assistance receives this roster we will follow up with you to make sure things are ok, provide additional support, and to acknowledge the difficult nature of the incident. This call allows Employee Assistance to inform you of the services available to you as a department member. We can also provide additional information including referrals and resources.

We wanted to thank Commissioner Ryder and Chief McCarthy for their ongoing support with the Peer Support Team and the Wellness Committee. Because of their dedication, personal beliefs and passion for mental health the Peer Support Team is back to full capacity.

We are all in this together, and the best way to ensure healthy, happy careers is to work together and always have each other’s back. If you or your co-worker’s are involved in a critical incident make sure to speak to a Supervisor or PBA rep and request the Peer Support Team to respond. #breakthestigma #urnotalone #ask4help

BRAVO ZULU

“They that sow the wind, shall reap the whirlwind.”

-British Air Marshal “Bomber” Harris

I have tried to keep many of the subjects in these articles pertinent to their occurrence in time as well as the month they appear in the article, as such is in this month’s piece.

In April to May 1945, Germany was feeling the increasing pressure. To the east of Germany, American, French, and English-led forces were on a ferocious pace towards the heart of Germany. To the west the Russians were on the doorstep of Berlin.

At the Elbe River, General Dwight David “Ike” Eisenhower

ordered his forces not to move any further towards Berlin. Eisenhower let the Soviets move into the city, in part to avenge their incredible losses. At the hands of Germany, the Russians lost “at least 11,000,000 soldiers (killed and missing) as well as somewhere between 7,000,000 and 20,000,000 million of its civilian population during the Great Patriotic War”(Dykman). The Soviets’ losses were so great that “[f]or every American soldier killed fighting the Germans, eighty Soviet soldiers died fighting”(Dykman).

Contradictory to General Eisenhower’s plan to let the Russians move onto Berlin, Stalin was concerned the American-led forces would beat them to Berlin. Stalin then “split the command of the Berlin operation between Marshall Zuhov in the centre and Marshall Konev in the south. Stalin thus effectively triggered a race between his two most senior commanders, as both of them were eager to be credited with the conquest of the German capital”(Remme).

On April 15, Russian forces began firing over a million rounds of artillery on the city. There were approximately a million Russians fighting approximately 90,000 Germans, made up predominantly of civilians. Fighting was intense just as with most of the battles in this war. The Germans showed absolute desperation, having young children and the elderly take up arms against the Russians.

With the warnings from Hitler’s staff of Russian forces approaching, Hitler committed suicide on April 30 by way of cyanide pill followed by a bullet to the head after living like a cockroach under the chancellery. Also lying with him dead were his wife of two days Eva Braun and Hitler’s dog Blondi(History.com Staff, “Adolf Hitler Commits...”).

On May 2, the Germans surrendered the city to Russian General Marshall Zuhov.

A few days later, on May 7, 1945, German General Alfred Jodl unconditionally surrendered all German forces in Reims, France. Hitler’s successor Grand Admiral Karl Donitz, Russian General Ivan Susloparov, French General Francois Sevez, and American General Walter Bedell Smith signed the agreement inside of a schoolhouse.

Shortly after the signing, General Susloparov received a message from Moscow not to sign the agreement. In accordance with his orders a second surrender would be signed the following day in Karlshorst, Germany. This time, General Georgy Zhukov would represent Russia in the German Instrument of Surrender.

This month we are recognizing three members from the Fifth Precinct: Police Officers Tanya Tucker, John Marcantonatos, and Gregory Vineyard. On a personal note, from working with these officers in the precinct, they have each brought to this job the highest levels of character, respect, discipline, as well as the desire to get the job done correctly.

Police Officer Tanya Tucker enlisted in the United States Army Reserve in 2001. She attended AIT (Advanced Individual Training) for Paralegal Specialist at Fort Jackson, South Carolina. Officer Tucker was assigned to the 7th Legal Support Organization and was promoted to sergeant two years later. In 2003, she was mobilized for Operation Noble Eagle.

Operation Noble Eagle began with the mobilization of thousands of National Guard and reserve personnel to perform security missions on military installations, airports and other potential targets such as bridges, power plants, and port facilities. Officer Tucker was assigned to a deployment station in Fort Meade, Maryland, to assist other soldiers with legal affairs prior to their deployment. She assisted with the preparation of wills and power of attorneys and gave legal briefings on USERRA (Uniform Service Employment and Reemployment Rights Act). Officer Tucker delayed a conditional offer of employment with the Nassau County Police Department to complete her mobilization.

In March 2005, Officer Tucker was hired by the Nassau County Police Department, and she was assigned to the Fifth Precinct upon completion of the academy.

In 2007, Officer Tucker was mobilized for Operation Iraqi Freedom. She was transferred to the 400th Military Police Battalion and deployed to Camp Bucca. Camp Bucca was an internment prison facility that housed approximately 19,000 detainees in the vicinity of Umm Qasr, Iraq. Working under the guise of the Office of the Staff Judge Advocate at the Camp, Officer Tucker worked as a paralegal assigned to Military Justice, Trial Defense Services, and Legal Assistance as needed.

Officer Tucker was mobilized again in 2011 to Camp Arifjan, Kuwait, and was assigned to Third Army-ARCENT. Officer Tucker was an International/Operational Law Paralegal. Her focus was rules of engagements and Geneva Convention regulations. While there, she participated in an international exercise with Kazakhstan Special Forces. Officer Tucker continued to serve with the reserves until 2015, completing fourteen years of service.

Police Officer John Marcantonatos enlisted in the United States Army Reserves in 1996. Upon enlisting, he attended Military Police Basic Training School at Fort McCellan, Alabama. He was assigned to the 340th Military Police Company based out of Jamaica, New York. In 2006, Officer Marcantonatos switched careers within the military and joined the 348th Military Police Detachment with the Criminal Investigation Detachment (CID) out of Fort Dix, New Jersey.

In July 1999, Officer Marcantonatos joined the New York Police Department and was assigned to the 23rd Precinct as a police officer in Spanish Harlem. In January 2007, Officer Marcantonatos left the NYPD to join the Nassau County Police Department, and upon graduation he was assigned

to the Fifth Precinct where he is currently assigned as a patrol officer.

In 2001, Officer Marcantonatos was activated with his Military Police Company for a Peace Keeping mission to Kosovo. While in Kosovo, his platoon was assigned to the village of Ferizaj, where they, along with other convoy escorts, conducted security patrols of the town. He also worked closely with the Greek Army as a joint mission with the local village Police Department.

Officer Marcantonatos was deployed again in 2003-2004 in support of Operation Iraqi Freedom. He landed on the first day of the war in Kuwait and within two weeks he was heading up north to Iraq. He ended up at Tallil Air Base, where they conducted Route Security Patrols, Convoy Escorts, and manned Relay Communication Towers. Halfway through his deployment he was assigned at Baghdad Airport, to perform the same duties.

Officer Marcantonatos was again deployed in 2008-2009 to Iraq as a Criminal Investigator with the Army Criminal Investigation Detachment. This time he ended up at Camp Taji in Iraq. His mission was to perform felony investigations, such as fraud, sexual assaults, and homicides, of U.S. service members and their foreign counterparts.

Officer Marcantonatos was once again deployed in 2015-2017 with the 701st Protective Service Battalion (CID) from Fort Belvoir, Virginia. For this mission he was assigned to the top two Department of Defense members. He was assigned Dignitary Protection for the Secretary of Defense and Under Secretary of Defense. He was assigned to the protection of Ashton Carter and Robert Work. Halfway through his mission he was switched to a Counter Surveillance Team for the remainder of his deployment.

Officer Marcantonatos is still serving with the Army Reserves with over twenty-two years of service and has the current rank of Sergeant First Class/ Special Agent.

Police Officer Gregory Vineyard is currently serving in the United States Army. Officer Vineyard joined the U.S. Army in November of 2007 when he completed Basic Training and Individual Training at Fort Jackson, South Carolina. After graduation, he was assigned to the 95th Engineer Company located at Schofield Barracks, Hawaii. The unit's primary mission was route clearance and IED mediation. Early in 2009, the company received orders to deploy to COB Speicher for Operation Iraqi Freedom. Officer Vineyard served as team leader of Alpha team during deployment, and he also was assigned as gunner of numerous convoy operations. Officer Vineyard assisted with the joint operations training of Iraqi Army Combat Engineers on route clearance operations.

After deployment, Officer Vineyard re-enlisted for an assignment in which Officer Vineyard received additional training located at Fort Sill, Oklahoma, to be a Patriot

Missile operator/maintainer. Upon graduation, Officer Vineyard was awarded Distinguished Honor Graduate and was assigned to 1-62 Air Defense Artillery Brigade in which Officer Vineyard served as Section Hot Crew Chief. Officer Vineyard and his Battery were deployed to United Arab of Emirates in 2013 to defend a possible threat to Dubai.

Officer Vineyard left active duty in 2014 when he re-enlisted to the U.S Army Reserves where he now is assigned to the 812th Military Police Company located in Orangeburg, New York, where he now serves as Headquarters Platoon Sergeant.

In October 2015, Officer Vineyard joined the Nassau County Police Department. Upon completion of the academy, he was assigned to the Fifth Precinct.

I would also like to take this opportunity to add that last month I found out that Daniel Scheidel from the American Legion Nassau Police Post 1050 stepped down from his position as Post Commander. I would like to congratulate Mr. Scheidel, a former Nassau County police officer who worked in the Third Precinct, for his dedicated service to the Legion, his members, and all veterans he has assisted over the years. Mr. Scheidel has been involved with the Post for over 28 years, serving in several positions.

If you have not already done so, I would encourage veterans to join the American Legion Nassau Police Post 1050. This Post is different from other Legion Posts because its members are exclusively police officers, active and retired, from the county. They may have played jokes on the rookies, all in good fun, (I had my share played on me) but they were awesome in a clutch and some of the best cops I've ever worked with, I'm sure many people on this job would agree.

REMEMBER ON THE JOB WHEN.....

We had to ask permission from CB to go on the parkway.

We had call boxes.

As we come into the first part of the year, we have seen several developments in our world as it pertains to policing in Nassau County. County Executive Curran has come out with various news stories of how they are increasing police presence in schools, responding to terrorism, threats by gangs to officers, and every other news flavor of the month. The Department always has a response. And most of the time the response is not based on reality. We are reactive instead of proactive.

Over the years we have seen times when the County was rudderless. Today, it is clear that they have absolutely no plan in regards to public safety. When the County comes out and attacks minimum manning, and antiquated work rules as the reason they can't get things done, it is clear that they have no plan of their own. Looks like, the "Plan" is that there is "NO PLAN".

It's getting really boring listening to our Department on TV, time and time again, with statements that are created to confuse, sidestep, and basically avoid the truth. We cannot sit idly by when they have not put one extra cop on the street, while our County Executive tries and con the people into believing that they are putting out extra patrols, when in fact they still leave posts empty tour after tour!

The sad truth is that we are hundreds of police officers under what we should be. Not too long ago we had an authorized budgeted strength of around 2700 officers. Today our budgeted strength is 2493, and the real head count as of this writing is 2358. I know they have been hiring as of late, but if you wonder why they don't have extra people to handle emergencies as they come up, the reason is they are hundreds of officers short of where we were less than a decade ago.

We all know that an ill conceived plan, which offers no direction or identifiable goal, is a morale killer. It's tiring wandering around in the dark, aimlessly. Those of us that ask the question, "Hey, where are we going?" will be called a nuisance by some. When the leadership talks of streamlining, those of us in the trenches know how this will go. The average cop on the street knows that "streamlining archaic work rules", only applies to those of us in the trenches. Only you will be asked to sacrifice. I have yet to see the leadership come up with a reasonable solution to the problems at hand. The leaders must lead, and they must recognize the negative effects of their actions.

I'm sure I will be criticized for this, and I'm sure some in the political circles will brand those of us who ask these sorts of annoying questions are only making this argument about overtime and money in general.

But the truth is if we were at the 2700 authorized strength,

overtime wouldn't be an issue at all. So instead of doing the job of running the county the right way, they attack your "archaic" work rules, because they do not want to hire the proper number of officers to get the job done.

Now some may say, "Who cares, it doesn't affect me." Do yourself and the PBA a favor – wake up! The county executive is trying to con the public, and hurt your safety. When they call your work rules "Archaic" and at the same time come out and say that they are putting extra patrols, when they are in fact not, puts you and the public in jeopardy.

The citizens' however, seem to understand the real value of police protection -- more so than our elected officials at times. Over the years the citizens' have supported the basic idea that all the post cars be filled. The PBA has always cared about your safety, and I would like to believe that department does too. It's sad to see them in attack mode, due to the fact that they have no plan.

I urge our leadership in the Department, to do just that, lead! Do not mislead the public that there are extra patrols, when they are none. Have the courage to stand up to those who send you out there to confuse the public.

If County Executive Curran continues down this road, the PBA will go to the public to correct the record. We will go to legislature; we will go to community meetings, and any other public forum in the community that will hear us. We cannot now or ever "Give up the Streets". We will never sell your safety short, or that of the public's. It is my hope that those in power start putting the public's safety first and political expediency last.

That's it until next month Onward and Upward!

CONGRATULATIONS



While some minor repairs were made to the property there is still much that needs t be done. I would advise the Commissioner to be careful driving in the Precinct parking lot. The potholes that were once repaired have not only returned, but look worse. I would also point out the radio tower next. It still hasn't been fenced and I would hate to see anyone damage the tower or worse have a small child hang from the low wires. Once inside, I'll show the Commissioner, but not up close, the broken floor tiles behind the desk. I will show him the Precinct turnout room/kitchen that was once described by one of our Nassau County Legislators as looking like a "frat house" because of all the furniture and debris all over the place. Keep in mind during our tour I would have a tete-e-tete explaining that we need more RMP's and radios. I remember as a rookie in both the Eighth Precinct (where I first started) and my second home the Sixth Precinct that back then there were more than enough radios and RMP's for our cops. Currently, our fleet of RMP's is at a bare minimum with some of our spare cars being used by the Third Precinct. I do believe that it's great that we are using technology to track down heroin in Nassau County, but don't forget about the Commands, County wide, that need to be adequately

equipped to do the job.

WAY TO (NOT) GO

I am sad to report that Nassau County Executive Laura Curran has made the poor choice of not honoring our Memorandum of Agreement making our members whole on Longevity. This is the same typical politician that stood on our Precinct doorstep demanding the Sixth Precinct de-merge from the Third Precinct. Seventh Precinct

We in law enforcement do not refer to one another as "brothers and sisters" to force familial importance on ordinary relationships, we really are that important to each other. It is not an overexaggeration to say our lives depend on one another.

Last month, the importance of backing each other up was brought home by some very real and very disturbing events. During the week leading up to April 20th, an infamous day that marks the anniversary of Hitler's birthday, the Columbine High School massacre, and that is additionally embraced as Weed Day, police departments across Nassau received a credible threat that MS13 was looking to murder a police officer in the Hempstead area. The ante was quickly upped when a second threat was uncovered.

Just over three years ago when NYPD Officers Ramos and Liu were assassinated during the rise of the national anti-police hostilities, the Department took the simple step of doubling our patrol cars. Three years ago there was no specific threat to Nassau but we still doubled patrol cars and naively calmed ourselves by dissociating from the threats faced by our counterparts to the west, putting too much stock in the hope that the imaginary wall that separates Nassau County from the world would keep us safe and the fact that the NCPD is blessed with an abundant supply of luck.

Fast forward back to this April, patrol cars were again doubled at the start of the week following 4-20. The Department expanded from doubling cars bordering Hempstead to doubling the entire fleet. Before this extensive doubling, the roll calls still had 10-68's—patrol cars laid up for the tour without an operator. This situation illustrates so very well the importance and the need for Minimum Manning.

By week's end, the doubling ended and we returned to our regular staffing, meaning mostly solitary patrol. There is no way to say with authority when to end precautionary measures when faced with a general threat. The seed is planted with ambitious MS13 members that the way to make a name for themselves is to take out a cop. A threat like that never really ends. Our jobs are as dangerous this month as they were last month. These events are a reminder of the importance of remaining vigilant, varying routines, and most importantly, looking out for each other.

As the County and the PBA start the work of negotiating a new collective bargaining agreement, if nothing else, this dark time shows us without any question the grave importance of Minimum Manning. At the end of his career, Commissioner Larry Mulvey highlighted publicly the vital importance of Minimum Manning,

one of the few tools left that “keeps the politics out of policing.” For a time in April, we saw how contractually-negotiated mandates are often interpreted—minimums become maximums—even in the face of additional threats.

In the ever-contentious realm of labor and management relations, Minimum Manning is one argument on which the PBA clearly falls on the side of right. The public benefits from the protections of Minimum Manning with quick response times and an ever-ready patrol response. The day a Nassau County patrol car signs on duty and is informed by CB that they are holding 30 calls, you will know that the imaginary wall fell, and the east became west, and that Minimum Manning is dead.

1935

The year started off with two changes to the Board, John Muller was the new Recording Secretary. Fred Bahr and Edward Horning were now Trustees. The Delegates were now elected in the Spring and took office on June 1. They were; PCT.1 – Robert Dryden and Richard Smith, PCT.2 – Edward Pait and Thomas Thornton, PCT.3 – John Zolezzi and Alfred Johnson, PCT.4 – Frederick Hiscock and Harry Billingham, PCT.5 – William Pearsall and George Erody, PCT.6 – Charles Plaskett and Arnold Smith, HQ – Joseph Dorsch and Alfred Zimmer.

On January 7, the Board concluded the trial of former Financial Secretary James Campbell. Only one of the Delegates admitted to spending the dues money that he had collected, the others all denied it. The Board ruled that Brother Campbell had to repay the Association a total of \$1,993.94 through monthly installments of \$20.00 to remain a member of the Association. He accepted the ruling of the Board.

The year 1935 would mark the Tenth Anniversary of the Department as well as the Tenth Anniversary for Chief Skidmore at its helm. The Board voted to commission an oil painting of the Chief in honor of his tenure and that of the Department.

February brought a first, the men began to complain about radio cars being assigned to cover school crossings. They could not leave the crossing for any reason which meant that cars had to respond from several miles away to cover calls if a car was on a crossing. For the first time in Association history, the President was to be compensated for using his own personal vehicle for Association business. The amount of his compensation was to be 5¢ a mile. Also, this month the Association purchased its first subscription to 'The Chief.'

In March the Board drew up petitions that were to be sent

to Governor Lehman urging him to support the 'Connery Bill.' This called for additional compensation to any worker throughout NYS, including Police Officers, who performed work more than eight hours. The Board also reinstated the Death Benefit in the amount of \$500.00.

Mrs. Minnie Graham was the first to receive this upon the death of her husband Ptl. Harry Graham, 'a Member in good standing.'

In April the Association and the Department were again receiving numerous complaints with regards to the soliciting tactics of the Nassau Police Conference. This prompted President Hanlon to issue a press release in which he stated that these solicitors were in no way connected with the Police Officers and Patrolmen's Association of the Nassau County Police Department or were any of the solicitor's members of either the P.O. & P.A. or the PDCN. Shortly thereafter the complaints subsided.

At the May Meeting the Board discussed reports that former President William Ryan was "bouncing," which meant that he never worked the same post. The Board voted to investigate the matter and eventually the 'bouncing' came to an end.

The Board also began discussions on an Insurance Fund. A committee was formed to investigate the matter. There were continuing lengthy discussions regarding the money that was still owed to the Association by some members.



Police Unity Tour

In May 1997 the Police Unity Tour was organized by Officer Patrick P. Montuore of the Florham Park Police Dept., with the hope of bringing public awareness of Police Officers who have died in the line of duty and to honor their sacrifices. The Police Unity Tour started with 18 riders on a four day fund-raising bicycle ride from Florham Park, NJ to the National Law Enforcement Officers Memorial in Washington D.C. which raised \$18,000.00. Today, the Police Unity Tour has over 1900 members nationwide who make the trip. In late 2005, the Police Unity Tour pledged \$5 million in support of the National Law Enforcement Museum. Inspired by our commitment and our motto, "We Ride For Those Who Died" , the National Law Enforcement Officers Memorial Fund has selected our organization to be the sponsor of the Museum's Hall of Remembrance. As of May 2016, the Police Unity Tour has donated over \$20 Million Dollars, which included this years highest donation ever of 2.5 million dollars.

Chapter 37 New York

We are the NEW YORK chapter of the Police Unity Tour. Chapter 37 was started by Port Authority police officers in 2002 and named in honor of the 37 PAPD officers who were killed in the line of duty on September 11, 2001 at the World Trade Center. Although designated the New York chapter, our membership of active and retired law enforcement officers also includes police departments from California, New Jersey and New Hampshire. We also view ourselves as the 9/11/01 Memorial Chapter. The original Chapter 37 members are represented by members of the Port Authority NY/NJ, Huntington Beach CA, Glendale CA, Nassau County and the New York City Police Departments. A pledge was made by the original members that Chapter 37 will always start our Tour at the World Trade Center to honor, respect and remember the 72 officers who lost their lives September 11, 2001.





The NCPD Hispanic Society Memorial Scholarship

The NCPD Hispanic Society Memorial Scholarship is awarded in the memory of two Hispanic officers who took pride in this department, in the community for which they served, as well as in their heritage - Detective Arthur Lopez, who died in the line of duty October 23, 2012, and Detective Al Samaniego, who passed on November 6, 2013, and was very involved in the community.

This scholarship will be open to **immediate family** (child, grandchild, sibling, niece, nephew, cousin, etc.) of Hispanic Society members in good standing. It will be offered to high school students registered for college, as well as students currently enrolled in an accredited college on a full time basis. Applicant must have minimum 3.0 GPA (numerically 87.5) at time of application. Verification of academic status must be submitted with application and essay. Maximum age of applicants will be **no older than 24 years old** at time of application deadline. Scholarship check will be made out to the school of attendance. Bursar receipt showing payment of tuition must be submitted upon receiving scholarship funds. The essay must be typed, double spaced, size 12, Times New Roman font, with the paper having 1" margins. There will be a **minimum of 500 words and a maximum of 700**. Essays will be read & graded on a set scale by the Executive Board. Final submissions must be received by midnight of due date. A personal interview to decide final placement of the top essays may take place. All decisions by the Executive Board will be final.

Applications and essay must be received no later than April 29, 2018. Two scholarships will be awarded for \$1,000.00 each. Applications must be completed and mailed with the essay. The scholarship winners will be honored at our Scholarship & Awards Memorial Dinner Dance on **May 31, 2018**. Additionally, the scholarship winners will be awarded their ticket to the dinner to receive their award.

Who is the most influential person in my life and how have they inspired me to be a better person, to work to the best of my abilities, and to also be involved in the community?






