## Legal Report

You have seen us write for many years about World Trade Center disability claims and benefits with a great deal of success. In fact, over the last several years, we have seen a remarkable change in the way that the Retirement System has handled these types of claims. However, there are still members out there that may have not filed for the valuable benefits to which they might be entitled. With that in mind, we wanted to make sure that the members are kept up to speed with some of the most important aspects of these cases.

Notice has been something that both the union and our office has preached in messages over and over. As of right now, the deadline to provide notice to both the Retirement System or to the Workers' Compensation Board of your participation in the rescue, recovery, or clean-up operations surrounding the WTC attacks is September 11, 2022. That means that if you have not yet provided notice to either of those Systems, if you file any claim for benefits at any point in the future without a valid notice form on file, your application will not be accepted or processed. While that deadline has been extended many times over the years, there is no guarantee that it will be extended yet again. This notice is not a filing of a claim, and it does not require any conditions or for a member to be going out of work or even seeking treatment. It merely means that you are placing the System on notice that you participated at the sites.

Regarding the qualification for the WTC Accidental Disability Retirement Presumption, the requirements

have not changed since the latest amendments made years ago. Thus, in order to qualify under the aegis of the presumption, a member must have either been down at one of the sites on either September 11, 2001, or September 12, 2001 (within the first 48 hours of the attacks), or have participated in the rescue, recovery, or clean-up operations for 40 hours or more. Without meeting those requirements, the member will not qualify for the presumption regardless of the severity of his or her condition. We have challenged several of these cases on varying grounds of justice or fairness, but the Retirement System is unwavering in its fight on this issue.

We have seen several different types of problems with meeting the presumption, but with each one, we must analyze the claim on a case by case basis. We currently have a case in litigation where the issue with the Retirement System entails the proof provided by the member. While we have a member with several affidavits of fellow officers confirming his participation in work activities at the WTC site on September 11, without confirmation by the Department, the Retirement System will not accept the affidavits. While we are very confident that this will resolve in favor of the member, the fight from the System is real and has forced us into multiple hearings on the matter. Other cases have turned on the number of hours at the site and the dates of participation. Other cases have turned on whether a member went down to the site as a volunteer or as an employee. In each instance, we have a different set of facts to argue.

Further, simply being accepted into the World Trade Center Health Program is not dispositive proof of participation either. The Health Program has a different set of criteria to qualify responders for treatment than the Retirement System does to meet the presumption. Thus, we can have a member who qualifies for benefits through the Victims' Compensation Fund, yet that same member cannot qualify for 3/4 benefits through the Retirement System. That is the sad reality of some of the claims that we have handled over the years.

However, there is a major silver lining to this. The Retirement System over the past several years has changed course on the amount of these claims that they are approving. In fact, this month alone we have seen 3 members approved for WTC related Accidental Disability Retirement benefits. One of these members had an active claim while he was still on the job, but the other two were retired for many years before unfortunate diagnoses allowed for our office to assist them file for Reclassifications of their pension from regular service related retirements into WTC claims. One of these members had been retired since 2006.

The claims also resulted from varying conditions as

well. From cancers to mental health claims to chronic fatigue to severe respiratory issues, we are seeing the Retirement System approve the vast majority of these cases in the last four to five years. We also have a sizable number still pending as well for which we have a great deal of optimism. Also, keep in mind that while the reclassification of your pension to WTC related is only prospective from the date of approval by the Retirement System, it will be based upon your already established final average salary but would be 3/4 of that number, tax-free, for the remainder of your life, and if you have chosen a beneficiary to your pension, the remainder of that beneficiary's life. Obviously, this can be an incredible lucrative and financially life changing outcome in many instances.

## **BUFFY'S SPOTLIGHT**

On April 6th, Officers responded to a report of a house on fire on West Fulton Avenue in Roosevelt. Upon arrival, Officers Connell, Julich, Didonato and Mateo observed heavy smoke and flames coming from inside the house. Officers forced entry into the home to search for possible victims prior to the fire departments arrival. As officers attempted to search the second floor, they were met with heavy smoke, and extreme heat but could see a what appeared to be feet at the top of the steps through the smoke. Officers were able to reach the victim, who was unconscious, and were able to pull the victim out of the fire and outside for medical treatment. The victim was rushed to the hospital, but was later pronounced. Officers Connell, and Julich were transported to the hospital due to smoke inhalation. Even though the victim succumbed to her injuries, these officers made entry into a burning home without proper protective gear, and were able to pull the victim to safety and give her a fighting chance. Sad outcome, but outstanding work fellas!!

On April 13th, Officers Slevin, Estrada, Alonge, and Oliva responded to a domestic disturbance in Roosevelt where the victim stated that her granddaughter who was at the location in violation of a stay away order and was making statements that she was going to kill everyone in the house and burn it down. As officers entered the location they were directed to an upstairs bedroom where the suspect barricaded herself in. After speaking through the door, officers were able to get the suspect to open the door and as the suspect exited the room she pointed back and officers could see she had lit the bedroom on fire. Officers attempted to place the suspect into custody while still outside of the bedroom where she violently resisted arrest as the bedroom became engulfed in flames. Officers had to forcibly drag the suspect out of the house and to safety before the house became engulfed in flames. Sounds easy until you see the size of the suspect. Again, this is an example of a WTF moment as officers had to drag a suspect from a home, that she had lit on fire herself, putting

themselves at great risk of serious injury. Outstanding work boys!!!!!!! And as if the suspect didn't do enough damage, while watching her families house burn down she shattered the rear window of the marked RMP!!!!

On April 17th, officers responded for a call of a house fire. Upon arrival, Officers Gotti and Bogan observed a fire near the front door and were instructed that an occupant was still inside the home. Officers then went to the 2nd floor of the home with a heavy smoke condition to find the occupant. Officer Gotti did find the victim with the assistance of Officer Bogan. The aided was removed from the home with the assistance of Officer Scott.

Roosevelt Fire Department responded to scene with the assistance of the Uniondale Fire Department and extinguished the fire. Fire Chief Tyler of the Roosevelt Fire Department ran fire operations at scene. Victims were transported to NUMC in ambulance 2361 for further treatment of smoke inhalation. Officers Bogan, Gotti and Scott were transported to NUMC in ambulance 2351 for further treatment and evaluation due to smoke inhalation.

On April 24th, PO responded to multiple 911 calls for a working house fire. Upon arrival SGT Giovaniello and PO Braun observed the home on fire and top floor smoked out. Officers gained entry through rear basement door where they woke up and extracted the tenant/victim. Officers then attempted to clear the top floor until notified the homeowners was not home. Bellmore FD arrived on scene and extinguished the fire. The Victim, PO Braun, and SGT Giovaniello were all evaluated and treated on scene.

As for my last Buffy Spotlight, I saved this one for my partner. And yes, me being off while he grabbed hardware is the reason why I left and went to the Squad.....

On March 20, 2022 at approximately 2241 hours, First Precinct GAP/Special Patrols Officers Vitale and Turbush were assisting patrol units that were responding to an unknown problem at 128 Hudson Avenue in Roosevelt. Officers Vitale and Turbush while in unmarked RMP 126 canvassing the area for suspicious activity observed a male black wearing a multi colored hoodie, black pants and black boots walking quickly northbound on Nassau Road carrying a black jacket and attempting to cover his left side waistband. Officers approached the suspect and identified themselves. The male immediately changed directions and began walking eastbound on East Fulton Avenue. At this time Police Officers Turbush and Vitale observed the butt of a black handgun tucked in the suspect's left side waistband. As officers exited the RMP and approached the male at the intersection of East Fulton Avenue and Wilson Place he was observed by officer Turbush throwing an unknown object into

the storm drain. Both officers heard the sound of an apparent metal object strike the steel storm grate and observed the suspect immediately walk away. The male was subsequently placed into handcuffs and stated: "I smoke crack, stem in my pocket" and "It's in the pocket, it's right there." Officer Vitale recovered a white rock like substance which is believed to be crack cocaine from his right front pants pocket. The suspect then stated: "I threw a stem." Officers Turbush and Vitale did then locate a black handgun with "MILLENNIUM" labeled on the side inside the storm drain. Officers did locate a New York State ID card in the suspect's pocket and identified him as living at 128 Hudson Avenue in Roosevelt, the same location as the unknown problem. Officers Turbush and Vitale were able to confirm with patrol units that defendant Badger was the suspect of the incident at that location.

Officers later found out that the defendant while at 128 Hudson Avenue came into the home, kicked in the victim's bedroom door and started cursing and physically fighting with him. During the fight the defendant pulled a black, loaded handgun from his waistband and pointed it at the victim's head and pulled the trigger, however the gun did not discharge. Another victim stated that he heard the fight and as he opened his bedroom door he observed the suspect pointing a black gun at the victim's head. The 2nd victim attempted to pull the suspect away from the victim. While the suspect was holding the black gun, he began to physically fight with the 2nd victim. The suspect then pointed the gun towards the 2nd victim's leg and pulled the trigger twice however the gun did not discharge. The defendant was charged with 3 counts of Criminal Possession of a Weapon, Gun, Attempted Murder 2nd, 2 counts Attempted Assault 1st, Burglary 1st, Menacing, CPCS, Criminal Contempt, Tampering and so on and so on, you get the point! Outstanding Job. Hardware to boot!!! This is the prime example and definition of Jump Out Boys. Not having any information about the call or any description of a suspect, PO Vitale and Turbush saw the suspect and just knew. Yes, I believe that all my years working with Vito rubbed off, but no one knows the streets like Baldy!!

This is all great work being done out there, and its being done professionally and safely.

To Vito, its been a great 7 years together. This transition will be tough without you following me, but no worries I plan on getting you a Computer for Dummies handbook and I spoke to the DD, they said they will let you go to Centennial Park once a month if you decide to make the move also.

As for the rest of you, remember watch the hands, watch each other's backs because once the word is out in Uniondale and Roosevelt that Officer Lewis/Buffy/Baldies Partner is no longer on the street its going to be a free for all. You think the DD will let me do a FI here

or there???

A suspect entered the store and ultimately shot three people causing one to lose their life, and seriously wounding two others. These two officers responded to the location forthwith entering the location and heading straight to the manager's office where the incident took place. These officers exposed themselves to grave danger entering the establishment to secure the scene, provide medical attention to the wounded, and transmit the necessary information to obtain proper medical help for the wounded as well as a description of the subject. These two officers assisted medics in getting the wounded out of the building to receive necessary life saving medical attention, after which they stayed behind and continued to secure the scene. For this heroism these two officers have been awarded the distinction of Top Cop for April of 2021! Well deserved recognition for these two brave officers! I would also like to extend my gratitude and respect for all our other officers, medics, supervisors, and first responders who also responded to back up these fine officers, and to help at the scene and ultimately apprehend the suspect. Hats off to all of you, it's the teamwork that ensures we are all able to conduct ourselves in the fashion we do, and the comradery which allows first on scene officers to enter extremely dangerous situations and know that they can always count on the fact that their back up is mere seconds away. ## TOP COP

The intelligence bulletin depicted a black dodge charger with tinted windows and black rims which was used in the commission of a gun point robbery earlier in the month. The vehicle was then pursued by BSO officers Psomas and Sierzant with the assistance of the 1st precinct. The subject stopped and exited the vehicle and attempted to again fire his weapon at Officers and fled on foot. A yard to yard search began with the assistance of multiple BSO officers including Lt. Delargy who arrived on scene, first precinct units, canine, aviation, and others. After a sighting of the subject BSO lieutenant Dan Delargy sprinted a long distance in the direction of the last sighting and encountered the subject who was still armed with the handgun. Lt. Delargy gave the subject verbal commands who then dropped the firearm and surrendered. Lt. Delargy then placed the subject into custody. The subject is a member of Crips street gang was out on parole and was wanted for robbing a woman in her driveway at gun point. These officers in the line of duty distinguished themselves by chasing an armed violent felon risking their lives after being shot at, protecting other officers and innocent people in the area. Their courageous act ended with no injuries to the public or the defendant, and removing a violent felony offender from the streets of Nassau County who was in possession of a firearm!

# Notes From the E.S.U. Corner

## ON THE JOB

On March 21, just before midnight PO's Liguori, Runko, Carr, and Shutowich were notified to respond with K-9 for a commercial burglary in progress in Mineola. Third pct units took the perimeter and noticed the store was ransacked. ESU members forced entry into the store and entered with K-9. After a search of the store the subject was located between the roof and the drop ceiling. The subject refused to come down after multiple commands and tried to avoid ESU officers by wedging himself on top of HVAC equipment. ESU officers had to set up ladders to get direct visual contact with the subject. While trying to avoid arrest, the subject did become entangled in HVAC equipment and the drop ceiling. ESU members had to use an angle grinder to cut away parts of the HVAC system to free the subject. After some persuasion the subject was guided down safely and placed into custody without injury. Another great job done not only by first responding 3rd pct officers, but by working together with K-9 and Officers Runko, Liguori, Carr and Shutowich.

## TRAINING

During the first 4 days of April, 8 ESU members and 1 ESU supervisor took a Preventive Radiological/Nuclear Detection Team Ops Course which was taught by CTOS and it took place at the UBS Arena. It was a 4 days class where members had to demonstrate their ability to operate PRND Team detection equipment, locate sources, and identify sources. This is one of the first courses we've attended at the new UBS arena and to get the lay of the land while searching for a "radiological threat" is a great eye opener for a possible threat assessment in our backyard.

Inservice has been in full swing, we have been building over the last few years and are working on table top exercises for hazmat along with learning new equipment. Our tech rescue day was two scenarios of a high angle worker down using extended anchor points and a confined space rescue. Cell extractions and EDP's have been rearing their head more often for the guys so our tactics day we tackled those two topics.

Congratulations to PO Schwaner on a job well done!



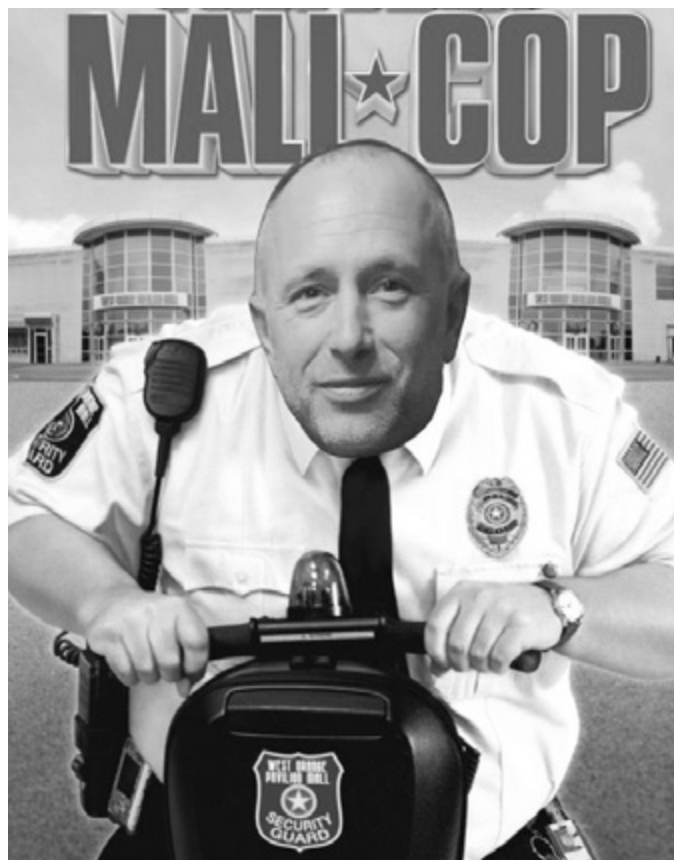
## MALL COP

This will be a combat style match and the Lewis System will be used for scoring, so everyone will have an equal chance at winning a prize.

**QUALIFICATION COURSE OF FIRE:** Fifty (50) round New York State DCJS qualification course of fire. @ 3 yard line- 12 rounds fired in two phases: Phase # 1 – 6 rounds fired in two round increments – no time limit. Phase # 2- 6 rounds fired in 6 seconds. @ 7 yard line – 18 rounds fired in two phases: Phase # 1 – 6 rounds fired in two round increments – no time limit. Phase # 1 – 12 rounds fired in 25 seconds with one reload. @ 15 yard line – 12 rounds fired in 40 seconds with one reload. @ 25 yard line – 8 rounds fired in 40 seconds with one reload. The above qualification course was designed for 6 shot revolvers. Reloading devices are suggested but not required. Semi-automatic shooters are required to have a minimum of two magazines. 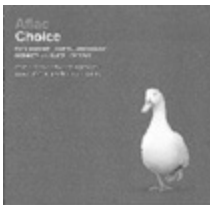

Periodically, your PBA reminds its membership of appropriate steps that should be taken if you are called to Internal Affairs or become part of ANY department investigation. Recent events underscore the importance of involving the PBA and your legal counsel, me, as soon as possible.

Should you be called to Internal Affairs, be it as a witness or subject, you must notify your local PBA representative IMMEDIATELY. If you are deemed a subject, you have the right to have both a union representative and legal counsel with you during the interview. **If the investigation is criminal in nature, call me first!**

REMEMBER: You must be afforded a reasonable amount of time to contact a PBA representative and attorney. You have the right to confer with us both before and after questioning.

YOUR PBA REPRESENTATIVES AND ATTORNEY  
ARE HERE TO PROTECT YOU!

In any situation, be it at Internal Affairs or otherwise, where you are asked to write a letter and there is even a remote possibility of discipline, be sure to begin the letter with the following statement:

"I am making this statement for administrative purposes only. I have not done so voluntarily, but in compliance with an order of a Superior Officer. This statement in no way constitutes any waiver of my rights, and this statement, or any part thereof, may not be used against me in any subsequent criminal proceeding."

Finally, upon notifying your PBA representative that you have been called to Internal Affairs as the subject of an investigation, we will arrange to meet prior to your interview at my office to review the facts and circumstances.
