

Stipulation of Settlement made this \checkmark day of \bigcirc , 2011, by and between the County of Nassau ("County"), a municipal corporation in the State of New York having its principal place of business at 1550 Franklin Avenue, Mineola, New York, and the Police Benevolent Association of the Police Department of the County of Nassau, Inc. ("PBA"), an employee organization having its principal place of business at 89 kast Jericho Turnpike, Mineola, New York.

WHEREAS, the PBA filed a grievance dated September 30, 2010, alleging that on September 5 and 6, 2010, the Fifth Precinct failed to follow agreed upon overtime book procedures by the manner in which police officers were assigned to work overtime; and

WHEREAS, the County denies all of these allegations; and

WHEREAS, the parties wish to resolve these matters in an amicable way amorigst them, without the uncertainties, costs and risks of continued litigation.

NOW THEREFORE, the parties agree to the following:

- 1. Even though it enters into this Stipulation, the PBA continues to believe that the Department's actions violated the parties' Collective Bargaining Agreement or relevant memoranda of agreement concerning overtime and overtime book procedures, and that it would prevail should the gripvance be decided by an arbitrator. For its part, the County believes that the grievance is without ment and that it would prevail should the grievance be decided by an arbitrator.
- 2. The following two police officers in the Fifth Precinct who were scheduled to be called in for overtime in September 2010, shall each be paid the number of hours indicated at their applicable overtime rate:

- In addition, the police officers described in paragraph 2 above shall not be charged for this time for purposes of calculating and recording overtime in the Overtime Book.
- 4. This Stipulation constitutes the entire settlement between the County and the PBA regarding its subject matter. No other promises have been made. This Stipulation may not be modified except by a written agreement between the parties.
- Nothing contained in this Stipulation shall be precedent setting or required the parties to enter into similar agreements in the future.

For the PBA

- 6. The grievance is withdrawn, with prejudice.
- 7. This Stipulation is subject to PBA ratification.

Memorandum of Agreement and Stipulation of Settlement ("Agreement") rhade this \checkmark day of \bigcirc 2011, by and between the County of Nassau, a municipal corporation in the State of New York, having its principal place of business at 1550 Franklin Avenue, Mineola, New York, 11501 (hereinafter called "County") and the Police Benevolent Association of the Police Department, County of Nassau, Inc., an employee organization having its principal place of business at 89 East Jericho Turnpike, Mineola, New York, 11501 (hereinafter called "PBA").

WHEREAS, the County and the PBA are parties to a collective bargaining agreement, as amended, setting forth certain terms and conditions of employment for PBA unit members; and

WHEREAS, the parties are signatories to a 1992 agreement in which the County *agree[d] not to unliaterally transfer any police unit work to nonunit Nessau County employees or volunteers* (the "Bayville Agreement"); and

WHEREAS, the parties are signatories to a 2010 agreement in which the County "re-acknowledge[d], re-affirm[ed], and agree[d] that it will not unitaterally transfer any police unit work to non-PBA unit personnel, including non-unit County employees, volunteers, outside contractors, or other outside personnel" (the "2010 Agreement"); and

WHEREAS, the 2010 Agreement provides that "[a]ny volation of this agreement shall result in payment, at time and one-half, to the next police officer scheduled to be called in for the number of hours, with a minimum of four, he/she would have received if he/she had worked the assignment"; and

WHEREAS, the County's Police Department maintains mobile command vehicles (e.g. command buses) in order to assist in its operations; and

WHEREAS, a dispute arose in which non-PBA unit members were assigned to perform security functions associated with the Department's command vehicles; and

WHEREAS, the parties wish to resolve this matter in an amicable way without the uncertainties, costs, and risks of continued litigation.

NOW, THEREFORE it is hereby agreed by and between the parties as follows:

- 1. The execution of this Agreement shall not constitute an admission of any violation(s) of the State, Federal or local statutes, laws, rules or regulations, or of any contractual agreement.
- In consideration of the PBA not commencing and/or continuing the pursuit of a contractual grievance and/or an action before the State of New York's Public Employment Relations Board, the County of



Nassau and the Nassau County Police Department agree that the security functions associated with all Department mobile command vehicles will be performed solely and exclusively by PBA unit members.

- 3. All police officers who were scheduled to be called in for overtime on the date(s) when the security functions of a mobile command vehicle were performed by or assigned to a non-PBA unit member shall be paid four (4) hours each at their applicable overtime rate. However, no police officer who actually worked and received payment for overtime on the date(s) at issue shall be entitled to additional compensation as provided for herein. Disputes regarding which officer(s) are entitled to compensation shall be adjudicated pursuant to the parties' arbitration procedures on an expedited basis.
- This Agreement represents the totality of the parties' discussions regarding its subject matter; there are no other agreements, of all or otherwise.
- 5. The parties acknowledge that they are authorized to execute this Agreement.
- This Agreement is subject to and shall become effective upon PBA ratification.

Legal Report

On September 28, 2011, the PBA held another one of its educational seminars and as usual, it was very well attended by active as well as retired members. The topics covered were the new Zadroga bill, accidental disability retirement with the main focus on what constitutes an "accident" and WTC service as it pertains to the Workers' Compensation Law. The presenters were all from the law firm of Fusco, Brandenstein and Rada, P.C.: John Hewson, Esq., Richard J. Brandenstein, Esq. and Milan Rada, Esq. It is extremely important that members be aware of their various rights and responsibilities concerning any injury or illness resulting from their service at the World Trade Center following the horrific, terrorist attacks on the Twin Towers on September 11, 2001.

The Zadroga bill essentially provides for continued funding to the World Trade Center Medical Monitoring program and re-opens the World Trade Center Victims' Compensation Fund. The fund actually opened on Monday, October 3, 2011 with applicants given a two year time period to apply. However, as of October 3, 2011, applications and eligibility forms have not yet been published, so there is not much to report on that issue. As soon as further details are available, they will be reported in the Legal Report as well as posted on the PBA website. In the meantime, if there are any pressing questions, please do not hesitate to call our office and we will do everything we can to accommodate you. Just because the fund opened October 3, 2011, you do not have to get your application in on the first day. It would be wise to begin collecting all available information on your service at the World Trade Center (where you worked, how many hours you worked, the specific duties that you performed, and making a list of all the medical treatment you have received including names, addresses and telephone numbers of all treating and consulting doctors, hospitals where you received treatment, objective test results and medications that you have taken over the course of the years; if you have already received compensation from a lawsuit, papers relating to that will be required).

For those who feel they have become permanently disabled for the performance of the full duties of a police officer as the result of their World Trade Center (WTC) service, there is the option of filing for a ¾ WTC accidental disability retirement pension, which provides a rebuttable presumption that the disability was incurred in the performance of duty and is the natural and proximate result of an accident not caused by the applicant's own willful negligence, if certain conditions are met: 1). The applicant's disability must result from a "qualifying condition or impairment of health." 2). the applicant must meet the duration requirement, i.e., must have served for the amount of time specified in the law. 3). the applicant must have successfully passed a physical examination as required by his/her employer.

Some of the "qualifying conditions or impairments of health" include: diseases of the upper respiratory tract and mucosae, including conditions such as conjunctivitis, rhinitis, sinusitis, pharyngitis, laryngitis, vocal cord disease, upper airway hyper-reactivity and trachea-bronchitis, or a combination of such conditions; diseases of the lower respiratory tract, including but not limited to bronchitis, asthma, reactive airway dysfunction syndrome, and different types of pneumonitis, such as hypersensitivity, granulomatous, or eosinophilic; disease of the gastroesophaegeal tract, including esophagitis and reflux disease, either acute or chronic, caused by exposure or aggravated by exposure; diseases of the psychological axis, including post-traumatic stress disorder, anxiety, depression, or any combination of such conditions; diseases of the skin such as contact dermatitis or burns, either acute or chronic in nature, infectious, irritant, allergic, idiopathic or non-specific reactive in nature, caused by exposure or aggravated by exposure; new onset diseases resulting from exposure as such diseases occur in the future including cancer, chronic obstructive pulmonary disease, asbestosrelated disease, heavy metal poisoning, musculoskeletal disease and chronic psychological disease.

A further requirement to be able to take advantage of the presumption provided in this law is that the applicant performed his/her service at any one of the designated locations between September 11, 2001 and September 12, 2002.

An applicant may apply at any time that (s)he becomes so sick that (s)he cannot perform the full duties of his/her position, provided that a notice form was submitted to the Retirement System on or before September 11, 2010. An applicant can apply even if already retired on service or performance of duty disability retirement.

With respect to Workers' Compensation, Richard Brandenstein, Esq. discussed the importance of treating under Workers' Compensation as opposed to your private medical insurance and of establishing with the Workers' Compensation Board all the body parts that have been injured or illnesses from which you now suffer.

As the readers of this Legal Report already know, I periodically write about Retirement System cases that are litigated mostly up to the Appellate Division, Third Department. There are times that I have made references to Appellate Division, First Department cases and to the very few New York State Court of Appeals cases that deal with Retirement System cases. Unfortunately, the Court of Appeals has not taken a look at the "incident" / accident" issue in quite some time. This most likely is not the economic climate to expect a more liberal interpretation of what constitutes an "accident," but the situation cannot become very much worse via any decision of the Court of Appeals. There have been several recent attempts to bring cases before the Court of Appeals, but these attempts were not successful. I have tried bringing one of my own cases before the Court of Appeals, but the request was denied.

This brings me to a point I want to make about the cases I discuss in the Legal Report. Recently I wrote about a Thursday, the day of the week that the Appellate Division, Third Department, handed down 11 or 12 decisions, in which the applicants were all denied. These were all Retirement System cases of one type or another. Not every case dealt

with the issue of whether an "incident" or "accident" had been suffered, but the majority of cases dealt with this issue and medical denials. Sometime after my article appeared, I received a telephone call from one of my clients, asking if all 11 or 12 denials were my cases, because if they were, this client was not so sure he was in the best of hands. I assured him that these cases were NOT my cases, but rather published cases, which I took the liberty to report on. When I am writing about one of my own cases in the Appellate Division or, hopefully in the Court of Appeals, I will always identify it as my case. I would do the same thing with a case at the initial or hearing level. I do not identify my cases by name until they reach the Appellate Division, at which point the case is a matter of public record. I suppose if one client was not clear about this issue, there might be more and I felt the need to clear this up for even the one client, if that is all there is, who might be under the misimpression that I write only about my cases.

But speaking of my cases, I want to describe the bitter battle waged to obtain a ¾ accidental disability pension, which will help to answer the question, "How long will my case take?" On average, it takes about 1 to 1 and ½ years to go from the beginning to the end of a case, in which no hearing or appeal is involved. Of course, it is not always possible to predict at the beginning of a case which will go to a hearing and which will not. So, in this case we filed the initial application on February 20, 2007. On May 8, 2007, we received a denial from the Retirement System advising us that the event causing the disability was not an "accident" within the meaning of the law.

This police officer was injured in an assault type situation when a combative and violent arrestee kicked the applicant in the knee and punched him. I sent a letter to the Retirement System pointing out the particulars of the claim and enclosing arrest documents. The Retirement System, to its credit, rescinded the original denial on June 11, 2007, acknowledg-

ing that the event of December 31, 2003 was indeed an accident. Then, on June 16, 2009, we received another denial from the Retirement System stating that the applicant was permanently disabled, but there was no causal connection between the disability and the accident. Accordingly, we now had to request a hearing and go through the appeal process. The first hearing, at which the applicant provided his medical evidence by way of testimony from the treating doctor, took place on August 12, 2010 before the Hon. Jack Mackston. The second hearing, at which the Retirement System supplied its medical evidence by way of testimony from its examining medical expert, Dr. Dermksian, took place on April 21, 2011. On September 12, 2011 we received a fully favorable decision from the Judge. From beginning to end, this case took 4 years and 7 months. That's a long haul and terribly oppressing on the applicant and his family.

As you can see, the New York State Comptroller has tremendous control in these cases, by virtue of controlling the calendar. This case could have moved quicker, and in fact, one cause of delay was our own request for an adjournment when the Retirement System wanted to take the case away from the Hon. Jack Mackston, who heard the testimony from the applicant's treating doctor and give it to another judge to hear the testimony of the Retirement System's doctor, who would not have had the opportunity to assess the credibility of the applicant's treating physician. The best I can tell anyone is that the case should take about a year to a year and ½ at the initial level. If the case goes into the hearing stage, it can take as long as this one did, over 4½ years, or even longer.

Third Precinct

Shortly after the last edition of the newsletter was printed there was a Legislative meeting on the Police Budget for 2012. This master plan was unveiled by the Acting Police Commissioner Thomas Krumpter. A major part of the Acting Commissioner's plan is to close two precincts. We are not privy to what two precincts they will close, at least not until after Election Day. These closures would result in eighty one sworn members, including Supervisors and Detectives out of work. The Acting Commissioner also stated that as of now there are no police layoffs scheduled. We are told that an analysis is ongoing as to what two precincts will be closed. To propose closing two precincts and not inform the Legislature which precincts would be affected in the words of Legislator Scannell to the Acting Commissioner "you are unprepared for a meeting that you know occurs the same time each year".

The budget meeting left many people with more questions than answers. Many said that the testimony of the Acting Commissioner was laden with anomalies and ambiguities. One of the many parts of the presentation I took exception to was a comment by the Acting Commissioner on his dismantling of units such as Enforcement, SET, Motor Carrier, Plainclothes and POP. He then stated that the Patrol Officer would have to make up for the loss of these units and concentrate on post integrity. I would like the Acting Commissioner to expand somewhat on this comment. Is he saying that the Patrol Officer has NO post integrity? I do agree that post integrity is a challenge when you run from call to call. Surely the Acting Commissioner is not that far removed from patrol where he knows that in order for an Officer to do his job safely and effectively we need all the units that were decimated to be reinstated. We also need no further cuts that are projected in his budget. In my opinion he owes this to the Officers that risk their lives every day, the public we are sworn to protect and to himself. You cannot do more with less. Unfortunately with less, you get less. Simple to understand and dangerous when it comes to public safety. All the technology in the world does not help when you need the assistance of a police officer who is no longer there. I did find one other thing somewhat curious, in the 2012 Budget, there is a \$50,000 increase in the pay for the Acting Commissioner..So much for a pay freeze.

I would like to applaud Legislator Joseph Belesi. Joe has stated in the past and once again at the Budget Meeting that he would "never layoff a cop". He is the ONLY Republican Legislator to do so. Joe is a 33year veteran of this department and he still remembers how arduous it is to be a cop.

I would like to thank everyone for attending the rally. Our professionalism and integrity made it a success. Our message was loud and clear. The unions involved called on their members and other union presidents, the response was great. The job of Police Officer is a noble and dangerous profession. We can all take solace in knowing that the PBA will never stop fighting for what is right. God bless and be safe.

MORE THIRD

On October 12th, Commissioner Krumpter laid out his budget to the County Legislators. He twisted his statistics in an attempt to make the public and the Legislators believe there are more cops on patrol now than there were in the past. It is not hard to pull the wool over the eyes of people who do not work in this department and don't really know the difference between the functions of a POP, anti crime or DWI cop, but I found it insulting that he thought this would fly in front of the large crowd of his own cops in the room. Everyone on this job knows that all of the POP, anti crime and DWI cops that he put back into patrol were cops that patrolled the streets in addition to the sector cars, so when you remove them from the roll calls, even my four year old can tell you that there are less cops on the street. He tried to portray the POP cops as cops who only go to community meetings, do office work and chase kids out of the parks. (I would hope he is not that far removed from patrol to really believe that). He likes to use the phrase "these officers were put back into patrol" in an attempt to confuse the average person into thinking those officers were not on the streets before, but are now. Let's break it down. Before the cuts, the typical Third Precinct roll call had 27 cops on the street in sector cars, in addition to that there were usually 2 pop cops, 4 anti crime cops and a dedicated DWI cop all "on patrol".(27+2+4+1= 34 cops on the roll call).....Today's typical roll call has 27 cops assigned to sector cars,1 POP cop (if he is working, no POP cops if he is on his regular day off), 2 anti crime cops and no dedicated DWI cops. (29 or 30 cops in the street at any given time). If you were following along, that is 4-5 less cops on the street for the Third Precinct now than we had

before the cuts. (4-5 cops multiplied by 8 precincts = 32-40 less cops on the street on any given day in Nassau County)...... You won't read that in Newsday...........That leads me to the next subject, Commissioner Krumpter also stated that he is starting an investigation into why summons activity is down. They are comparing monthly summons stats...... So It looks like it's time for another simple math equation.....(32-40 less cops on the street in Nassau County per day, multiplied by an average of 29 days a month equates to 928-1,160 positions on the roll calls that currently are not filled per month. If you multiplied those numbers by an average of 11 hours per position, (some 10 hour and some 12 hour tours) it would equate to 10,208-12,760 man hours. I don't think you need much of an investigation to figure out that when you take some of the biggest ticket writers (POP, anti crime, DWI cops) out of their details and reassign them to patrol where they can't possibly maintain their activity while also answering 911 calls and you deplete the roll calls by 10,208-12,760 man hours per month, you are going to have decreased summons activity.

Moving right along to claim number three, where the commissioner stated to the legislators that DWI's in Nassau county are down......just because we have less DWI arrests, does not mean that less DWI's exist, it only means that there are less dedicated DWI enforcement officers therefore less arrests are being made. (When other types of crimes get reported, whether they are solved or not, it is still counted as a crime when it comes to keeping statistics) When a DWI driver does not get caught, nobody knows it, so how can you gauge the number of intoxicated drivers on the roads when you change the equation and decrease the amount of officers enforcing that specific crime.

Last but not least, closing two police precincts, I'm having a hard time believing that our police commissioner would propose something as drastic as closing two of his own police precincts. The commissioner was at the PBA office for a little Q and A with the executive board, trustees and delegates about a month ago and the subject of moral came up, the commissioner said that if anyone had any ideas of how to raise moral to let him know. I can certainly tell you that proposing to close two precincts isn't the best route to take to increase moral.

In closing, I completely disagree with the direction the commissioner is taking this department but, it was nice to hear him and a majority of the legislators applaud the work of the men and women in this department, I just wish they would realize that it is their responsibility to provide us with the proper staffing levels and tools to do our job.

TOP COPS – JUNE PO JASON WRIESKE PO THOMAS MAHER PO THOMAS EQUINDA

On Friday June 10, 2011 at approximately 2225 hours, plain-clothes Police Officers Maher, Equinda and Wrieske

were on patrol in Westbury when the officers observed a parked vehicle with it's interior dome light on. As the officers approached the vehicle they observed one subject in the driver's seat and another in the front passenger seat. The subjects stated that they were waiting for a female friend to meet them at that location but did not know what her name was. At that point a female was seen exiting a house in the vicinity where the car was parked, upon seeing the officers she ran back into the house. The officer's then observed one subject shoving a plastic bag into his front waistband area. They also observed ten blue bags each containing a tan powder, believed to be heroin, wrapped together with a rubber band on the driver's side front floor of the vehicle. Neither defendant claimed ownership of the alleged heroin. At this time both defendant were asked to exit the vehicle. Officer Maher placed one of the subjects into custody. Officer Wrieske informed the other subject that he was under arrest and instructed him to place his hands behind his back in order to be handcuffed. The subject threw a clear plastic bag containing sixteen blue envelopes each containing a tan powder believed to be heroin to the ground. The subject refused to place his hands behind his back and flailed his arms above his shoulders so as to prevent his arrest. Officer Wrieske struggled to place the subject into custody and during the struggle, both parties fell to the ground causing Officer Wrieske to break his right hand. PO Equinda assisted PO Wrieske in placing the subject into custody. The subjects were transported to the Third Precinct for arrest processing and Officer Wrieske was transported to The Nassau University Medical Center for treatment of his injury. The defendants were charged with Criminal possession of a controlled substance in the third degree, Assault 2nd and Tampering with Physical evidence.

RALLY AGAINST MANGANO'S FISCAL REFORM ACT

The PBA teamed up with other county and state unions at a rally against Ed Mangano's Fiscal Reform Act in front of the County Executives Building on October 17. It was estimated that approximately 3,000 people attended to listen to leaders stand up for their unions and members. Attendance by the membership of the Nassau County PBA was excellent and it showed the County that we are unified during this County's fiscal crisis. Mangano thinks that the PBA members like him and that our membership lacks solidarity. Based on the attendance at the Rally, especially from our members, he should now realize that we are strong and together as one and we are willing to fight his every move. The battle continues. Let's remain together and stay positive

THE POLICE BUDGET – RISKING PUBLIC SAFETY AND SERVICE FOR COST SAVINGS

On October 12, Commissioner Krumpter was given his marching papers from Ed Mangano to address the Legislators and reveal the Police Budget for 2012. This budget included the controversial proposal to close two precincts. The Commissioner stated by closing two precincts that there would be a savings of over \$15 million. Though he noted that the 1st precinct and the 3rd precinct would remain open, the Commissioner would not state the two precincts that would close until a "study/analysis of the numbers was conducted." Based on this "study/analysis", he or Mangano would then reveal the two precincts that would close. According to the Commissioner, this decision, ironically, would be available after Election Day. This is a slick move by Mangano and his office to try and bypass the election in order to protect his political party and leave the residents of Nassau in the dark. Don't the residents have the right to know which precincts they plan on closing before the election? Should the residents know prior to an election if their current local legislators or opponent would be in favor or opposed to it? Peter Schmitt, in his usual gruff and obnoxious way, stated that it doesn't matter which precinct would close. I am sure if they planned on closing the 7th Pct, he would be opposed to it. We have all read or watched the news reports in regards to this budget hearing, but as usual, a lot of important comments and answers from the day were left out. Below are some highlights from the day that you should be aware of:

Several legislators asked the Commissioner if he would layoff police officers. Everyone expected a simple yes or no answer. Instead he referred to the fact that on average 100 NCPD officers retire each year and based on that number, he did not foresee layoffs in his (really Mangano's) plan. The Commissioner has watched Mangano and now has implemented Ed's art of dancing around tough questions. Why answer quickly and decisively when you can answer by rephrasing the question or just talk for as long as possible so the listener becomes bored and distracted?

Legislators asked if there is a "Plan B," if his proposal for closing precincts was rejected. Once again, it was a simple yes or no answer. At this point, there was complete silence for a period of time. Once the legislators realized that he did not have a "Plan B", they then directly asked him again would he lay off police officers. A simple yes or no answer would have sufficed. His reply was "no one wants to lay off people and that is something that we would address at that time." In other words, the Commissioner is probably not for layoffs but since Mangano makes the decisions, it is still a possibility. Once again, we lack leadership. Do not rely on someone who came up through the ranks in this department with an understanding of the job, and is expected to lead, not follow, to stick up for you. You have to ask the following question to Commissioner Krumpter: "Do you really want to be remembered as the guy who laid people off, dismantled the department and killed the job that provided so much for you and your family? Or, do you want to be the man who stood up and said NO, this is not right!" Just so you know, a simple answer of NO to layoffs would have gone a long way with the members of this department.

The Commissioner was also asked several times about dedicated positions such as the Heroin Task force, DWI patrols, Anti Crime and the POP units, to name a few. Many residents and legislators agree that by not having these units the county's safety has and continues to be compromised. In regards to heroin, he was asked how many people were in the Heroin Task Force. The Commissioner kept on referring to the total number of cops in Narcotics/Vice Squad. According to that statement, I guess we should only be concerned when you die from heroin. Since Mangano loves press releases they should notify all the residents not to worry about the thousands of heroin users and numerous drug dealers that are still in Nassau County because the medical examiner has not received their corpses yet.

He had a year to prepare this budget. In that year, this was the best answer/finding he could come up with? Closing two precincts was the best scenario? It took a year to color code a map, draw perfect circles and then refuse to let you know which precinct(s) will close? What is the County Executive and Commissioner's contingency plan if the legislators do not pass the Police Budget? Ed Mangano continues to fudge the budget numbers, lie to the public and now recently he is ready to rewrite the United States Constitution. It doesn't get anymore Un-American than Ed Mangano. Ed's lack of respect for the workers of Nassau County has been well documented, but maybe you should also know that while you are out serving the public he is wasting millions of dollars while helping out his friends and family. Did you know that Ed Mangano hired a convicted felon to the Director of Minority Affairs for

\$90k per year? Did you know that Mangano hired Al D'Amato's daughter to be the Senior Citizens Commissioner for over \$80k per year and just recently promoted her to a new county position for over \$105k per year? Why wouldn't Ed Mangano award million dollar contracts to his former law firm employer, Rivkin Radler? Also, it makes sense that during a fiscal crisis that Mangano has a car show, is building turf fields and renovating a pool while threatening layoffs. The Sixth Precinct Top Cop Committee has selected Police Officer James Pettenato as our "Top Cop" for July 2011 because of his actions on July 10, 2011. At 2124 hrs Officer Pettenato while on Directed Patrol for drug activity in Manhasset, did observe two suspects do a hand to hand exchange. Officer Pettenato approached the suspects on foot and observed one of them discard something which was later determined to be marijuana, onto the ground and walk away. Both suspects ran in opposite directions and a foot pursuit began. Officer Pettenato while pursuing one subject gave out a notification. The pursuit lasted several minutes and the subjects were apprehended with the assistance of Officers DeMeo and Farrell. While conducting a patdown search for Officer Safety and determining the subject's identity one of the subject's wallets was found to contain a New York State Driver license and a New York State Bar Association I.D, not belonging to the subjects. Also found in one of the subjects backpacks were several credit cards not belonging to the subjects. These items were reported stolen from a vehicle earlier that day. Officer Kelly canvassed stepping Stone Park in Kings Point and determined that the suspect, an ex maid, hired a taxi after

being denied access to the park and left the area. Officer Kelly was able to make contact with the proper taxi company and was advised that the woman and baby were transported to the Roslyn Railroad station in Roslyn Heights. Officer Kelly requested through CB that a unit respond to the Railroad station and check for the woman and baby. Officer Ferrer then responded to the Roslyn Railroad station where he located the suspect and baby. The suspect stated to officer Ferrer "This is my baby" and that she was coming from Great Neck. Officer Kelly arrived at scene and after a brief investigation determined that this was in fact the subject and baby that they were looking for. The subject was advised that she had to give the baby to the Officers. The subject refused to give the baby to the Officers and after several verbal commands to do so she continued to refuse. The subject, while holding the baby in one arm began flailing her arms pushing and shoving Officer Kelly and Officer Ferrer and yelling "You aren't taking my baby. This is my baby!" At this time, fearing for the baby's safety, Officer Ferrer did grab hold of the baby. The subject then became even more combative and continued to flail her arms and did physically obstruct the Officers from taking the baby. The subject was advised that she was under arrest and she continued to violently resist. Officer Lawrence who had arrived at scene was able to take hold of the baby while Officers Ferrer and Kelly took the subject into custody. It is because of their quick thinking, keen investigations skills and rapid response that Officers Kelly and Ferrer are our "Top Cops" for August 2011.

After the unions gave up concessions in the last contracts and contributed to his saving money by eliminating different jobs, he now proposes to take away benefits from county employees and lay off many of them. What a laugh! All of our retired members are backing the PBA in their fight with the county and will support our active PBA members.
