In Remembrance

Please bear with me as I try to write this article. On October 18, 2012 Police Officer Joseph P. Olivieri Jr., made the Supreme Sacrifice in the performance of his duty. I did not know Joe all that well. I saw him around the building but we were usually passing each other. His passing is tragic. Despite what some are saying in the newspapers, in my humble opinion an alleged drunk driver caused Joe's death. We know it and the subject's lawyer knows it. If the subject was not allegedly under the influence of some type of intoxicant then the accident probably doesn't happen. Now, as I said, I didn't know Joe. But, after hearing all the wonderful things that were said about him, I wish we had more than a professional relationship. May he rest in peace.

On January 29, 2010 Police Officers Arthur Lopez and Keith Blum were assigned to ESU. Throughout their training it would be an understatement to say they were both enthusiastic and quick learners. They genuinely enjoyed training and the joking. Artie proved particularly adept at the joking around and the sarcasm. He was quickly loved by all. When he was assigned to Field Training I had him for a number of tours. He was funny, personable, knowledgeable, willing to learn. We shared some wonderful moments. I also met his parents at this time. They were just two beautiful people who obviously loved their son. Artie soon went to work night tours. Unfortunately, an injury to one of our day tour members necessitated the need for a replacement. Artie came to day tours. I was lucky enough to work with him steadily two tours out of every five.

We had many laughs. We also had some things in common. Working out, protein shakes (at 5pm. And numerous times at 10-10:30am) One day trying to teach him how to ride a motorcycle was almost priceless. Whatever the situation was, he would greet it with that infectious smile of his.

Trying to describe Artie is extremely unusual. Every adjective you can think would probably be used. Knowledgeable, personable, playful, industrious, if you can think of anything positive to say about a human being you can use those words to describe Arthur Lopez.

On the morning of October 23rd, 2012 Police Officer Arthur Lopez made the supreme sacrifice in the performance of his duty. For some who may not know, I had the honor of working with him that day. Without getting into specifics, he was a true hero that day. Please know that I do not use that word lightly. Artie responded to the threat he faced that day as only the rest of us could hope to respond. Sadly, he was mortally wounded. To use any of a myriad of adjectives to describe his assailant would be conferring some type of human quality to this individual. The only acknowledgement I would like to make of the subject would be in a legal setting.

I would like to thank a few people and groups. First of

all Commissioner Thomas Dale. He has been as stand up a human being as you will find on the face of this planet. He could not have taken this job even thinking that four Officers would perish in the line of duty. There have been a couple of other incidents. Let's put politics aside. This is just one person's opinion. He has been as good a Commissioner, as well as a person, throughout this entire ordeal that I could ever hope to find.

There is one other individual I would like to thank. Chief of Patrol Frank Kirby. I have worked under him in the Third Precinct and in ESU. Words alone cannot adequately explain how I feel. I will say that it is a privilege to be a subordinate and work for these two men. I will be forever grateful for their support.

Speaking of support: the outpouring of support and encouragement from the members of this department and the executive staff has been almost overwhelming. It is indescribable. It makes me so proud to be a member of a police department like this. Truly, they do take care of their own. Nobody can ever say a bad word about this Police Department to me. Not ever.

A couple more thank yous and I will stop boring you. Artie's family has been very supportive of both me and the NCPD throughout this difficult time. With all that they have had to deal with, they have taken the time to express their support and love. I would like to publicly say thank you. To the NYPD ESU and the other units within the NYPD that busted their collective butts to see this individual captured I say thank you and a job well done. Especially, to the two plainclothes guys from the 105 Pct. You know who you are. They acted in the finest tradition of the NYPD and they are fully deserving of being acknowledged.

Let us also thank the Merrick Fire Department. They opened their doors and their hearts to the NCPD and Artie's family. To say they bent over backwards is to understate their hospitality. During the motorcade from the church to the cemetery there were (I believe) 21 arches to honor Artie. The Merrick F.D. was responsible for this honor. It is not an easy task. Also, during this motorcade the outpouring of support from the public was massive. There were people pulled over to the side of the road that were saluting. There were grownups and children with handmade signs honoring and thanking Artie for his service and sacrifice. The public reaction was tremendous.

I would like everyone reading this to keep someone else in mind as well as Artie. Raymond Facey. This was a gentleman doing the right thing who ended up getting killed for his efforts. How many times have we been going to calls and someone is in front of us not moving because they are on the phone. Mr. Facey had pulled over to the side of the road to use his cell phone and pays the ultimate price for his efforts. He also leaves behind a devastated family. Please, if you can, take a moment to remember his sacrifice. I would also like to thank my former partner. She could not have been more helpful or supportive during this time. No matter how far she rises up in this department she is a true friend. Thank you. If I have left someone or something out

I will address it in a future article. Obviously, there are certain things that I cannot discuss publicly. If and when the time is right the discussion will happen. If, in the push to get this article out I have forgotten to thank someone, I will remedy that.

One final thought to my fellow members of ESU: to say this has been a painful ordeal for all of us is obviously an understatement. But, you have all taken the time to look out for me as well as each other. Your support has been invaluable. It will never be forgotten. It cannot be expressed adequately with words. (For which you are all grateful I am sure) Starting with the senior guys, the supervisors, and everyone else (especially those who live near Jamesport) I thank you from the bottom of my heart. Hopefully we can move forward with a renewed sense of purpose. I also hope these thoughts and words are weaved together in a coherent fashion. We love you Artie.

So as the dust settles and we all come to grips with the tragic and senseless loss of our friend, son, brother and a top shelf cop who always stepped up to do the right thing in all he did. I think back to the many nights I worked along side this great cop in our ESU rescue truck looking to help the cops and citizens on the streets on Nassau County. Artie always wanted to be the first in on any assignment. His work ethic was second to none. I was lucky enough to be one of Artie's field training officers in his assignment to ESU. Right away I found a young cop eager to learn and to get involved in every aspect of what we do as ESU cops. As ESU cops we are charged with and undertake many diverse and difficult jobs. Artie never shied away from any of those task, in fact he stepped up and took on any and all challenges that were asked of him. The respect he showed for everyone, especially the senior members of our unit was his trademark and the staple of a truly fine young man who was clearly raised by parents of high standards and great morals.

We are a very small unit of 30 members which includes bosses. We have all suffered an incredible loss. But I know full well that the loss suffered by his family and closest friends is something that cannot be measured. My thoughts and prayers are with you all. As I stood in the hospital with my fellow ESU officers surrounding Artie and paying him his much due respect, I was moved by each and every 1st pct. officer who entered that room and said their goodbyes to this fallen hero. The pain they were all in was evident in their faces. Artie loved his 1st pct family and spoke of them daily. You see, it was a statement of who Artie was, you could not know him without loving him.

My memories of Artie will always bring a smile to my face. Artie and I shared many laughs about the many obstacles he and I faced in an effort to maintain our perfectly spiked hair. We often joked about the tactical gel we needed to carry at all times in order to fix our spikes after a long tac job wearing a tactical helmet for hours. Our biggest fear was having to don an SCBA mask for a HazMat. We both knew

the fall out of our hair was going to be huge. He in fact just gave me a tip on some new hair products for that always great looking perfect spike and flip, Thanks Pal. I also remember one of our first pin jobs together, he was my trainee and we responded to Hempstead for a serious auto accident with a car into a building. I remember looking over at Artie in the passenger seat with his ever present smile and already putting on his gloves before we were even close to the scene. We arrived and Artie jumped out and into action. He had our extrication equipment off the truck and in operation before I even made it over to his side of the truck. The victim was out of the car but I decided it was Artie's time to show me what he had. I turned him loose on that mangled wreck of a car and Artie removed the doors and side of that car within minutes. He far exceeded my expectations with his skill and drive. You could not wipe the smile off his face after that job. He was so excited and pumped up by all of it.

I will miss Artie's love and passion for the job. I will miss his ever present smile and laugh. I will miss the ease in which Artie could laugh at himself as hard as he laughed along with others at a good joke. We loss someone truly special that horrible day when that coward took Artie from all of us. I was at the scene that day and can't even explain the anguish and tremendous loss we were feeling. I was on the Cross Island Pkwy going to see my daughter in RI when the traffic came to a dead stop. My phone rang and it was Marcus Negron our operations officer. He told me about the bad scene that was unfolding at the Cross Island Pkwy and Hempstead Tpke. He said to me that Artie was hurt badly. I looked up and realized I was under the sign for the Hempstead tpke exit ahead. I left my car and ran to the scene to see if I could help.

I remained at that scene with Sgt Papa and we tried to come to terms with what had just unfolded. As that day wore on, I came to realize that you never really come to terms with the loss of such a great young man who was so full of life. You instead cope with the loss and try to remember and pay respect to that great young man. So, as we prepare to say our final goodbye to yet another brave police officer. I will choose to remember Artie as I am sure he would love us to all remember him, A brave young cop with an incredible amount of passion and boundless energy for doing a job he loved. A man who always put his family, friends and partner before himself. I will remember Artie with his ever present smile and laugh. I hope you will all do the same.

Artie I will keep the tactical gel on standby pal until we meet again. R.I.P. brother. Taken from us to soon and too young.

The above was written by me and posted on face book 2 days after Artie was taken from us. As the days have passed and we were all consumed by Hurricane Sandy and the endless challenges we all had to meet as police officers in those very intense days and nights. It occurred to me that the challenges of this storm and the dangers we all faced in doing our jobs throughout that storm were right in Artie's wheel house. He would have loved every minute of being out there and helping the cops and residents of Nassau County. He would have had that trade mark smile from ear to ear as we jumped

from one call to the next. So, I guess we can clearly see that Artie will never stray from our thoughts. He has left a lasting mark on the members of ESU and this dept. that cannot be taken away by the cowardly act of a cold blooded killer. I have unfortunately been on scene for 3 of the last 4 members that have died in the line of duty. Each time I found myself asking why did this happen. I still do not have the answer to that question but I do know one thing for sure. While these men died doing their jobs and as hero's in the face of danger. These men were not just hero's because of the heroic actions they undertook on those fateful days that they made the ultimate sacrifice. They were hero's because of the way in which they lived their lives each and everyday while they were still here with us. Any doubts, just listen to the countless stories that go with each of these fallen hero's.

I was also honored to be a part of the procession for Artie's final farewell. His closest friends from the infamous 1st pct. Sqd 14 posse and his side kick Keith Blum included me in the tribute that we paid to Artie at the Merrick Firehouse. I was both touched, moved and grateful to be a part of that final salute. The crew from Sqd 14 in the 1st pct are a truly remarkable group of young cops. I know that we cannot comprehend this tragic and senseless loss. Unfortunately, we as cops like to make sense of things and have answers to every question. We in fact pride ourselves on being the guys and gals who know. But in this case I think we just have to cope and keep moving forward which is what I am sure Artie would have wanted us to all do. I do know one thing for sure in all I have heard over the last few weeks and in the time I have known Artie, he was a young guy who in his 29 years lived more than most folks that have been on this earth for 80 years. So, I will close this out by simply saying what Artie said to all of us in the unit on a daily basis, "I'm just happy to be here" which he clearly was. Artie also loved to say, "I totally get that" and as I look back now, I realize he really did. R.I.P. Artie. Forever an E-Man.

We were young, neither of us a cop before, Leone/Lopez sitting next to each other in the Police Academy where our destiny began. We had a rough relationship there you and I not always seeing eye to eye, but we made it through and by God's plan were assigned to the First Pct.

We learned how to do our job from the city guys around us and we did it well. Most importantly we grew into friends and eventually brothers. Work was work, but life was more important. We all tried to do as much as we could together outside of work, which gave us this incredi-

We had it good at work, we knew whoever had a heavy call or an investigation going on that the other was coming...NO MATTER WHAT.....I never had to wait or ask for assistance, I never had to wait for you and you knew you had the same for me. We had something special, our squad was the best. You empowered me to be better than good enough. The years went by and it came time for you to fulfill your desire to move on to bigger and better things than patrol when you were chosen for ESU. I remember you had your own self issues with going, you didn't want to leave the boys, you didn't want to leave Greg. You asked me what did I think and I told you that if it's what you want you should do it, and I knew it was what you wanted. I told you I would take care of Greg and I filled your seat...That's you buddy always worried more about us than yourself. That was work and there is just too much to say about that but there is something more important.

You were at my wedding, the actual church and sat there with Hogie despite that Diana was 45 minutes late. That was one of the days that I realized that you would stand by me no matter what, thick or thin, day and night. You've seen the best of me and the worst of me, you've laughed with me (mostly at me), and you cried with me. And when I cried you always patted me on the back and told me that you loved me. You never let me hang my head, I wear my heart on my sleeve but you always made me keep my head up. We had the circle and you stuck by it. When times were tough at home you left the door open for me, made up the couch with blankets and a pillow and never asked any questions. You are a great friend, a best friend. We went out and made moves from time to time and we had a blast. At Christmas time you would knock on my door late at night unannounced and would hand Diana and me a present, when I asked what it was for you would just say....."you do so much for me, you're great friends." You always asked my advice on things, we would discuss things and I guess I realize it now, how much you valued my opinion. When you bought the boat, I took you out and showed you the ropes, but you were a natural. I could go on and on we have 8 years of memories and we made new ones everyday. This newsletter is not long enough to say everything.

You always told me that you would take a bullet for me, and I said the same to you. I feel like I let you down...I was supposed to protect you. It was the oath we took as blue brothers, it was the pact we made as friends. I'm sorry I wasn't there to live up to my end of the bargain, I would of if I could. It took awhile but you finally got me, understood me, most people don't, and I am forever grateful for that.

We're doing our best to take care of mom and pop and that is one thing you don't have to worry about. We had plans buddy, we were supposed to see this life of the badge to retirement and beyond. I'd give it all back to see you again, to hear your voice again. I'll take it from here look out for me, look out for all of us.....our time will come when we can rejoice together in the Kingdom of Heaven, until then don't worry you will always be one of the boys. I got your back cause I know you always got mine.

The morning after Artie Lopez was murdered I went for an early morning walk. I was still reeling from standing in formation at Joe Oliveri's funeral the day before with an ache in my heart for his family and friends.

When I got the phone call about Artie, I got numb. I responded to the hospital and we all did what we could do to help ease the pain of family and friends. The outpouring of support from Artie's peers was unbelievable. The Dept. and peer support did a great job.

But the next day, when I took this walk, I was alone. And I'm sure most of us had a moment by ourselves to reflect. And during this walk my mind was working incredibly hard to put in order what happened. First of all there was every emotion present, anger, confusion, sorrow and depression. And they kept pushing their way to the front of my mind to be the dominant emotion.

We were all brought up, trained that things happen in order, first comes A then B, then C. But sometimes things get really screwed up. And this is one of those few times and there's no mathematical formula to fix this. Yes I'm angry at the DWI that caused Joe's death and yes I'm really angry at the animal who cold bloodily killed Artie. I'm confused as to why it had to happen to these particular men. I feel such sorrow for the families, friends and co-workers who have to deal with this. And it's when I'm alone that sadness starts to creep in.

This is the point of my article...Every one of us will experience some form of these emotions at different intensities at different stages during this grieving period. It's normal, it's human and it needs to be addressed.

I'm not saying everyone should go to EAO but what I am saying is it can't be kept inside. We all have friends, co-workers and families who feel the same pain even though they're not even on our job. How many wives and kids of our cops are thinking right now, this could happen to me? Everyone needs to be consoled, to have the chance to verbalize their feelings and allow them to give and receive the support needed to get all of us through this. Everyday we go to work we rely on our partners to watch our backs. This is no different.

I'd like to thank the PBA for all of the support which was given Joe and Artie's families, friends and co-workers. Thanks to the Dept and all the units involved making sure the families were cared for with professionalism and respect. And thanks to every outside agency that assisted with the capture of Artie's killer and his associates.

President's Message

Since the October Newsletter this job has gone through a rough time with the passing of two of our own in the Line of Duty. On October 21, 2012 I received a call at 5:13 in the morning that no one wants to receive with the news that Police Officer Joseph Olivieri, age 43, of Highway was struck by a car on the LIE and was in serious condition. A short time later Joe passed away from the injuries sustained by the accident. Joe left behind two children, Amanda and Daniel, his parents, two brothers, nieces and nephews. He also left behind many friends who knew him as a go-to guy who would help anyone and was always the first on the scene to assist. Joe loved being a police officer, especially a Highway officer after serving in Highway with the NYPD. His enthusiasm for the job showed every day he came to work and after nearly 20 years as a police officer he never slowed down. Joe is the 33rd Police Officer in Nassau to make the ultimate sacrifice and the 4th since Mike Califano was killed last February 5, 2011 followed by Geoffrey Breitkopf on March 12, 2011 and Charlie Cole of Highway who passed away on August 14, 2011 from cancer that was linked to his response on 9/11.

On October 23rd, less than 24 hours after Joe was laid to rest, we suffered another Line of Duty death. Just 5 days after losing Joe in the Line of Duty. Police Officer Arthur Lopez, age 29, was shot and killed by a subject during a car stop, after he was observed driving a vehicle that had apparently left the scene of an auto accident. Artie became the 34th Police Officer to make the ultimate sacrifice in Nassau County. Artie was just days short of his 30th birthday (November 1st) and was just starting to live his life. He was a highly decorated police officer who loved this job and loved to help others. He was a building block for the future of this job having been transferred to ESU after working in the 1st. He leaves behind his parents, Mirella and Alphonse and a sister, and many other relatives who cared so much for him.

The one thing, besides being police officers and loving this job, that they had in common was a very supportive family. Speaking with the parents of Joe and Artie during these tragic times you could tell why they were both as good as they were. They came from good hard-working families who taught them respect and in return they both turned into hard working respectful cops who were loved by many and will be missed by all.

Legal Report

On September 27, 2012, the Appellate Division, Third Department, decided the case of a firefighter who applied for accidental disability retirement benefits involving the issue of whether a line of duty injury resulted from an "accident." In the matter of "incident" vs. "accident" the rules for firefighters and police officers are the same. The case is *Matter of Carrella v. DiNapoli*. Our law firm did not represent Firefighter Carrella, but the case is instructive in pointing out what is required for a line of duty event to be considered an "accident."

During the course of his employment as a firefighter, Carrella was dispatched to assist a man who had collapsed in his bathroom. While tending to the victim, Carrella apparently slipped on urine on the bathroom floor, which caused the victim's body to fall on Carrella's right leg, causing injury to Carrella's knee. Carrella's application for accidental dis-

ability retirement benefits was denied on the initial level on the basis that the incident did not constitute an "accident" within the meaning of Retirement and Social Security Law section 363. Thereafter, Carrella requested a hearing and redetermination of the decision finding no "accident." Following a hearing before a Judicial Hearing Officer appointed by and employed by the Retirement System, the Judicial Hearing Officer denied the application on the same ground, that is, that an "accident" had not occurred. The Comptroller accepted the decision of the Judicial Hearing Officer. Carrella then appealed the unfavorable decision pursuant to Article 78 of the Civil Practice Law and Rules, resulting in the Appellate Division's decision.

The rationale of the Appellate Division was as follows. In his testimony, Carrella acknowledged that by assisting the victim he was performing his ordinary duties as a firefighter. The Court reasoned that "[A]n injury which occurs without an unexpected event as the result of activity undertaken in the performance of ordinary employment duties, considered in view of the particular employment in question, is not an accidental injury" within the meaning of Retirement and Social Security Law Section 363. For a firefighter to encounter a wet surface while assisting a victim who has collapsed on a bathroom floor is not an unexpected event, even if Carrella was unaware of the particular liquid that caused him to slip. "Accordingly," the Court found, "substantial evidence supports the [Comptroller's] determination that [Carrella's] injury resulted from a risk inherent in the performance of his ordinary duties." Carrella's appeal to the Appellate Division was denied.

So, if a police officer answers a call for an aided case in a bathroom, be aware that a slip and fall on a "liquid" in the bathroom, will most likely result in a denial of an accidental disability retirement (¾) pension, but will be the basis for a performance of duty disability (½) pension. In either case, whether ¾ or ½, the injured police officer will have a claim for Workers' Compensation benefits, which pays \$792.07 per week for all accidents occurring after July 1, 2012. Remember that just as the disability pensions are tax free, so is the Workers' Compensation payment. In the case of a ¾ disability pension, any Workers' Compensation payment offsets the ¾ accidental disability benefit. In the event that the Workers' Compensation payment is suspended or paid for only a specified, limited time, the Retirement System picks up that portion so that the injured police officer always gets 75% of final average salary from the Retirement System. In the case of a performance of duty disability pension, the Workers' Compensation benefit is paid in addition to the performance of duty disability benefit. However, Workers' Compensation payments now only last for a certain number of years as determined by a Workers' Compensation judge and is no longer a lifetime payment.

TRAGEDY STRIKES AGAIN

On October 18th we lost another of our own. Police officer Joseph Olivieri was killed when he was struck by a car while performing his duties. As I submit this article, the details of the incident are still being investigated, but whatever the outcome, we have still lost a family member and the pain is still the same. Please keep Officer Olivieri and his family in your thoughts and prayers.

TICKET WRITING SLOW-DOWN

Am I the only one who was reading the Newsday article on September 24th, wondering which side Deputy Commissioner Krumpster is on. First of all, I think the information he gives Newsday is more opinion than fact, but even if any part of this is true, a good leader would address the problem within the Department and not fuel the already low opinion of the NCPD that people outside this department have of us lately, by having it aired to the public. It seems as if our County Executive, Commissioner and Deputy Commissioners attempt to degrade us and create a negative image of this department every opportunity they get.

These are not the guys who we would expect to be taking pot shots at us, for crying out loud, these are the people that are supposed to be on our side, the people that we should be looking to for a little stability and positive reinforcement.

How disheartening would it have been if General Petraeus and the President of the United States had bad mouthed the troops in Afghanistan during the war, is this any different?

Without dissecting the entire article, there are a couple of statements from the article that stand out.

1) Commissioner Krumpster states "a failure to issue tickets puts people at risk, but notes that the County's traffic fatalities were down 16 percent in 2011 compared to 2010 and it's unclear what caused the drop".

Question: So the Commissioner can't explain why the

roads are safer, but he can explain how we are putting people at risk. I'm a little confused, the roads are safer, but over the past year, we have made them more unsafe? I say, that they are the ones who are putting the public and the cops at risk with their off the cuff decision making.

2) Commissioner Krumpster stated that the decrease in tickets has nothing to do with the number of Police on patrol

Discussion: There are not as many cops on the street as there were in the past. They like to say that there are the same amount of cops on the street now, as before. This is very deceptive, especially to the public, who don't know any better. If you define cops on the street as cops only assigned to post cars in all eight precincts, they are right. But we all know that in addition to the sector guys there were allot more cops on the street at any given time than there is now, when you count the BSO cops, dedicated DWI cops, POP cops, motorcycle cops, narcotics cops, mall detail cops, precinct plain clothes cops and Motor Carrier cops. They have eliminated some of these units and slashed others to the bone. These units were responsible for a very large number of tickets.

In addition to the reduced amount of cops on the street, there are a number of other reasons to explain why numbers are down. Morale sucks, we have been put through the ringer by NIFA, the County Executive, the Legislators, Newsday, the public and our own leadership for the past year and a half and being accused of purposely not writing tickets and having it on the front page of Newsday certainly doesn't help the situation.

I'm in my 20th year as a cop in the Third Precinct and in my entire time here, the number of patrol cops has not changed. What has changed is the call volume, it is way up. The length of time we stay out on a call has lengthened, due to the amount of time it takes to get through to the Station House and Data Processing. They have built three huge housing developments, (The Archstone, Meadowbrooke Pointe and The Avalon), increasing the population in the area by thousands of people. They have constructed two new malls in addition to Roosevelt Field, (The Source and The Gallery at Westbury Plaza) causing the influx of nonresidents to increase dramatically. We don't even have RMS yet, which will cripple this precinct, and Commissioner Krumpster says that the number of cops on patrol have nothing to do with the decrease in ticket numbers.

Patrol staffing has not changed with the times. When we were adequately staffed, we handled less calls and had time to address quality of life issues on our post throughout the tour which included writing tickets. Currently, most of your time is spent going from one assignment to another without any time in between. I'm sure they don't want us to stop and write tickets when you observe a violation on your way to a cardiac, disturbance or an auto accident.

As a Union Delegate, neither I nor any of my Union colleagues has ever advocated for a ticket slow down. The truth is that we have been trying to do more with less for far too long.

WIDOWS AND ORPHANS FISHING TRIP

Brian Engelhardt and Mike Covais organized the second annual Widows and Orphans fishing trip and barbecue out of Captree, on September 9th. The weather was beautiful and the boat had a good crowd. With the help and Generosity of Brian Hogan from A1 Grand Auto Body who paid for the boat and raffle prizes, the event raised \$ 11,000 for the cause.

TOP COPS - MAY 2012 P.O. TIMOTHY METZGER

Between Tuesday May 8, 2012 and Wednesday May 10, 2012 two subjects made a series of telephone calls to 911, stating that there were several persons with guns in and around the area of the Mineola Railroad Station. After the last call, which was made on Thursday May 10, 2012, Police Officer Timothy Metzger in RMP 311, acting on information that the cellular tower was in the area of Old Country Road, and armed with the knowledge that a couple he had taken a domestic incident report from, approximately one week prior, coincided with the spate of 911 calls, began a canvass of the area and came upon the defendants. When asked, the co-defendant stated that he was both homeless, and was at social services earlier that day. Knowing that there had been a similar calls made to 911 for a complainant stating that there was an individual with a weapon outside Social Services. Officer Metzger requested that 911 call-back the listed cellular phone number from that earlier assignment; a cellular phone secreted in the bra of the co-defendant began to ring. Both defendants were transported to the third squad, where each gave statements of admission as to their actions in these incidents.

Police Officer Metzger's thorough knowledge of his post and keen observations resulted in the arrest of two defendants who were charged with three counts of Falsely Reporting of an Incident.

TOP COPS - JUNE 2012 P.O. MICHAEL VERGANO P.O. ALAN OTTO

On June 07, 2012 at approximately 1256 hours, a 911 call for a suspicious person was dispatched to a residence in Garden City Park. While canvassing the area Police Officer Joseph Choo observed an alarm ringing at that location, Officer Choo searched the perimeter of the home and found an open rear door and window. At the time Officers Otto and Vergano were also canvassing the area for the suspicious person. They entered the Waldbaum's food store to search

inside. The Officers were informed by the manager that a male fitting the description had come in, cashed out some coins and went into the rear bathroom with a black bag. Arresting Officer's Otto and Vergano located the defendant, who gave consent to look inside the bag that he was carrying. The Officers observed what appeared to be proceeds from a burglary. The defendant was escorted outside. Witnesses were transported to the parking lot and a show-up was performed with positive results.

The defendant was charged with numerous Third Precinct burglaries. A computer check also revealed that the defendant had an open Arrest Warrant for Violation of Parole.

TOP COPS - JULY 2012 P.O. CHARLES JAVOROWSKY P.O. HECTOR BOURREN P.O. JASON WRIESKE

On July 27 at 1756hrs Officers Charles Javorowsky, Hector Bourren and Jason Wrieske responded to a call for a fight with a knife which was then updated by radio to a person with a gun and a report of shots being fired. The Officers determined that a robbery had taken place and the subjects were hiding in a residence in New Cassel. As the Officers were establishing a perimeter, Officer Javorowsky observed two subjects run from the rear of the location. Officer Javorowsky engaged in a foot pursuit of the two subjects. After running through numerous yards and jumping numerous fences Officer Javorowsky lost site of the subjects. At that point Officer Javorowsky met up with Officers Wrieske and Bourren and again the three Officers canvassed the area where Officer Javorowsky lost sight of them. The subjects were observed jumping a fence, Officers Wrieske, Bourren, and Javorowsky engaged in a foot pursuit of the two subjects. Officer Bourren and Javorowsky were able to apprehend one subject and placed him into custody. Officer Wrieske apprehended the second subject in the rear yard of the same location.

The defendants were each charged with armed Robbery.

Officer John Fallace was honored at the annual DAI dinner with a Lifesaver Award. Congratulations to John. Below is the scenario:

Early in the morning on Sunday February 12, 2012, Fourth Precinct officers responded to a report of shots fired in the vicinity of Inwood. Responding officers saw a large

house party in the front of the location. After an investigation, police said that shots were fired and shell casings were recovered from the scene.

Witnesses saw a subject place a handgun and rifle into his vehicle. Both firearms were recovered by police officers. The subject was placed under arrest at scene.

Due to Officer Fallace's experience and working relationship with the community of Inwood, he assisted Detective Nill and Sheinberg with the case. During the ongoing investigation, Officer Fallace obtained credible information from witnesses and residents of the neighborhood that a subject known to Officer Fallace was responsible for the shots fired earlier in the evening. Based on Officer Fallace's information, Detective Nill and Sheinberg requested that Officer Fallace accompany them to find and identify the subject involved with the above listed shooting.

On February 12 at 2:09 p.m., Officer Fallace and Detectives Nill and Scheinberg located the subject and a woman on Mott Avenue and West End Avenue in Inwood. They approached them on foot. Officer Fallace came face to face with the subject. The subject displayed a handgun and pointed it in the direction of Officer Fallace and Detective Nill and Scheinberg. Officer Fallace was able to block the subject's arm that was holding the gun and Detective Nill and Scheinberg began to assist with trying to gain control of the subject and the gun. Unbeknown to the officers involved and based on eyewitness accounts, the subject pointed the gun at Officer Sheinberg and Nill during the struggle. The subject attempted to fire his gun twice but it jammed. The subject was able to push away from the police and again pointed his gun at the officers. At that time Officer Fallace, with weapon drawn, fired 7 shots at the subject, striking him three times. The subject was able to escape into a backyard and a perimeter was established. The subject was later apprehended and his weapon was also recovered.

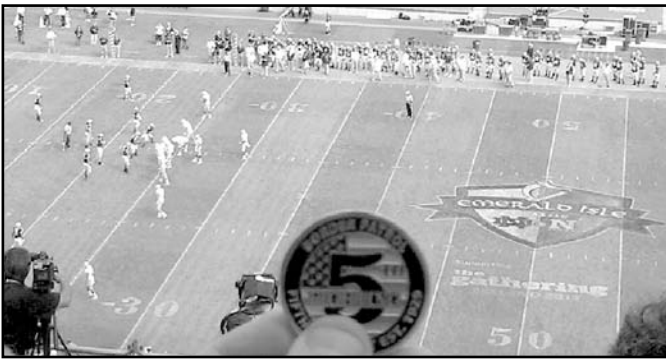

MERGER CONTINUED

I know my article in regards to the merger was a little long last month but I believe what I said needed to be said. Those of us who are Police Officers and who hold the lower supervisory ranks on this job are but pawns in this political game that is being played out before our eyes. The County and the

Department are playing games with our lives and the lives of the residence for a campaign promise. Over the years with the evolution of the Department it became apparent that there was a need to increase manpower and to add Precincts to cover the growing population and infrastructure. Flash forward to the present day when government has become too big for itself and the arterial bleeding of budgets need to be stopped. Money has been squandered, nepotism has run rampant and mismanagement is the name of the game. Where do they look to cut to save money, the employees of course. They jump on the band wagon and declare public employees the end all to society and the enemy of this Country. The Country which Unions built. In recent years we have seen our ranks shrink by hundreds in order to stay within the budgets that the County approves while they overspend on projects, goods and materials. They implement computer programs and initiatives that they say will reduce costs but end up with costs sky rocketing. The structure of this job is being turned upside down and becoming complete chaos with yet another plan that has been promoted as a cost saving plan that creates a more efficient Police Department. This couldn't be any further from the truth. With the merging of the Commands there should have been an increase in the Desk personal to keep up with the workload or we should go back to having the Desks at the Police centers fully staffed so that there is not a delay in getting the assistance that the Officers on the street need in order to get them back in-service faster and make things more efficient again like they were before the efficiency plan became active. It makes no sense to have perfectly good stationhouses and arrest processing rooms sitting idle while the ones in the new Mega Command stationhouses are overcrowded and Officers have to wait their turn to have use of one of the few computers in which to process their arrests which again keeps Officers off of the street longer. It also doesn't make any sense to have the Precinct Squad in one

building and the main precinct in another. It is just a shell game, shuffling Commands around in an effort to make the public think that they are reducing costs and saving them money. The Commissioner comes from a job that has a history of not treating their Cops right which is why it is a 20 and out job. Those that remain longer if they're lucky they are in a good detail and like what they're doing. Now he is here and appears to have an utter dislike and distaste for us and our job as if we are a second rate Department and that he knows better. He is coming at us with both barrels and the Ranking Officers of this job that have spent their entire careers here are standing idly by while it is being destroyed.

The Officers interviewed the subject who made an oral admission of being involved in an altercation with a woman over a parking space and that he had grabbed at the woman's vehicle. The subject was arrested and taken to the Sixth precinct for processing. Officers Maloney and Flidner are congratulated for being selected as our Top Cops for May 2012.

TOP COP JULY 2012

The Top Cop Committee has met and has selected Police Officers Christian Moy and Joseph Franolich as our Top Cops for July 2012. On July 25, 2012 there was an occupied Burglary in the Village of Kings Point. In the Burglary a male subject dressed in camouflage clothing and wearing a mask displayed a handgun. The subject struck the female victim with the gun and fled the scene after it was discovered that the safe in the home was empty. While conducting a canvas of the area, Officers Franolich and Moy located a male subject on the roof of the Great Neck Middle School. They ordered the subject off of the roof and asked the subject for

I.D which he was unable to produce. The subject was questioned as to what he was doing in the area and why he was on the roof. The subjects answers where evasive and he gave conflicting statements. The subject's vehicle was located several blocks away and he gave Officers permission to retrieve his I.D from the vehicle. While retrieving the subjects I.D Kings Point Police Officer discovered camouflage clothing, boots, a BB gun and a paintball mask in the subjects vehicle. A two way radio and a glove were found on a path between the victim's residence and the school during a canvass of the area the next morning. Detectives obtained a search warrant for the subject's phone and information from the cell phone revealed that there was another subject acting in concert with the initial subject and that the cell phone had police radio scanning capabilities. It is because of the actions of Officer Moy and Officer Franolich that this dangerous subject was located and arrested and it is because of this that they are our Top Cops for July 2012.

Seventh Precinct

Once again tragedy has struck our Police family. On October 18th Police Officer Joseph Olivieri while rendering aid at a traffic accident on the LIE was struck and killed by another motorist. Joe was the third Police Officer to be killed in the line of duty in less than 2 years, and like Mike Califano and Geoff Breitkopf is from the class of December 1998. On October 22, a sea of blue lined the streets of Ronkonkoma to pay their respect to our fallen brother and a hero, with a full inspectors funeral. Police officers all over

the state as well as the country came to say goodbye to Joe, hoping that we would never have to do this again.

The next day October 23, I started to write my newsletter article and as usual, I always suffer from some type of writers block. How do I want to put my feelings into words. As I was staring at my computer screen, I started to receive some text messages and phone calls that a cop may have been shot near the city border. Then after a few more calls were made, the worst case scenario I could imagine was true and one of our own again was killed in the Line of Duty. Artie Lopez, an ESU officer while investigating a possible leaving the scene of an accident was shot cold blooded by an ex con who had no business being on the streets of this county or state for that matter. As Lt. Adam Scheiner stated the person responsible for this doesn't deserve to share the same earth with Artie Lopez, and unfortunately Artie is gone and this person still is here.

In less than 24 hours after burying one of our brothers, who paid the ultimate sacrifice we are again mourning the loss of another one of our brothers and heroes. It almost seems surreal to believe that we are going through this again. The grieving process had not even ended for Joe and the members of this department are forced to deal with another tragic blow. My thoughts and prayers go out to all our members, but especially those of the Highway Patrol Bureau, Emergency Services Unit, and Bureau of Special Operations. I urge all members, that if you are having a tough time dealing with these tragedies to reach out to peer support or employees assistance. Some of you may not realize the impact of these tragic deaths until later on, as cops we put are feelings and emotions aside in order to get the Job done, thats how we function, I know I get it. But we are still humans, we do have emotions and feelings and they need to be expressed.

Other than the military, there are very few occupations that will experience injuries or deaths to their co-workers like the Police. I don't know any of my friends in civilian life who has experienced losing co-workers/friends like we have in the police department. That is why we are like a family, because we rely on each other so much, every day we rely on our brothers and sisters to make it to the end of the tour. So if you see one of your brothers or sisters having a tough time with these losses urge them to get some help.

I will miss Joe and Artie as we all will, though I did not run into Joe that often, I will always remember his quirky little laugh and his license plate DJ JOE. His love for the job and coming back from a serious auto accident in the 7th, that most of us would probably would have been forced to retire from. Not Joe he was determined to come back to the job he loved. Artie Lopez, was an infectious kind of guy, though I did not work with him at the precinct level, he responded as an ESU cop to a lot of calls in the 7th that I was involved in. The guy always had a smile on his face, it was unbelievable he would step out of the truck and nothing was ever a problem. I would apologize for the raccoon call or some other mundane BS call that we needed ES for and he would always smile and say no problem Bro thats

part of the job. My partners and me would always say how we loved that they had younger guys on ESU like Artie, always gung ho and eager to help out whether it was a violent 10-62 or a lockout and when Artie rolled up there was that smile. May God Bless them. Rest in Peace Brothers we have it from here.

The upcoming Year of Faith is a "summons to an authentic and renewed conversion to the Lord, the One Savior of the world".
