9/11

20 years removed but still feels like it was yesterday

I woke up on that Tuesday morning at 0600 hours on September 11, 2001 and headed to work in Bellmore by 0630 hours. It was a beautiful day with blue skies and not one cloud. We were expecting a big crew at ESU. The day tour, the night tour, 10 members coming in for a training class, along with four members from other departments. By 0745 hours everyone was present, so we took our coffee and headed to the conference room. By 0800 hours everyone was settled in, and we were talking about the following days, times, and locations.

0846 hours - American Airlines Flight 11 crashes into the north tower of the World Trade Center, just under 25 miles from where we were.

0855 hours – PO Jay Dalton knocks on the door to the conference room and says “Guys who work in the city, call your office, a plane just hit the WTC.”

I walked across the hall to Crime Scene, and they were all watching the news coverage. We couldn’t tell what had happened or why the airplane had crashed.

As I walked back to the ESU Office, I saw our colleagues from NYPD drive past the side door at a high rate of speed, on their way back to NYC.

I went into the ESU office where everyone was watching the news. The police scanner locked on NYPD ESU. The North Tower was badly damaged but standing.

0903 hours - United Airlines Flight 173 crashes into the south tower.

Multiple planes hijacked - all airborne. We are stunned. What are we seeing?

0930 hours – As we stood and watched the TV, Flight 175 crashed into the south tower. Immediately after, I heard

on the scanner, a NYPD Lieutenant transmit on his radio “Central – we are under attack, notify the military and shut down the air space over New York City.”

Waiting for further information, ESU members headed back to the conference room.

0940 hours – American Airlines Flight 77 crashes into the Pentagon.

0959 hours – The south tower collapses. I was standing with PO Pat Crowe who looked at me and said, “There are a lot of dead cops and firefighters.”

1005 hours – Everyone was sent back in the ESU Office. Training is over.

1007 hours - United Airlines Flight 93 crashes in a field in Shanksville, southeast of Pittsburgh.

1028 hours – The north tower collapses.

Sgt. Paul Englert directed me to call NYPD ESU and see what assistance was needed.

I called Truck 10 Queens; “This is Costigan Nassau ESU”, I said to the officer on the other end. “What can we do to help?”

The male said, “Send everything!”

I said, “Equipment or manpower?”

“Send everything! We have nothing. We need everything and everyone you have!”

He said his name and I asked him, “What rank are you?” He said, “Retired – that’s what I mean.”

That’s what he meant. Everyone, all the active guys, were en route to the WTC or were already at the scene. No one was left in quarters.

I am ordered to call all off duty members to report in and as I am calling, members are just showing up. I remember Sgt. Bob Bressingham who had recently moved over to Motor Carrier from ESU walking in and saying, “Let’s go.”

Every member I called – one ring and I would say “We need you to come in.” The reply was, “On my way.”

We called to NYPD ESU Base in Floyd Bennet Field, “Where do you want us?” – “Come to Floyd Bennett.”

Nassau Motorcycle Platoon were lined up in the driveway – we pulled on to Newbridge Rd. We had a convoy of 12 trucks with 28 members. Det Mark Timpano who was a former ESU, also jumped in with us.

No sirens were needed as we were escorted by the Bike

Platoon – traffic was non-existent and every inform sign over the parkway roads read NYC CLOSED TO ALL TRAFFIC.

By 1200 hours we were at NYPD Base at Floyd Bennett Field in Brooklyn and standing by. We had a clear view of the smoke billowing up from Manhattan.

It was hard to stand down – but the plan was to wait until the chaos calmed down at the collapse site.

1430 hours – we left the trucks and loaded up on a bus. The bus dropped us off down at the Brooklyn Pier.

1515 hours – We hopped on a NYPD Harbor Boat and headed to Manhattan. Just before we got there, we hopped from NYPD Harbor onto NCPD Marine Bureau for the final leg of our trip.

1630 hours – we deployed into lower Manhattan, into the smoke, haze, and dust – we set up our NCPD command post under Sgt. Mark Tynan in front of the Century 21 Store. The collapse and shear destruction were too much to really process.

As darkness came – the fires, explosions, smoke, and smell were in every direction. I remember seeing a huge steel girder was dangling off the remainder of WTC 4. At any other time, the area would be roped off, but on this day rescue workers were working directly under the girder.

I was with Sgt. Mark Tynan when we looked over and saw a young NCPD cop on top of a pile. Sgt. Tynan told me to find out what he was doing and who he was with. It was Rookie Jimmy Brown – 2nd Pct. He came in on his own – his cousin, Paddy Brown, Capt. FDNY was missing. I told him if he needed anything to come to our location. Jimmy would later become a member of ESU.

There was a rescue of a Port Authority cop going on about 25 yards in front of us. Numerous NYPD and Nassau ESU were working to free the Sgt. John McLaughlin who was buried under tons of debris.

0230 hours – I met my neighbor from Long Beach, FDNY Chief George Maier, in front of WTC 4. The Chief told me that not one member of his battalion has been heard from since the collapse.

I knew from my previous training that at WTC 4 there were parking garages and a Port Authority Police substation. The Chief asked if we could get a team there to do a search. WTC 4 was partially collapsed and on fire.

Bob Bressingham, Kenny Mazzi, Tony Rivelli, and I entered the building and descended the stairwell one level. At one point we came to a bunch of Rescue equipment laid out probably \$200,000 in equipment. We stopped and I said, “Well, where are they? Someone had

to put this equipment out.”

A few feet away was a total collapse – did the crew who put this equipment here leave or are they on the other side of this collapse with the pathway now blocked. Can they get out? Can we get in to get them?

We descended another floor. Over our heads were huge piles of cement just hanging with water pouring down through. Store alarms were a constant, piercing, blasting, ring.

I remained on that level with Tony Rivelli. Bob Bressingham and Ken Mazzi went down another level and made it to the PATH train station which was quickly filling with water. A quick search and as they started to back up, a girder broke free and came sliding down on the escalator. They ducked under and continued to come up.

As I waited with Rivelli, we had a similar incident when a huge piece of cement broke free and fell a few feet from us. The building was in a state of collapse. We regrouped, and altogether, exited WTC 4.

Dawn was breaking. The rescue of Port Authority Sgt. John McLaughlin was just coming to an end. Nassau PO Richie Doerler played a major part in getting John free. Richie stayed below grade in a crevasse, surrounded by steel. The heat was unbearable, but the rescuers were able to make the steel move slightly, about an inch, and that was all they needed to free Sgt. McLaughlin.

1100 hours – we headed back to NYPD Command post at Stuyvesant HS. As we walked away, I remember turning and looking back – now I was able to get a clear view of the total devastation.

Three NYPD helicopters came in and picked us up. Flying over the WTC on September 12, we were able to get a full view of the collapsed towers, fires, and responders. We flew back to Floyd Bennett Field and were met by ESU Sgt. Timmy Smith. He told us Port Authority ESU member and friend, George Howard of Hicksville was confirmed dead. The names kept coming over the next few weeks.

Everyone became numb to the loss. Tony Rivelli’s cousin, Retired Det. John Van Maren’s son-in-law, Det. Lt. Dennis Farrell’s brother, Terry. Too many. Just too many.

20 years have since passed. One of the guys who went in on Sept 11th, Paul McCabe has since passed away from 9/11 cancer. Multiple members are now suffering from 9/11 cancer, coughing, lung problems, PTSD.

In closing, I only write about 9/11 from my experience, but the on-going response by many other members continued for months after the attack.

My last visit was May 11, 2002. I went into NYC with Richie Doerler in an ESU tractor trailer and retrieved two steel girders which are on display at Eisenhower Park as part of the Nassau County 9/11 Memorial.

Please take advantage of the WTC Health Program. Annual medicals have uncovered many conditions of responders related to 9/11. Retired members living out of state will be able to be connected to a local medical facility.

We got the "Steps Legislation" passed into law to protect our newer members from being frozen by NIFA, we were instrumental in the re-opening of the 6th & 8th precincts, the 5-year transfer MOA which gives officers the right and flexibility to move from precinct to precinct if they wish, the "Longevity MOA", which put us back on the map as we move forward to secure that benefit (as it was wrongfully taken from us). We attacked the crossing guard situation which led to the hiring of more guards and securing our members safety, we were able to get more long guns onto the street to further protect our members and the public, we secured more new patrol cars through the County. We protected our members daily during the COVID pandemic by holding the County accountable for cleaning our cars and equipment, not to mention our efforts to get the necessary safety equipment such as gloves, masks, shields, robes and proper COVID testing and immunization, we also secured a "COVID presumption" that covers you now and into the future. Legal Report

The Legal Report has often covered the requirements of obtaining a $\frac{3}{4}$ Accidental Disability Retirement pension versus a $\frac{1}{2}$ Performance of Duty Disability pension. In order to qualify for either of these disability retirement benefits the applicant must prove he or she is permanently incapacitated for the performance of the full duties of a police officer, that the disability is causally related to the injury or injuries being claimed, that the injury was suffered in the line of duty and that the injury is the result of an "accident" as this term is used in the Retirement and Social Security Law (RSSL), or the result of an incident. What separates one benefit from the other is whether the injury is the result of an "accident." If not, the applicant will be limited to a $\frac{1}{2}$ Performance of Duty Disability pension.

As we have written many times, within the meaning of the RSSL explanations of what constitutes an "accident" comes from case law. "For purposes of the Retirement and Social Law, an accident has been defined as a 'sudden, fortuitous mischance, unexpected, out of the ordinary, and injurious in impact.' "The Courts have emphasized that "in order for any injury to be considered accidental, it 'must not have been the result of activities undertaken in the ordinary course of one's job duties, but, rather, must be due to a precipitating accidental event which is

not a risk of the work performed.”

In June 2021, the Appellate Division, Third Department handed down a somewhat different type of a ¾ Accidental Disability Retirement pension decision in that it dealt with an allegation that the disabling injury was a mental one diagnosed as posttraumatic stress disorder, manic depression and anxiety, by the applicant’s physicians and deemed by them to be unable to return to work. The applicant was a State Police Officer.

While we have written a great deal about ¾ Accidental Disability Retirement claims based on physical impairments, such as injuries to the back or knee or shoulder, we have not written frequently about mental impairments causing a disability, if at all. Connecting this State Police Officer’s mental injury to an “accident” within the meaning of the RSSL is necessary in order to qualify for a ¾ Accidental Disability Pension.

The Officer worked as a trooper for a time and then as an investigator. While working as an investigator he worked as an undercover narcotics detective, both here and abroad. He spent much of his time in Columbia working with informants “in an effort to infiltrate drug cartels and curtail the supply of drugs coming into the United States. This work entailed interacting with dangerous individuals and exposed [the officer] to a number of traumatic events, including losing informants who were killed and having to identify their bodies.” Sometime after returning from a mission, the officer suffered a panic attack in his office. Subsequently, he received the diagnoses of: post traumatic stress disorder, manic depression and anxiety. The officer filed an application for a ¾ Accidental Disability Retirement pension on the basis of his diagnosis, which the Officer claimed was a result of his work with drug cartels. The Retirement System denied his application on the basis that the event which the Officer cited to be the cause of his mental injury was not an “accident” within the meaning of the RSSL.

The Court noted that “Initially, the burden is on the party seeking accidental disability retirement benefits to demonstrate that his or her disability arose from an “accident” within the meaning of the RSSL, and the Comptroller’s determination in this regard will be upheld if supported by substantial evidence.” After going through an analysis and considering all the requirements for an event to qualify as an “accident” as listed above, the Court decided that the cause of the Officer’s injury was not an “accident” within the meaning of the RSSL. The Court wrote “Here, [the Officer’s] mental injuries were a direct result of the stress that he was under while working undercover and interacting with informants and members of dangerous drug cartels. This dangerous undercover work was part and parcel of his regular duties as a narcotics investigator and was specifically set

forth in [the Officer’s] job description. Inasmuch as the stress that produced [the officer’s] mental injuries was an inherent part of his job and was not unexpected” the event causing the mental injuries was not an accident.

Interestingly, the Court observed that this case does not benefit from the presumption that benefits first responders to the World Trade Center terrorist attacks on 9/11. This 9/11 presumption provides that mental impairments suffered as the result of the 9/11 attacks are presumed to be the result of an accident.

BUFFY'S SPOTLIGHT

First Precinct Special Patrol Officers Fullerton, Vitale, Girona, and Stephani after receiving numerous community complaints of narcotic sales coming from 2 Babylon Turnpike in Roosevelt, The Rosa Parks Senior Center; set up observation points at the location and made several arrests over a 2-month investigation. On May 21st, Special Patrols, BSO and Narcotics Detectives executed a search warrant at 2 Babylon Turnpike and placed 7 defendants into custody and charged them with Criminal Possession of Controlled Substance in the 3rd degree and 5th degree. This was a joint effort between NVB Detectives and First Precinct Special Patrols. The residents of the senior complex came out and thanked

the officers and were very happy with the results.

On June 21st, Officers responded to a call for a suicidal male with a firearm in Wantagh on 109s post. Upon arrival officers heard what sounded like gun shots coming from inside the home. Officers set up a perimeter around the house and Sgt. Logiudice called the aided and after extensive conversation with him, Sgt. Logiudice was able to talk the aided out of the home without incident. Inside the location, officers recovered several loaded shotguns, and a loaded hand gun. Officers also observed spent shell casings as well as holes in the basement. Everyone involved with this incident did an outstanding job, but a special buffy spotlight goes out to Sgt. Logiudice. Sgt. Logiudice was able to talk to an armed, suicidal male and have him surrender without incident or harm to himself or any police personnel. **OUTSTANDING WORK!!!!**

On June 22nd, Officers were dispatched for a Pharmacy Robbery that just occurred. While canvassing Officer Tuffarelli observed a male who matched the description walking on Newbridge Road. Officer Tuffarelli, upon exiting his RMP, observed the same male now fleeing on foot. After a brief foot pursuit, the defendant was taken into custody by Officer Tuffarelli and Officer Waltman. Officers were able to recover proceeds from the pharmacy from the defendant. Defendant was charged with 5 counts of Robbery 1st, Criminal Possession Controlled Substance 2nd, and 3rd, as well as Robbery 2nd. **THIS IS OUTSTANDING WORK!!!! GREAT JOB BOYS, DOING THE FIRST PROUD!!!!**

On June 30th, First Precinct Special Patrol Officers Girona and Stephani conducted Operation Night Watch with Nassau County Probation's Gang Unit. Possession Firearm, Criminal Possession Weapon 2nd, 3rd and CPW 4th. Again, great job boys! Hardware!!!!

On July 28th Officers responded for a Robbery at the 7-11 in Baldwin. During the canvass Officers Taddeo, Haubold, and Slevin located the defendant hiding near the scene. Officers placed the defendant into custody without incident. Defendant was charged with Robbery 3rd.

Again, a lot of great work being done over the summer and this is only half of the buffy spotlights. More to come next month. I truly love working in the First Precinct. Fighting First for Life!!

LOCAL LAW 187-21 VETOED

On behalf of my fellow Sixth Precinct PBA representatives PO's Michael Calfayan, Sean Maass, William Popiolek, and Joseph Lianzo we hope everyone had a great summer. We welcome all the new arrivals that graduated from the Police Academy. On August 3, 2021, there was a discussion and concluded with a vote on the Nassau County Local Law 187-21. It was introduced by Legislators Josh Lafazan and co-sponsored by Legislators Delia DiRiggi-Whitton, Arnold Drucker, and Ellen Birnbaum. This was a good bill that protects law enforcement and first responders against harassment, menacing, or assault or injury is motivated by such individual's status as a first responder. It also gave law enforcement and first responders the right to civilly sue those who commit such crimes. If we all look back, we observed violent protests throughout our Country which included our brothers and sisters in blue in the New York City Police Department. The media displayed cops being threatened and attacked by criminals under the guise of protesters. All of you that worked the protests last summer, throughout the County, maintained professionalism. As professionals, we understand that people have a constitutional right to peacefully protest. At times protesters will verbally vent to law enforcement. However, some protesters will verbally threaten bodily harm you or even spit at you. These behaviors are roots that could lead to mass violence against law enforcement. The bill was voted on and passed. However, Legislators Drucker and Birnbaum who originally co-sponsored the bill flipped, and voted against the bill. One would think that both of them would have carefully read this bill, thought it through, and perhaps would have made changes where needed. Way to play both sides of the fence. The truth is there was no need to make any changes. It was a good and righteous bill for all law enforcement and first responders. Ultimately County Executive Laura Curran, under the guidance of Attorney General Letitia James, vetoed the bill. Will the rejection of the bill enable criminals, under the guise of protesters, the right to attack police? Only time will tell what results from the veto if we do have protests at the level of last summer.

Summer 2021 was definitely the busy season we anticipated with countless radio assignments, aided cases, distress response calls, boating accidents and the like.

Despite the increased number of recreational boaters and the dangers they present, Marine Bureau crews were out there answering the call and at the same time, educating the public. Through high visibility patrol, frequent IP visits to problem areas and good old-fashioned enforcement, we managed to weather the storm. Both recreational boating accidents and fatalities are down. This is a testament to the hard work of the Marine Bureau members who rise to the occasion when difficult situations get thrown our way.

Amongst these situations were several BWI arrests, with crews providing fast emergency response, conducting thorough investigations and following through with good arrests.

LEARNING CURVE

Dear PBA Member,

Periodically, your PBA reminds its membership of appropriate steps that should be taken if you are called to Internal Affairs or become part of ANY department investigation. Recent events underscore the importance of involving the PBA and your legal counsel, me, as soon as possible.

Should you be called to Internal Affairs, be it as a witness or subject, you must notify your local PBA representative IMMEDIATELY. If you are deemed a subject, you have the right to have both a union representative and legal counsel with you during the interview. **If the investigation is criminal in nature, call me first!**

REMEMBER: You must be afforded a reasonable amount of time to contact a PBA representative and attorney. You have the right to confer with us both before and after questioning.

YOUR PBA REPRESENTATIVES AND ATTORNEY
ARE HERE TO PROTECT YOU!

In any situation, be it at Internal Affairs or otherwise, where you are asked to write a letter and there is even a remote possibility of discipline, be sure to begin the letter with the following statement:

"I am making this statement for administrative purposes only. I have not done so voluntarily, but in compliance with an order of a Superior Officer. This statement in no way constitutes any waiver of my rights, and this statement, or any part thereof, may not be used against me in any subsequent criminal proceeding."

Finally, upon notifying your PBA representative that you have been called to Internal Affairs as the subject of an investigation, we will arrange to meet prior to your interview at my office to review the facts and circumstances.
